Second plan application has been filed by the Applicant/RP for approval of the Resolution Plan, in terms of our order dated 11.05.2026 passed in IA/(Plan)7(AHM)2026.

Today, we have heard the salient features of the Resolution Applicant with addendum. However, at this stage, learned counsel appears for the Operational Creditor, namely, Enercon GmbH seeks indulgence of two days to file appropriate application in this IA, which is allowed. Let the copy of the same be provided to the SRA, with liberty to file a response and counter response.

1. The present Application has been filed by the Resolution Professional of Wind World (India) Limited under Section 60(5) of the Insolvency and Bankruptcy Code, 2016 read with Rule 11 of the National Company Law Tribunal Rules, 2016 for taking on record the change in the constitution of the Committee of Creditors pursuant to the Security Receipts Transfer Agreement dated 15.05.2026 and in compliance with Regulation 28(2) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, with the following prayers:
  - a) *allow the present Application and take on record the resultant change in the constitution of the committee of creditors by virtue of the Security Receipt Transfer Agreement dated 15 May 2026;*
  - b) *pass such other orders as this Hon'ble Tribunal may deem fit and proper in the facts and circumstances of the case.*
2. It is submitted that certain financial debts of the Corporate Debtor were assigned by the original lenders to National Asset Reconstruction Company Limited and thereafter to Omkara Asset Reconstruction Private Limited acting as Trustee of Omkara PS 05/2025-26 Trust. Subsequently, pursuant to the Security Receipts Transfer Agreement dated 15.05.2026, India SME Asset Reconstruction Company Limited (ISARC) has been substituted in place of Omkara Asset Reconstruction Private Limited as trustee of the said trust.
3. The Resolution Professional has placed on record the intimation received from ISARC, the Security Receipts Transfer Agreement and the revised constitution of the Committee of Creditors. It is stated that consequent upon the said transfer, Omkara Asset Reconstruction Private Limited ceased to be a member of the Committee of Creditors with effect from 15.05.2026 and the Committee of Creditors stands reconstituted accordingly.
4. Heard the learned counsel for the Applicant and perused the material available on record.
5. The Application has been filed for reporting the change in the constitution of the Committee of Creditors in terms of Regulation 28(2) of the Insolvency and

Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016. The documents placed on record support the substitution of Omkara Asset Reconstruction Private Limited by India SME Asset Reconstruction Company Limited as trustee of Omkara PS 05/2025-26 Trust.

6. Accordingly, the report regarding the resultant change in the constitution of the Committee of Creditors pursuant to the Security Receipts Transfer Agreement dated 15.05.2026 is taken on record.
7. The Registry is directed to place the report with the main Company Petition record.
8. In terms of above, **IA No. 869 of 2026** stands allowed and disposed of.
