Ref.: Formation of City Square Global LLC, a subsidiary of the Company, in the State of New Jersey, United States of America

With reference to the captioned subject, and pursuant to Regulation 30 read with Para A of Part A of Schedule III of the Listing Regulations, we wish to inform you that Jay Ambe Supermarkets Limited ("the Company"), along with two other members, has formed City Square Global LLC, a domestic limited liability company under the laws of the State of New Jersey, United States of America. The Certificate of Formation of City Square Global LLC was duly filed in accordance with New Jersey State Law on June 08, 2026 with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services, and Identification Number 0451477520 was assigned to it. The Certificate of Formation was subsequently amended, vide Certificate of Amendment filed on July 01, 2026 bearing Validation Number 4326280510, so as to record the name of the member as "Jay Ambe Supermarkets Limited".

Reason for delay in intimation:

Regulation 30(6) of the Listing Regulations requires that, where a disclosure is made beyond the timeline prescribed thereunder, the listed entity shall furnish an explanation for the delay. In this regard, we wish to state that the Certificate of Formation, the Certificate of Amendment, the Employer Identification Number letter and the executed Operating Agreement in respect of City Square Global LLC were transmitted to and received by the Company from its authorised representative in the United States of America only on September 16, 2026. The present intimation is accordingly being filed forthwith upon receipt and verification of the said documents. The delay in intimation is unintentional and is sincerely regretted, and the Company has put in place internal processes to ensure timely intimation of such events in future.

Mr. Jignesh Amratbhai Patel, Managing Director and Promoter of the Company, holds 29% of the membership / percentage interest, and Mrs. Shital B Patel, forming part of the Promoter Group of the Company, holds 20% of the membership / percentage interest in City Square Global LLC, in their individual capacity, aggregating to 49%. Arm's length: Yes, the transaction is on an arm's length basis.
