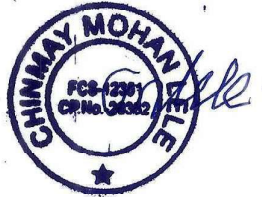

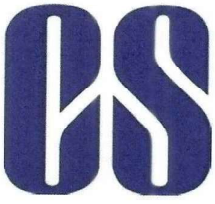

Subject: Report of Scrutinizer on Voting Process carried out through Postal Ballot ("Remote E-voting") of Arvaya Healthcare Limited (Formerly Known as Bijoy Hans Limited) (The Company) conducted pursuant to the provisions of Section 108 and 110 of the Companies Act, 2013 ("the Act") read with Companies (Management and Administration) Rules, 2014.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules thereunder relating to Remote e-voting process for postal ballot. My responsibility as a Scrutinizer for the voting process is restricted to ensure that the voting process is conducted in a fair and transparent manner and make the Scrutinizer's Report of the votes cast "in favour" or "against" the above resolutions, based on the reports generated from the e-voting system provided by National Securities Depository Limited (NSDL)/ Central Depository Services Limited (CDSL), the authorized agencies to provide remote e-voting facilities and engaged by the Company for that purpose.

In this regard, I submit my Report as under:

1. The members of the Company whose names were recorded in the Register of Members or in the Register of Beneficial Owners maintained with the Depositories as on the Cut-off date i.e., Friday, 10th July 2026, were entitled to vote on the resolutions in the Notice.
2. As confirmed by the Company, the notice was sent through electronic mode to those members whose email addresses were registered with the Registrar and Share Transfer Agent of the Company / Depository Participant(s).
3. The Company had published an advertisement about the dispatch of the Notice in Financial Express - in English and Dainandin Barta - in Assamese on Tuesday, 14th July 2026.
4. The Company has engaged the services of e-voting facility provided by the National Securities Depository Limited ("NSDL").
5. The votes exercised through the e-voting facility commenced from Wednesday, 15th July 2026 at 9:00 AM (IST) and ended on Thursday, 13th August 2026 at 5:00 PM (IST): [both days inclusive], being the last date for remote e-voting, were considered for my scrutiny.
