UPON hearing the counsel the Court made the following

O R D E R

IA No. 166314/2026

1. The short issue that arises for consideration before us is that the Interim Resolution Professional has proceeded on leave, till at least the end of July 2026, due to which difficulty is being faced in complying with the time bound directions issued by this Court vide order dated 04.12.2025 passed in Contempt Petition (Civil) Nos.660-661/2025 read with order dated 18.05.2026 passed in C.A. No.814/2026 regarding registration of the apartments by NOIDA in consultation with the home buyers.

2. It is pointed out that claims of 71 home buyers are yet to be verified. We, therefore, appoint CA Ritu Rastogi (IBBI Registration No.IBBI/IPA-001/IP-P00204/2017-2018/10393) as the new IRP for completion of the remainder of exercise regarding execution of conveyance deed on behalf of M/s. Hacienda Project Private Limited in terms of the orders of this Court.

3. Ms. Rastogi shall be entitled to same remuneration as was paid to earlier Insolvency Resolution Professionals.

4. IA No. 166314/2026 stands disposed of.
