**Sub: Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015**

In terms of the provisions of Regulation 30 (read with Part A of Schedule III) and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we wish to inform you that the Bombay Stock Exchange, vide its email dated 30th June, 2024, has levied a fine of ₹5,000 (Rupees Five Thousand only) on the Company for the non-compliance with Regulation 23(9) of the Listing Regulations. The Company has remitted the aforesaid amount on 2nd July, 2026.

The said fine was levied on account of the filing being submitted on the day following the submission of the PDF version of the financial information to the Exchange. The delay in uploading the file was purely inadvertent and occurred due to a technical error encountered in the XBRL sheet during the filing process. The PDF filing containing the requisite financial information was submitted within the prescribed timeline.

The Company remains fully committed in ensuring compliance with all the applicable provisions of the Listing Regulations.
