Heard learned counsel/senior counsel for the parties.

2. The present matter has been placed before this Court at the instance of the Registry seeking directions with regard to the manner in which the amount of Rs.9,61,90,236/- (Rupees Nine Crores Sixty One Lakhs Ninety Thousand Two Hundred Thirty Six) deposited by the applicant/petitioner-ICICI Lombard General Insurance Co. Ltd. which has been invested in FDR which is maturing on 23.09.2026, should be dealt with.

3. In view of the fact that during the course of the proceedings, this Court *vide* order dated 14.08.2023 passed in Civil Appeal No.4914 of 2023 had directed for the said deposit by the applicant/petitioner-ICICI Lombard General Insurance Co. Ltd. and *vide* order dated 12.08.2026, the impugned judgment dated 03.05.2023 passed by the NCDRC has been set aside and the matter has been

remanded to the NCDRC for *de novo* consideration, we deem it appropriate that the said amount be returned to the applicant/petitioner-ICICI Lombard General Insurance Co. Ltd. along with up-to-date accrued interest and suitors' fund amount.

4. Accordingly, the Registry shall refund the said amount invested in the FDR along with the accrued interest and suitors' fund amount as per Rules to the applicant/petitioner-ICICI Lombard General Insurance Co. Ltd.

5. The same be done within three weeks from today.

6. With the aforesaid direction, the Miscellaneous Application stands disposed of.
