A W A R D

1. We have heard learned counsel for the parties.
2. We have also interacted with the Commissioner of Nashik Municipal Corporation and Uttam Nivrutti Netawate-the respondent.
3. Parties have entered into a settlement dated 29.06.2026, which is taken on record.

4. In terms of the settlement, respondent is being reinstated in service with all consequential benefits. However, respondent has agreed to waive off back wages from 24.06.2011 to 25.02.2020. It means that he will be entitled to back wages from 26.06.2020 till the date of actual joining.

5. That apart, respondent would be entitled to 4 additional increments in terms of the Order dated 11.03.2014.

6. The Special Leave Petition is disposed of in terms of the settlement agreement. The settlement agreement shall form part of this Award.
