1. The information required pursuant to SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI (LODR) Regulations'), read with Secretarial Standard on General Meeting (SS-2) issued by Institute of Company Secretaries of India, regarding the Directors seeking appointment/re-appointment in the Annual General Meeting are annexed hereto and both forms part of the Notice.
2. The Board of Directors of the Company has appointed Mr. Varun Mehra, Company Secretary in practice and Partner at MSV & Associates, (Membership No. F11599, CP No. 19212) as the Scrutinizer, for conducting the Annual General Meeting and remote e-voting as well as voting at the meeting process in a fair and transparent manner.
3. The Register of Members and the Share Transfer books of the Company will remain closed from Thursday 24<sup>th</sup> September, 2026 to Wednesday, 30<sup>th</sup> September, 2026 (both days inclusive) for the purpose of AGM.
4. The Company has engaged the services of Central Depository Services (India) Limited (CDSL) as the authorised agency to provide the e-voting facility.
5. **A MEMBER ENTITLED TO ATTEND AND VOTE AT THE AGM IS ENTITLED TO APPOINT A PROXY TO ATTEND AND VOTE ON A POLL INSTEAD OF HIMSELF/HERSELF AND SUCH PROXY/ PROXIES NEED NOT BE A MEMBER OF THE COMPANY.** A person can act as proxy on behalf of members not exceeding fifty (50) and holding in the aggregate not more than ten percent of the total share capital of the Company carrying voting rights. A member holding more than ten percent of the total share capital of the Company carrying voting rights may appoint a single person as proxy and such person shall not act as proxy for any other person or shareholder.

A proxy form for the meeting is enclosed to this report. The proxy form in order to be effective, should be duly stamped, filled, signed and must be lodged with the Company at its registered office at least 48 hours before the commencement of the Annual General Meeting.

6. Corporate members/HUF/Trust, intending to send their authorized representative(s) to attend the AGM, pursuant to Section 113 of the Companies Act, 2013, are requested to send to the Company, a certified true copy of the relevant Board Resolution/Authorisation letter together with the specimen signature(s) of the representative(s) authorised under the said Board resolution/Authorisation letter to attend and vote on their behalf at the Meeting.
7. For convenience of members, an attendance slip is annexed to the notice. Members are requested to affix their signature at the space provided and hand over the attendance slips at the place of meeting. The proxy of a member should mark on the attendance slip as 'proxy'.
8. To facilitate ease of investing for holders of securities in physical form and in line with relevant SEBI Circulars, the Company has opened an additional special window for a period of one (1) year, from 5 February 2026 to 4 February 2027, for lodgement of transfer deeds and dematerialisation of physical securities. This window is applicable to physical securities that were sold or purchased prior to 1 April 2019 or were earlier rejected, returned, or left unprocessed due to deficiencies in documentation, procedural requirements, or for any other reason. The securities so transferred shall be mandatorily credited to the transferee only in demat mode and shall be under lock-in for a period of one year from the date of registration of transfer and such securities shall not be transferred / lien-marked / pledged during the said lock-in period. However, the claimant must have the original security certificate with them and the same should not have been transferred to IEPF for any reasons. Members are requested to avail the aforesaid facility.

The Company has engaged the services of M/s Beetal Financial & Computer Services Pvt. Ltd. and Central Depository Services (India) Limited (CDSL) to provide the e-voting facility.

Please note that remote e-voting is optional and not mandatory. The members who have cast their vote by remote e-voting whether partially or otherwise prior to the Annual General Meeting shall not be allowed to change it subsequently, they may also attend the Annual General Meeting but shall not be entitled to cast their vote again

The Company has also arranged for physical voting through ballot or polling paper at the AGM for the members who have not cast their vote through remote e-voting.

#### 29. PROCEDURE FOR REMOTE E-VOTING:

**The instructions of shareholders for remote voting are as under:**

Step 1: Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

Step 2: Access through CDSL e-Voting system in case of shareholders holding shares in physical mode and non-individual shareholders in demat mode.

- (i) The voting period begins on Sunday, September 27<sup>th</sup>, 2026 at 09.00 AM (IST) and ends on Tuesday, September 29<sup>th</sup>, 2026 at 5.00 PM (IST). During this period shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date of Wednesday, September 23<sup>rd</sup>, 2026, may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.

- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242** dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

**Step 1 :** Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (iv) In terms of **SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020** on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

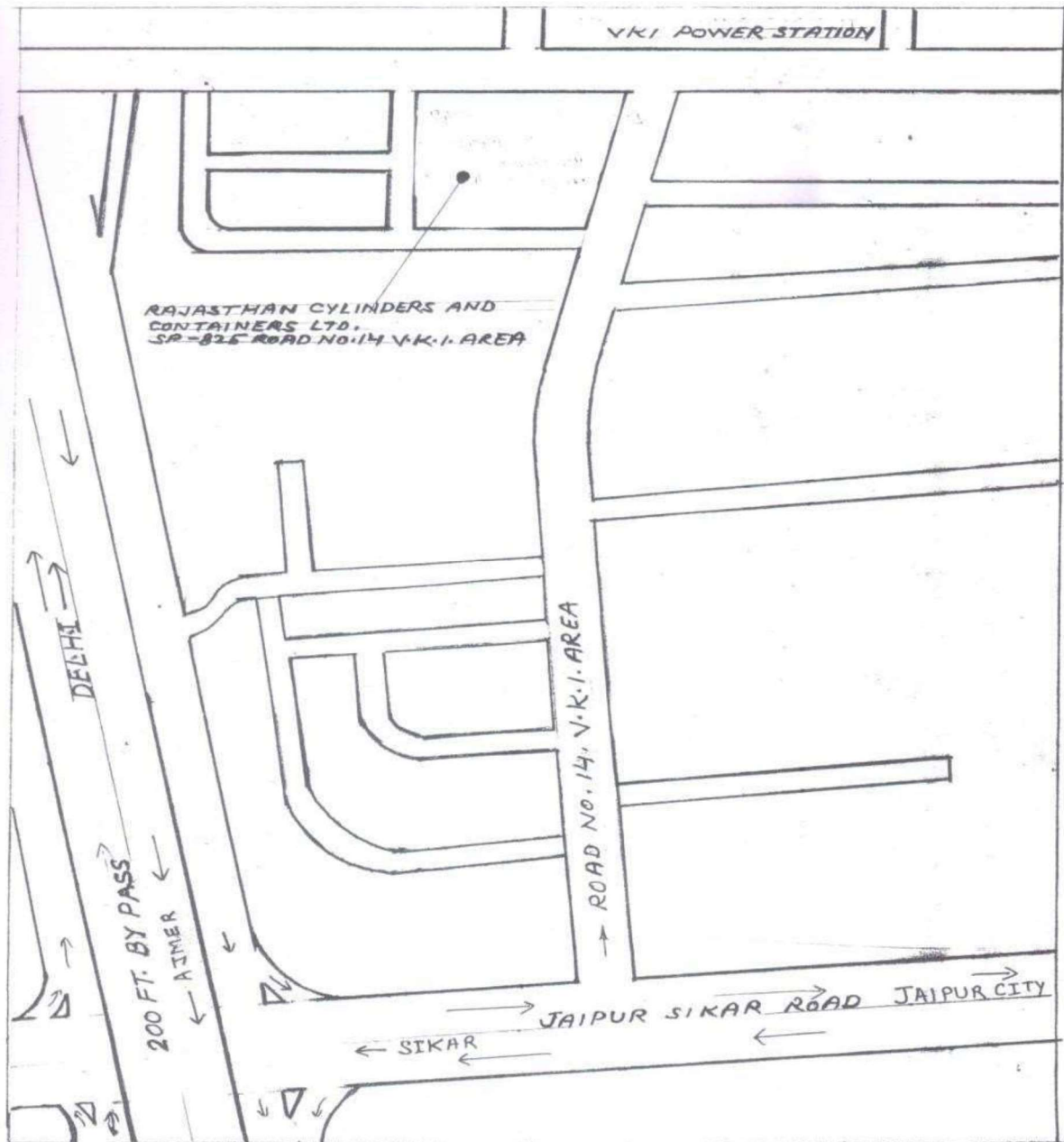

**2. Performance Review and State of Company's Affairs**

The Company's manufacturing unit at SP-825, Road No. 14, VKI Area, Jaipur-302013 — where it manufactured LPG Cylinders, Valves & Regulators and rendered LPG refilling services has remained closed since 09<sup>th</sup> December, 2022, following a sustained period of operational losses driven by adverse industry and macro-economic conditions in earlier years. The Company disposed of the substantial plant and machinery at this unit to reduce interest cost and settle creditors, and continues to hold no active manufacturing operations as on the date of this Report.

During the financial year 2025-26, the Company did not undertake any manufacturing or trading activity and had no revenue from operations. Total income for the year, comprising other income, stood at Rs. 114.50 Lakhs (previous year: Rs. 91.60 Lakhs), while the Company incurred a loss after tax of Rs. 101.49 Lakhs (previous year: Rs. 86.37 Lakhs), as set out in the financial highlights table above.

The Company continues to explore options for setting up a new business/project and is in the process of appointing a consultant for this purpose. The Board will keep Members updated on material developments in this regard.

### 3. Operations

**Production and Sales:** During the period under review, the Company did not carry on any production activities.

During the year under review, the manufacturing unit of Company located at SP-825, Road No. 14, VKI Area, Jaipur-302013 was inoperative and remained closed. This indicate that a material uncertainty exists that may cast significant doubt on the Company's ability to continue as a going concern. However, The Company is in process to appoint a consultant for setting up a new business / project, hence, the financial statements for the year ended 31<sup>st</sup> March, 2026 have been prepared on going concern basis.

### 4. Dividend

The Board of Directors of the Company have decided not to recommend any dividend for the financial year 2025-26.

### 5. Transfer to Reserve

The Company has not transferred any amount to reserves for the financial year 2025-26.

### 6. Deposits

During the year under review, your Company has not accepted any deposit within the meaning of Section 73 and 74 of the Companies Act, 2013, read with the Companies (Acceptance of Deposits) Rules, 2014 and therefore there are no outstanding deposits as on 31<sup>st</sup> March, 2026.

### 7. Credit Rating

No Credit rating was obtained during the financial year 2025-26.

**MANAGEMENT DISCUSSION AND ANALYSIS REPORT**

The Management presents its analysis of the Company's performance and outlook for the financial year 2025-26. This report may contain forward-looking statements that involve risks and uncertainties; actual results may differ materially from those expressed or implied.

**1. INDUSTRY STRUCTURE AND DEVELOPMENT**

The Company was engaged in manufacturing LPG Cylinders, Valves & Regulators and providing LPG refilling services. Following a sustained period of operational losses in earlier years driven by pandemic-related disruption and adverse industry conditions, the Board approved closure of the Company's manufacturing unit at SP-825, Road No. 14, VKI Area, Jaipur-302013, with effect from 09<sup>th</sup> December, 2022. Substantial plant and machinery at the unit has since been disposed of in tranches to reduce interest cost and settle creditors. The Company has not undertaken any manufacturing activity since that date, including during the financial year 2025-26, and has not yet identified a suitable new business opportunity, though it continues to evaluate options, including the appointment of a consultant to assist in setting up a new venture.

**2. OPPORTUNITIES AND THREATS**

The principal opportunity before the Company is the identification and commencement of a viable new business line, for which the process of engaging a consultant is ongoing. The principal threat remains prolonged absence of operating revenue, which continues to erode the Company's net worth through recurring administrative costs, absent a new revenue stream being established in the near term.

**3. SEGMENT WISE OR PRODUCT WISE PERFORMANCE**

**4. OUTLOOK**

The Company's near-term outlook remains contingent on identifying and commencing a new business activity. The Board will keep Members updated as this process progresses.

## 5. OPERATIONAL & FINANCIAL OVERVIEW

Total income for the FY 2025-26 under review was Rs. 114.50 Lakhs as against Rs. 91.60 Lakhs in the previous FY 2024-25. The loss before tax for the FY 2025-26 is Rs. -138.93 Lakhs as against loss of Rs. -147.46 Lakhs in the previous FY 2024-25. The loss after tax for continued operations is Rs. -101.49 Lakhs for the FY 2025-26 as against Loss of Rs -86.37 Lakhs in the previous FY 2024-25.

## 6. INTERNAL CONTROL SYSTEM AND THEIR ADEQUACY

The internal control framework is designed to ensure proper safeguarding of assets, maintaining proper accounting records and providing reliable financial information and other data. This system is supplemented by internal audit, reviews by the management, guidelines and procedures. The Company has adequate internal control system to safeguard the company's assets from any loss or damage, to control cost, prevent revenue loss and required financial and accounting controls and to effectively implement the applicable accounting standards. During the year under review, S.S. Surana & Co. (FRN: 001079C), were engaged as Internal Auditors of the Company. Internal auditor evaluated the functioning and quality of internal controls and provided assurance of its adequacy and effectiveness through periodic reporting. Internal audit was carried out as per internal audit plan, which was reviewed by the Audit Committee of the Company. The Company intends to undertake further measures as necessary in line with its intent to adhere to the procedures, guidelines and regulations, as applicable, in transparent manner.

To maintain its objectivity and independence, auditor directly reports to the Chairman of the Audit Committee of the Company. Further, the Statutory Auditors have also, in compliance with the requirements of the Companies Act, 2013, issued an opinion with respect to the adequacy of the internal financial controls over financial reporting of the Company and the operating effectiveness of such controls details of which may be referred to in the Auditor's Report attached to the Audited Financial Statements for the Financial Year 2025-26.

## 7. RISKS AND CONCERNS

The Company is exposed to credit, liquidity, market and commodity risk, monitored under the Board-approved Risk Management Policy, with oversight from the Audit Committee. Given the closed manufacturing operations noted above, a material uncertainty exists relating to the Company's ability to continue as a going concern; however, the financial statements have been prepared on a going-concern basis in view of the Company's ongoing efforts to establish a new business, as explained in Note 44 to the financial statements.

## 8. MATERIAL DEVELOPMENTS IN HUMAN RESOURCES/INDUSTRIAL RELATIONS FRONT, INCLUDING NUMBER OF PEOPLE EMPLOYED

As on 31<sup>st</sup> March, 2026, the Company had 11 permanent employees, all at its administrative office; no contract labour has been engaged since closure of manufacturing operations in December 2022. The Directors place on record their appreciation for the continued support and dedication of the Company's employees.

### Report on the Audit of the Financial Statements

#### Qualified Opinion

We have audited the accompanying financial statements of **RAJASTHAN CYLINDERS AND CONTAINERS LIMITED** ("the Company"), which comprise the Balance Sheet as at 31<sup>st</sup> March 2026, the Statement of Profit and Loss (including other comprehensive income), the Statement of Changes in Equity and the Statement of Cash Flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information (hereinafter referred to as "the Financial Statements").

In our opinion and to the best of our information and according to the explanations given to us, except for the effects of the matter described in the Basis for Qualified Opinion section of our report, the aforesaid financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended, ("Ind-AS") and other accounting principles generally accepted in India, of the state of affairs of the Company as at 31<sup>st</sup> March 2026, and its loss (including other comprehensive income), changes in equity and its cash flows for the year ended on that date.

#### Basis for Qualified Opinion

- (i) The interest payable u/s 16 of MSMED Act, 2006 on overdue amount of trade payable to micro enterprises and small enterprises has not been ascertained and not provided for. (Refer Note No. 19).
- (ii) The Balances of Trade payables, Financial Assets (including employee's advances), Advances including advance to suppliers, Loans given, interest receivable on loans and Unsecured Loans taken are subject to confirmation and consequential adjustments, if any (Refer Note No. 35).
- (iii) Loans & Advances includes Rs. 230.50 Lakhs receivable from related parties of the company. In absence of any agreement and repayment terms, we are unable to comment on recoverability of the same.
- (iv) The Company has recognized deferred tax assets amounting to Rs. 650.76 Lakhs as on 31st March 2026, which includes deferred tax assets on carried forward unused tax losses and other taxable temporary differences on the basis of expected availability of future taxable profits for utilization of such deferred tax assets. However, in view of the history of losses recorded by the Company and no operational segment, we are unable to comment on any adjustments that may be required to the carrying value of aforesaid net deferred tax assets as at 31st March, 2026 (Refer Note No. 6)

Had the impact of above qualification in Para (iii), without considering Para (i and ii) for which impact could not be determined, been considered, the total comprehensive income for the year would have been Rs. -752 Lakhs as against the reported figure of Rs. -101.24 Lakhs, Other equity would have been Rs. 425.57 Lakhs as against the reported figure of Rs. 1076.33 Lakhs and Deferred Tax Assets would have been Rs. Nil as against the reported figure of Rs. 650.76 Lakhs.

We conducted our audit of the Financial Statements in accordance with the Standards on Auditing (SAs), as specified under section 143(10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the 'Auditor's Responsibilities for the Audit of the Financial Statements' section of our report. We are independent of the Company in accordance with the 'Code of Ethics' issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the

Financial Statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the Financial Statements.

### Material Uncertainty related to Going Concern

We draw attention to Note 36 of the Financial Statement which indicates that the Company has closed its manufacturing operations due to unsatisfactory performance of the company and continued operational losses. The company has disposed off its Plant & Machinery in one or more tranches. These events or conditions, indicate that a material uncertainty exists that may cast significant doubt on the Company's ability to continue as a going concern. However, consent of Board of Directors is accorded to appoint a consultant for setting a new project, hence, the financial statements have been prepared on going concern basis.

### Key Audit Matters

Key audit matters ('KAM') are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. Except for the matters described in the "Basis for Qualified Opinion" section, we have determined the matters described below to be the key audit matters to be communicated in our report-

**Report on the Internal Financial Controls under Clause (i) of Sub-section 3 of Section 143 of the Companies Act, 2013 ("the Act")**

We have audited the internal financial controls over financial reporting of Rajasthan Cylinders and Containers Limited ("the Company") as of 31<sup>st</sup> March 2026 in conjunction with our audit of the financial statements of the Company for the year ended on that date.

**Management's Responsibility for Internal Financial Controls**

The Company's management is responsible for establishing and maintaining internal financial controls based on the internal control over financial reporting criteria established by the Company considering the essential components of internal control stated in the Guidance Note on Audit of Internal Financial Controls over Financial Reporting issued by the Institute of Chartered Accountants of India (ICAI). These responsibilities include the design, implementation and maintenance of adequate internal financial controls that were operating effectively for ensuring the orderly and efficient conduct of its business, including adherence to company's policies, the safeguarding of its assets, the prevention and detection of frauds and errors, the accuracy and completeness of the accounting records, and the timely preparation of reliable financial information, as required under the Companies Act, 2013.

**Auditor's Responsibility**

Our audit of internal financial controls over financial reporting included obtaining an understanding of internal financial controls over financial reporting, assessing the risk that a material weakness exists, and testing and evaluating the design and operating effectiveness of internal control based on the assessed risk. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion on the Company's internal financial controls system over financial reporting.

**Meaning of Internal Financial Controls over Financial Reporting**

A company's internal financial control over financial reporting is a process designed to provide reasonable assurance regarding the reliability of financial reporting and the preparation of financial statements for external purposes in accordance with generally accepted accounting principles. A company's internal financial control over financial reporting includes those policies and procedures that (1) pertain to the maintenance of records that, in reasonable detail, accurately and fairly reflect the transactions and dispositions of the assets of the company; (2) provide reasonable assurance that transactions are recorded as necessary to permit preparation of financial statements in accordance with generally accepted accounting principles, and that receipts and expenditures of the company are being made only in accordance with authorizations of management and directors of the company; and (3) provide reasonable assurance regarding prevention or timely detection of unauthorized acquisition, use, or disposition of the company's assets that could have a material effect on the financial statements.

**Inherent Limitations of Internal Financial Controls over Financial Reporting**

Because of the inherent limitations of internal financial controls over financial reporting, including the possibility of collusion or improper management override of controls, material misstatements due to error or fraud may occur and not be detected. Also, projections of any evaluation of the internal financial controls over financial reporting to future periods are subject to the risk that the internal financial control over financial reporting may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.

**Basis of Qualified Opinion**

According to the information and explanation given to us and based on our audit, the following material weaknesses have been identified as at March 31, 2026:

- The company's internal financial control were not operating effectively in respect of assessing interest payable under MSMED Act, 2006 and other disclosures of trade payable to micro enterprises and small enterprises has not been ascertained and not provided for which could potentially result in company not recognizing possible interest on this account.
- The company's internal financial controls were not operating effectively in respect of balance confirmation of Trade payables, Financial assets (including employee's advances), Advances including advance to suppliers, Loans given and Unsecured Loans taken.
- The Company has recognised deferred tax assets amounting to Rs. 650.76 Lakhs as on 31 March 2026, on the basis of expected availability of future taxable profits for utilization of such deferred tax assets. However, in view of the history of losses recorded by the Company and no operational segment, we are unable to comment on any adjustments that may be required to the carrying value of aforesaid net deferred tax assets as at 31 March 2026.
- Loans & Advances includes Rs. 230.50 Lakhs receivable from related parties of the company. In absence of any agreement and repayment terms, we are unable to comment on recoverability of the same.

Material weakness is a deficiency, or a combination of deficiencies, in internal financial control over financial reporting, such that there is a reasonable possibility that a material misstatement of the Company's annual financial statements will not be prevented or detected on a timely basis.

**Qualified Opinion**

In our opinion, except for the possible effects of the material weaknesses described above and on the achievement of the objectives of control criteria, the Company has, in all material respects, an adequate internal financial controls system over financial reporting and such internal financial controls over financial reporting were operating effectively as at March 31, 2026, based on the internal control over financial reporting criteria established by the Company considering the essential components of internal control stated in the Guidance Note on Audit of Internal Financial Controls Over Financial Reporting issued by the ICAI.

We have considered the material weaknesses identified and reported above in determining the nature, timing and extent of audit tests applied in our audit of the financial statements of the Company for the year ended March 31, 2026 and these material weaknesses have affected our opinion on the financial statements of the Company and we have issued a qualified opinion on the financial statements.

The company has closed the operations at the Company's manufacturing unit located at SP – 825, Road No.14, V K I Area, Jaipur -302013 w.e.f 9th December, 2022 due to unsatisfactory performance of the company with continued operational losses. The company has disposed off substantial Plant & Machinery in one or more tranches. These events or conditions, indicate that a material uncertainty exists that may cast significant doubt on the Company's ability to continue as a going concern. However, consent of Board of Directors is accorded to appoint a consultant for setting up a new business and the company is in process of appointment of a consultant for setting a new project, hence, the financial statements have been prepared on going concern basis.

**Note '37': LEASES**

**B FINANCIAL RISK MANAGEMENT**

**i. Credit risk**

Credit risk refers to the risk of default on its obligation by the counter party resulting in a financial loss. The Company is exposed to credit risk mainly from trade receivables, other financial assets like security deposits, bank deposits and loans. Security deposits and bank deposits are mostly with banks, hence the company does not expect any credit risk with respect to these financial assets. Loans are given for business purposes and the company reassess the recoverability of loans periodically and interest recoveries from these loans are regular and there is no event of default. Trade receivables includes significant portion of dues from state government corporations, hence, probability of default is remote. Credit risk on trade receivables is managed by the Company through credit approvals, establishing credit limits and continuously monitoring the creditworthiness of customers to which the Company grants credit terms in the normal course of business.
