**Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”)**

Further to our intimations dated February 27, 2024 and May 11, 2024 and pursuant to provisions of Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015 (Listing Regulations) read with SEBI Master Circular dated January 30, 2026, please note that Learned Income Tax Appellant Tribunal, New Delhi (“Ld. ITAT, New Delhi”) vide its order nos. ITA No. 1449/Del/2024 and 1821/Del/2024 (Assessment Year : - 2018-19) dated May 18, 2026 received on May 19, 2026 has dismissed the appeal filed by Income Tax Department and ordered the Company’s appeal in its favour against the order dated February 26, 2024, which was partly in favour of the Company, passed by Commissioner of Income Tax (“CIT”) (Appeals) for the AY 2018-19. The details are as follows:

- For the A.Y. 2018-19, CIT Appeals had allowed four (4) out of five (5) grounds in favour of the Company with an amount involving Rs. 12,46,14,878/- and the remaining one (1) ground with amount involving Rs. 1,52,42,500/- was dismissed, against which the Company filed appeal on March 30, 2024 before Ld. ITAT, New Delhi. Also, the Assistant Commissioner of Income Tax (“ACIT”), New Delhi filed an appeal before Ld. ITAT, New Delhi on 3 grounds out of 4 decided in favour of the Company on April 19, 2024 involving a total amount of Rs 12,43,38,323/- .

The appeal filed by the Company has been admitted and ruled in its favour by the Ld. ITAT, New Delhi. Further, the appeal filed by ACIT has been dismissed on all 3 grounds involved.

There is no impact on financial, operational or other activities of the Company as of now. Any further update, if any, in this connection will be submitted to the Stock Exchanges in due course.
