In relation to the application initially submitted by the Company on June 09, 2025, and subsequently resubmitted on August 12, 2026, seeking re-classification of certain shareholders from the 'Promoter' category to the 'Public' category, the Stock Exchanges sought certain documents, information and clarifications from the Company in connection with the application.

The Company was in the process of collating the requisite documents and information from the concerned stakeholders and, upon completion of the collation process, resubmitted the application along with the requisite documents and information.

However, the National Stock Exchange of India Limited ("NSE") subsequently rejected/closed the application on the ground that the application had been closed due to prolonged submission. The NSE further informed the Company that, if it intends to pursue the matter further, it may do so by filing a fresh application along with the applicable fees.

The Company is accordingly evaluating the next course of action in relation to the proposed re-classification.
