Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI master circular dated 30th January, 2026, we are disclosing that Nomination and Remuneration Committee of UTI Asset Management Company Limited has; on 6th August, 2026 at 0930 hrs IST; approved the allotment of 4,263 equity shares of face value of ₹10 each pursuant to the exercise of options by eligible employee under ‘UTI AMC Employee Stock Option Scheme – 2007’.

Post the aforesaid allotment, the issued and paid-up share capital of the Company shall be increased from ₹ 1,28,53,45,650 (12,85,34,565 equity shares of face value of ₹10 each) to ₹ 1,28,53,88,280 (12,85,38,828 equity shares of face value of ₹10 each).

The new equity shares shall rank *pari-passu* in all respects with the existing equity shares.
