NOTES:

- a) **A MEMBER ENTITLED TO ATTEND AND VOTE AT THE ANNUAL GENERAL MEETING (THE “MEETING”) IS ENTITLED TO APPOINT A PROXY TO ATTEND AND VOTE INSTEAD OF HIMSELF / HERSELF AND SUCH PROXY NEED NOT BE A MEMBER OF THE COMPANY.** A person can act as proxy on behalf of members not exceeding 50 (fifty) and holding in aggregate not more than 10% of total share capital of the company carrying voting rights. A member holding more than ten percent of the total share capital of the Company carrying voting rights may appoint a single person as proxy and such person shall not act as a proxy for any other person or shareholder. The instrument of proxy in order to be effective must be received by the Company not less than 48 hours before the commencement of the annual general meeting. A Proxy form is annexed herewith and same is available on the Company's website www.khandelwalextractions.com. Proxies submitted on behalf of the Companies must be supported by an appropriate resolution/authority as applicable.
- b) Only Members / Proxies / Representatives / Invitees of the Company are permitted to attend the Meeting at the venue. Attendance of any other individuals, including relatives and acquaintances accompanying Members, is strictly prohibited.

- c) The Register of members and Share Transfer books of the Company will remain closed from **19th September, 2026 to 26th September, 2026** (both days inclusive).
- d) The Annual Report for the financial year 2025-26 including the Notice of the AGM is being sent by electronic mode to those Members whose email IDs are registered with the Depository Participants (“DPs”)/the Company/its Registrar and Transfer Agent (“RTA”). Members who have not registered their email IDs so far are requested to promptly register/update their email ID with their respective DPs, in case of shares held in dematerialised form, or with the Company/RTA, in case of shares held in physical form. In compliance with Regulation 36(1)(b) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Members whose email IDs are not registered with the Company/DPs/RTA will be sent a letter providing the web-link and exact path where the complete Annual Report, including the Notice of the AGM, is available. Members may also request for a physical copy of the Annual Report and Notice of AGM from the Company/RTA, as applicable.
- e) The Notice calling the AGM has been uploaded on the website of the Company at www.khandelwalextractions.com. The Notice can also be accessed from the website of stock exchange i.e. BSE Limited at www.bseindia.com and notice is also available on website of CDSL (agency for providing Remote e-Voting facility) at www.evotingindia.com.
- f) The Company has entered into necessary arrangements with National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) to enable the shareholders to dematerialize their shareholding in the Company for which they may contact the Depository Participant of the above Depositories. The Company’s ISIN No. is INE687W01010.
- g) Members are requested to lodge Share Transfer documents and all other correspondences and queries relating to Share Transfer, Share Certificates, Change of Address etc., to the Company’s Registrar and Transfer Agent (“RTA”) i.e. M/s Alankit Assignments Limited having its office at Alankit House, 4E/2, Jhandewalan Extension, New Delhi – 110055
- h) Members are requested to register/update/intimate changes, if any, pertaining to their name, postal address, email address, telephone/mobile numbers, Permanent Account Number (PAN), signature, bank mandate, demat account details, nomination and other KYC details, in the following manner:
 - i. For shares held in physical form: Members are requested to furnish/update the aforesaid details with the Company/RTA in the prescribed forms, including Form ISR-1 and other applicable forms, in accordance with the applicable SEBI circulars/master circulars issued from time to time. The prescribed forms are available on the website of the Company at www.khandelwalextractions.com.
 - ii. For shares held in electronic form: Members are requested to approach their respective Depository Participants (“DPs”) for registration/updation of the aforesaid details in their demat account.
- i) Pursuant to the provisions of SEBI circular no. SEBI/HO/MIRSD/MIRSDPoD-1/P/CIR/2023/37 dated March 16, 2023 w.r.t “Common and Simplified norms for processing investor’s service requests by RTAs and norms for furnishing PAN, KYC details and Nomination”, all the shareholders holding shares in physical form are requested to approach for furnishing their PAN, Nomination, Contact details, Bank Account Details and specimen signature for their corresponding folio numbers etc. To the Registrar and Transfer Agent of the Company (“RTA”) viz. M/s Alankit Assignments

Limited in the format/mode as prescribed under above mentioned SEBI Circular. Shareholders holding shares in dematerialized form are requested to approach their respective depository participants for updating above mentioned details.

- j) Securities and Exchange Board of India has mandated the submission of Permanent Account Number (PAN) and Bank details by every shareholder, accordingly, shareholders are requested to please update PAN and Bank details to their Depository Participant in case of Demat holding. Members holding shares in physical form may submit the PAN and Bank details to the Company or the Registrar.
- k) Transfer of securities in physical mode was discontinued with effect from 01st April, 2019. However, in order to facilitate ease of investing for investors and to secure the rights of investors in the securities which were purchased by them, SEBI has opened a special window only for Transfer and Dematerialization of Physical Share Certificates to facilitate investors who had purchased / sold shares prior to 01st April, 2019 and transfer deed was duly executed before 01st April, 2019, but the transfer could not be registered. A onetime opportunity is given to facilitate these shareholders from 5th February, 2026 to 04th February, 2027. During this period, the shareholders are requested to please lodge pending transfer requests, if any, and complete the transfer procedure within the timelines as allowed by the SEBI. Securities that are re-lodged for transfer shall be issued only in demat mode and shall be locked in for a period of one year from the date of credit.
- l) Pursuant to Section 72 of the Companies Act, 2013 and applicable SEBI regulations/circulars, the facility for making nomination is available to Members in respect of the shares held by them. Members who have not yet registered their nomination are requested to register the same by submitting Form SH-13. Members who wish to modify/variation their existing nomination may submit Form SH-14. Members who wish to opt out of nomination may submit Form ISR-3 after cancelling their existing nomination, if any, through Form SH-14. The aforesaid forms are available on the website of the Company at www.khandelwalextractions.com. Members holding shares in dematerialised form are requested to submit the requisite forms/details to their respective Depository Participants and Members holding shares in physical form are requested to submit the same to the Company/RTA, as applicable.
- m) Members may further note that SEBI has mandated listed companies to issue securities in dematerialised form only while processing various service requests relating to securities held in physical form, including issue of duplicate securities certificate, claim from unclaimed suspense account, subdivision/splitting of securities certificate, consolidation of securities certificates/folios, transmission, transposition, etc. Accordingly, Members holding securities in physical form are requested to make such service requests by submitting the duly filled and signed Form ISR-4, as applicable, the format of which is available on the Company's website at www.khandelwalextractions.com. Members are advised to ensure that their folio is KYC compliant for processing of such service requests. In view of the above and to eliminate the risks associated with holding physical share certificates, Members holding shares in physical form are strongly advised to dematerialise their shareholding at the earliest for safer and more convenient holding and management of their securities.
- n) In terms of Section 108 of the Companies Act 2013 read with relevant applicable rules and pursuant to Regulation 44 of SEBI (Listing Obligations and Disclosure

Requirements) Regulations, 2015, the Company has made arrangement of e-voting through CDSL. Members have option to cast their vote by using electronic voting system from a place other than the venue of the meeting (remote e-voting). Members who wish to cast the vote at AGM shall be provided a Ballot to cast their vote. The members who have cast their vote by remote e-voting may also attend the meeting but shall not be entitled to cast/change their vote again in the meeting. Information and instructions relating to e-voting are provided at end of the notice. The details of User ID and Password relating to e-voting are sent herewith.

- o) In case of joint holders attending the Meeting, only such joint holder who is higher in the order of names will be entitled to vote.
- p) The voting rights of the members shall be in proportion to their shares of the paid-up share capital of the Company as on the cutoff date i.e. 19th September, 2026. The poll process shall be conducted and scrutinized and report thereon will be prepared in accordance with Section 109 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 as amended from time to time.
- q) The remote e-voting period commences at 10:00 a.m. IST on Wednesday, September 23, 2026 and ends at 5.00 p.m. IST on Friday, September 25, 2026. During these period members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date i.e., Saturday, September 19, 2026, may cast their vote electronically in the manner and process set out here in above. The remote e-voting module shall be disabled for voting thereafter. Once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently.
- r) The Company has appointed M/s. Banthia & Co. (Prop. Mr. G.K. Banthia) of Kanpur, Practicing Company Secretaries (C.P. No. 1405) as the Scrutinizer for conducting the e-voting and polling process in fair and transparent manner who have consented to be available for the same.
- s) The scrutinizer after scrutinizing the votes cast at the meeting and through remote e-voting, will, not later than two working days of conclusion of the meeting, make a consolidated scrutinizer's report and submit the same to the Chairman. The results declared along with the consolidated scrutinizer's report shall be placed on the website of the Company www.khandelwalextractions.com and on the website of CDSL www.evotingindia.com. The results will simultaneously be communicated to the Stock Exchange(s).
- t) Subject to receipt of requisite number of votes, the Resolutions shall be deemed to be passed on the date of the Meeting, i.e. 26th September, 2026.
- u) A Route Map showing directions to reach the venue of AGM is attached at the end of this Annual Report as per the requirement of the Secretarial Standard-2 on General Meetings.
- v) Register of Directors and KMP and their Shareholding maintained u/s 170, Register of contracts and arrangements in which Directors are interested u/s 189 shall be open for inspection of the member during AGM.
- w) All documents referred to in the accompanying notice shall be open for inspection at the registered office of the Company between 02:00 pm to 04:00 pm on all working days except Saturday up to the date of Annual General Meeting.

THE INTRUCTIONS OF SHAREHOLDERS FOR REMOTE E-VOTING:

Step 1 : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

Step 2 : Access through CDSL e-Voting system in case of shareholders holding shares in physical mode and non-individual shareholders in demat mode.

- (i) The voting period begins on 23rd September 2026 at 10:00 A.M. and ends on 25th September 2026 at 05:00 P.M. During this period shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. 19th September, 2026 may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple –voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

Step 1: Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (iv) In terms of **SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020** on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

Pursuant to above said SEBI Circular, Login method for e-Voting for **Individual shareholders holding securities in Demat mode CDSL/NSDL** is given below:

(x) On the voting page, you will see “RESOLUTION DESCRIPTION” and against the same the option “YES/NO” for voting. Select the option YES or NO as desired. The option YES implies that you assent to the Resolution and option NO implies that you dissent to the Resolution.

(xi) Click on the “RESOLUTIONS FILE LINK” if you wish to view the entire Resolution details.

(xii) After selecting the resolution, you have decided to vote on, click on “SUBMIT”. A

confirmation box will be displayed. If you wish to confirm your vote, click on “OK”, else to change your vote, click on “CANCEL” and accordingly modify your vote.

(xiii) Once you “CONFIRM” your vote on the resolution, you will not be allowed to modify your vote.

(xiv) You can also take a print of the votes cast by clicking on “Click here to print” option on the Voting page.

(xv) If a demat account holder has forgotten the login password then Enter the User ID and the image verification code and click on Forgot Password & enter the details as prompted by the system.

(xvi) There is also an optional provision to upload BR/POA if any uploaded, which will be made available to scrutinizer for verification.

(xvii) Additional Facility for Non – Individual Shareholders and Custodians –For Remote Voting only.

- Non-Individual shareholders (i.e. other than Individuals, HUF, NRI etc.) and Custodians are required to log on to www.evotingindia.com and register themselves in the “Corporates” module.
