That the underlying petition under Section 95(1) of the Code was filed by Bank of Baroda ("Financial Creditor") for initiation of insolvency resolution process against Mrs. Prabha Singh (Personal Guarantor) in respect of the debt arising out of credit facilities extended to the Corporate Debtor, M/s Kakan Rice Mill Pvt. Ltd.
4. This Tribunal by an order dated 23.03.2026 appointed the Applicant herein as the RP to examine the application and submit a report under Section 99 of the Code.
5. That the Applicant had conducted a detailed examination of the application, relevant records, financial documents and submissions made by the Financial Creditor, in accordance with the provisions of the Code and applicable regulations.
