ORDER

I.A. Nos.212981/2026, 212980/2026, 212979/2026 and 212978/2026 in CIVIL APPEAL Nos.2369-2380/2022:

1. Read the office report dated 10th August, 2026.
2. Pursuant to settlement agreements reached by and between the parties, all the appellants barring Mr. Sandeep Singh (appellant in Civil Appeal No.2372/2022) have decided not to proceed with their appeals and they are sought to be withdrawn, as detailed below:

3. Thus, since the appellants in Civil Appeal Nos.2369/2022, 2370/2022, 2373/2022 and 2376/2022 are seeking withdrawal of the said appeals on the ground of settlement having been reached, we

permit such withdrawal and order that Civil Appeal Nos. 2369/2022, 2370/2022, 2373/2022 and 2376/2022 shall stand dismissed as withdrawn, at the instance of the aforesaid appellants.

4. I.A. Nos.212981/2026, 212980/2026, 212979/2026 and 212978/2026 are allowed.

5. Office to take appropriate notice of this order and make necessary endorsement.

6. Civil Appeal No.2372/2022 may now be pursued by the appellant – Mr. Sandeep Singh and be listed on next Tuesday, i.e., 18th August, 2026. Since we are informed that Mr. Sandeep Singh and the respondent – M/s. DLF Ltd. are also negotiating an out of the Court settlement, any such settlement if arrived at in the meanwhile may be placed on record.

CIVIL APPEAL No.9096/2022:

7. Appellant – Shilpa Jain and the respondent no.1 – M/S DLF Ltd. have settled the inter-se disputes and differences.

8. The Supreme Court Mediation Centre has forwarded a copy of the settlement agreement dated 29th May, 2026 executed by the appellant as well as the respondent no.1 – M/s. DLF Ltd. in the presence of the mediator. The settlement agreement is taken on record.

9. None appears on behalf of the appellant.

10. Mr. Pinaki Misra, learned senior counsel appearing for the respondent no.1 – M/S DLF Ltd. submits that the appeal may be disposed of treating the terms of settlement as part of the order.

11. We order accordingly. The appeal stands disposed of.

12. In the event, however, that the appellant has any grievance in respect of disposal of the appeal in her absence, we grant her liberty to file an application for recall of this order.

13. Pending application(s), if any, shall also stand closed.
