O R D E R

1. Leave granted.

2. The appellant challenges the judgment and order dated 10.03.2025 in Writ Petition No. 8426/2022 passed by the High Court of Judicature at Bombay titled "*Nalanda Bansiddhappa Gaikwad vs. Adhyaksha/Vyavasthapakiya Sanchalak Jagdish Electronics India Pvt. Ltd.*"

3. Having heard learned counsel for the parties, we are of the considered view that interest of justice would be best met with the modification of the impugned order and the amount of compensation being enhanced from a sum of Rs.6,00,000/- (Rupees Six Lakhs only) to Rs.13,00,000/- (Rupees Thirteen Lakhs only).

4. It is not in dispute that a sum of Rs.6,00,000/- (Rupees Six Lakhs) already stands disbursed to the appellant. Let the remaining amount of Rs.7,00,000/- (Rupees Seven Lakhs only) lump sum be remitted into the bank account of the appellant within a period of two weeks from today. The particulars of the bank account be supplied by the learned counsel for the appellant to the learned counsel for the respondent.
5. The impugned order dated 10.03.2025 in Writ Petition No. 8426/2022 stands modified to the above extent.
6. Needless to add, all disputes and claims *inter se* the parties stand fully settled.
7. We appreciate the efforts put in by Ms. Tanaya Patankar assisted by Mr. Nakul Patwardhan, learned counsel for the appellant and Anand Dilip Landge, learned counsel for the respondent.
8. The appeal is allowed.
9. Pending application(s), if any, shall stand disposed of.
