In relation to the civil complaint (No. 24-CV-08080) filed before the United States District Court for the Eastern District of New York (“**US Eastern District NY Court**”) by the United States Securities and Exchange Commission (“**US SEC**”) against Mr. Gautam Adani and Mr. Sagar Adani, we would like to inform you that the US SEC, Mr. Gautam Adani and Mr. Sagar Adani have filed their request for entry of final judgment, on consent, before the US Eastern District NY Court on May 15, 2026 India Time/ May 14, 2026 New York Time. The final judgment is awaited.
