Concurring to the recommendation of Audit Committee, the Board has accorded approval for writing off of outstanding dues recoverable from VLS Asset Management Limited ("VAML"), a non-material subsidiary of the Company, aggregating to Rs. 9,68,880.75 (Rupees Nine Lakhs Sixty Eight Thousand Eight Hundred Eighty and Seventy Five Paise only) inter alia to facilitate closure of said subsidiary by adopting procedure under Section 248 of the Companies Act, 2013 subject to approvals.
7. The Board concurring to the recommendation of Audit Committee, has accorded approval for the proposal for appointment of Grant Thornton Bharat LLP as Internal Auditor of the Company for the Financial Year 2026-27, subject to requisite documentation.

Opinion

1. We have audited the accompanying Statement of audited standalone annual financial results ('the Statement') of VLS Finance Limited ('the Company') for the quarter and year ended 31 March 2026, attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) including relevant circulars issued by the SEBI from time to time.

- 5 The Board of Directors of the Company in its meeting held on 22-November-2025 has approved buy-back of its own shares through tender route under stock exchange mechanism in terms of proviso to clause (b) of sub section 2 of section 68 of the Companies Act, 2013 and other applicable regulations. The buyback so approved opened from 18/12/2025 and closed on 24/12/2025. During this period 26,31,578 equity shares of Rs 10/- each have been bought back by the company at a rate of ₹ 380/- per share. A total sum of ₹ 99,99,99,640 (Rupees Ninety Nine Crores ninety nine lakhs ninety nine thousand six hundred forty only)(excluding transaction costs) was utilised for the said buyback. The Requisite compliances under the applicable provisions of the Companies Act, 2013, SEBI regulations, and other relevant laws have been duly made in respect of aforesaid buyback. The equity shares bought back were extinguished on 13 January 2026. Accordingly, Earnings Per Share (EPS) has been calculated based on the weighted average number of equity shares outstanding as at 31 March 2026.
- 6 On November 21st, 2025, the Government of India notified the four new Labour Codes (the Code on Wages, 2019, the Code on Social Security, 2020, the Industrial Relations Code, 2020 and the Occupational Safety, Health and Working Conditions Code, 2020) consolidating 29 labour laws. The Company and the Group have carried out assessment of the impact of these Labour Codes and have recognised the relevant expense, wherever applicable, under 'Employee Benefits Expense'.
- 7 The figures for the last quarter of the year ended on 31 March 2026 and last quarter of the previous year are the balancing figures between audited figures in respect of the full financial year and the published year-to-date figures upto third quarter, for both years.
- 8 The Board of Directors have proposed final dividend of Rs 1.50 per equity share for the financial year ended 31-March 2026. The Dividend will be 15% on face value of Rs.10/- per equity share, subject to approval by the members of the Company at the forthcoming Annual General Meeting.
- 9 The columns relating to profit/loss from discontinued operations have been dispensed with in above results because there were no operations which were discontinued during relevant Quarter/Period.
- 10 The Company operates in single segment viz. investments and dealing in Shares/Securities & Derivatives, hence segment-wise reporting has not been made.
- 11 Previous period figures have been regrouped / reclassified wherever necessary to conform to current period classification and rounding off errors have been ignored. The amounts reflected as "0" or "-" in the financial information are values with less than rupees five hundred.
