Subject: Clarification and Corrigendum to the disclosure dated September 19, 2026 regarding bagging/receipt of contract for lifting of Pond Ash and Fly Ash

Dear Sir/ Ma'am,

With reference to the Company's disclosure dated September 19, 2026 regarding the contract awarded to Refex Industries Limited for lifting of Pond Ash and Fly Ash under RCR (Road-cum-Rail) Mode, we wish to clarify that the quantity under the said contract is **10 Lakh Metric Tonnes** and not **10 Metric Tonnes**, as inadvertently stated in the earlier disclosure.

The aforesaid error was purely typographical in nature. There is no change in the underlying contract, its value, scope, execution period or any other terms disclosed earlier. The corrected disclosure, incorporating the accurate quantity, is enclosed as **Annexure A** for ease of reference.
