We confirm that there are no material reasons for his resignation other than those provided above.

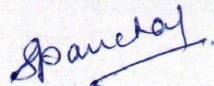

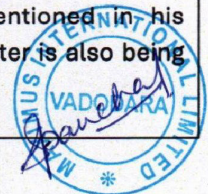
