Pursuant to the provisions of Regulation 30 of the Listing Regulations read with Schedule III and the SEBI Master Circular HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026, we wish to inform you that Jubilant Generics Limited (“JGL”) (a wholly owned step down Indian subsidiary) has received an order from the Income-tax department.

JGL believes that the impugned tax adjustments have been made ignoring the facts and contentions of the Company. Hence, JGL is in the process of filing necessary appeal in relation thereto. An application before the Advance Pricing Authority covering the year under consideration has also been filed separately. Post such adjudication or redressal process, impugned tax adjustments are likely to get deleted.
