**National | July 14, 2026:** Avio Smart Market Stack Limited has signed a MoU with the Government of Tripura to establish a state-of-the-art freeze-drying facility for fresh fruits and vegetables, marking a significant step towards strengthening agro-processing infrastructure and creating sustainable livelihood opportunities in the Northeast.
