Subject: Clarification in respect of significant movement in the price of security of Genesys International Corporation Limited ("Company")

This is with reference to the communication received from the Stock Exchange(s) seeking clarification from Genesys International Corporation Limited ("Company") regarding the significant movement observed in the price of security across Exchanges, in the recent past.

In this regard, we wish to submit and clarify as under:

The Company has been and continues to be in compliance with the disclosure requirements prescribed under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), and has been making timely disclosures to the Stock Exchanges of all events and information which are required to be disclosed thereunder.

As on the date of this clarification, there is no undisclosed material event, information or impending announcement in the knowledge of the Company which is required to be disclosed under Regulation 30 of the SEBI Listing Regulations and which, in the opinion of the Company, may have a bearing on the price/volume behaviour of the Company's securities.

The Company has taken note of a news article published in the online edition of *Gujarat Samachar* on August 24, 2026, inter alia, reporting that Ahmedabad Municipal Corporation ("AMC") has awarded a contract to the company stated to be valued at approximately ₹240 crore for undertaking a comprehensive 3D GIS survey/mapping project for the city of Ahmedabad.

In this connection, the Company wishes to clarify that as on the date and time of this clarification, the Company is yet to receive a formal communication from Ahmedabad Municipal Corporation confirming the award of the aforesaid contract to the Company.

Accordingly, no disclosure regarding award/receipt of the aforesaid contract has been made by the Company under Regulation 30 of the SEBI Listing Regulations, since no formal award/order or other definitive communication confirming such award has been received by the Company as on date.



The aforesaid news article was not issued, published, authorized or caused to be published by the Company, and the Company has not made any announcement to the media or to the public representing that the aforesaid contract has been awarded to it.

The Company shall continue to monitor developments in this regard and, if and when any formal award/order or definitive communication is received which triggers a disclosure obligation under the SEBI Listing Regulations, the Company shall promptly make the requisite disclosure to the Stock Exchanges in accordance with applicable law.

This clarification is being submitted in response to the communication received from the Stock Exchange(s) and in the interest of investors and other stakeholders, with a view to place the correct factual position on record and avoid any unwarranted speculation arising from the aforesaid media report.

You are requested to kindly take the above clarification on record and disseminate the same.
