O R D E R

Mr. Vinayak Sharma, learned standing counsel for
the respondent(s)-State of Chhattisgarh, has handed

over four demand drafts drawn in favour of the petitioner-Company, each valued at Rs.50,44,165/- (Rupees Fifty Lakh Forty Four Thousand One Hundred and Sixty Five Only), total amounting to Rs.2,01,76,660/- (Rupees Two Crore One Lakh Seventy Six Thousand Six Hundred and Sixty Only), which, according to the respondent(s), is the amount due and payable to the petitioner-Company for the work done.

In that view of the matter, we dispose of the present proceedings as the amount for the work done has already been paid to the petitioner.

We, further direct the petitioner to cure/rectify the defects, as may be pointed out by the respondent(s) in writing, within two weeks from today. The petitioner shall cure/rectify such defects within a further period of four weeks from the date of communication thereof.

In the event, the defects are not cured/rectified within the aforesaid period, it shall be open to the respondent(s) to apply for refund of the amount.
