- I. The name of the Company is **ITL INDUSTRIES LIMITED**.
- II. The Registered Office of the Company will be situated in the State of Madhya Pradesh.
- III. The objects for which the Company is established are as under :

**(A) THE OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:**

1. To Carry on the business of designing, manufacturing, developing, fabricating, improving, buying, selling, importing, exporting, and dealing, in machinery, machinery tools, jigs, fixture's dies moulds, cutters, saws, knives, implements, automotive parts, machinery spares and precision machine components and in particular to manufacture, machine, give heat treatment, produce, repair, alter, convert, recondition, prepare for sales buy, distribute, sell, hire, import, export, let-out on hire trade and deal and to take up job work in machine tools and implements, apparatus, appliances, precision instruments components parts, accessories. Fittings and things in any stage or degree of manufacture, process or refinement.
2. To buy, sell or otherwise dispose of manufacture, assemble, work, store, distribute, repair, convert, alter, remodel, let on hire and deal in machinery, implements, lathes, shaper, bandsaws, jig bores, presses, drill machine, girders, milling machines, slotters, furnaces, rolling stock and hardware, precision measuring instruments, mechanical instruments and accessories.
3. To carry on all or any of the businesses of manufacturing, processing and dealing in iron and steel, ferrow alloys, special steels, aluminum, brass, copper lead, zinc, and their alloys and products and manufacturing and dealing in industrial machineries internal combustion engines, ball, roller and tapered bearings tubes, cables wires, pipes, cookers, printing machinery and textile machinery and their parts components and accessories.
4. To carry on in India or elsewhere the business in the field of information technology and information technology enabled services including Hardware

**B. MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE III (A) ARE**

1. To manufacture, produce process, design fabricate, assemble, buy, sell, import, export and deal in products or by-products, commodities, raw materials, stores, tools, dies, jigs, fixtures, moulds, gauges, plants and machinery used in the manufacture of items stated above whether in India or abroad and to offer technical consultancy services in general and to those intending to manufacture commodities machinery or equipment of the type manufactured by the Company.
2. To amalgamate enter in to partnership or partially amalgamate with or acquire interest in the business of any other company, person or firm carrying on business included in the objects of the company or enter into any arrangements for sharing profits or for co-operation or for limiting competition, or for mutual assistance with any such person, firm or company or to acquire and carry on any other business (whether manufacturing or otherwise) ancillary to the business of the company or connected therewith or which may seem to the company capable of being conveniently carried on in connection with the above or calculated directly or indirectly to enhance the value or render more profitable any of the company's property and to give or accept by way of consideration for any of the acts or things aforesaid or property acquired, any shares. Debentures, debenture-stock or securities that may be agreed upon and to hold and retain or to sell, mortgage and deal with any shares, debenture stock or securities so received.
3. To acquire from time to time and to manufacture and to deal in all such stock in trade, goods, chattels and effects as may be necessary or convenient for any of the business for the time being carried on by the company.
4. To acquire and takeover the whole or any part of the business, properties and liabilities of any person or persons, firm or company, carrying on any business which this company is authorized to carry on or possessed of any property or rights suitable for the purposes of this company.
5. To undertake or participate in the formation, management, supervision or control of the business operation of any other Company, firm or person.
6. To apply for secure acquire by grant, legislative, enactment. Assignment, transfer, purchase or otherwise and to exercise, carry out and enjoy any charter, license, power, authority, franchise, concession, right or privilege, which any Government or authority, or any Corporation or other Public Body may be empowered to grant, and to pay for, aid in, and contribute towards carrying on the same into effect.
7. To apply for promote and obtain statute, order, regulation or other authorization or enactment which may seem calculated directly or indirectly to benefit the Company,

and to oppose any bills, proceeding, or applications, which may seem calculated directly or indirectly to prejudice the Company's interest.

8. To purchase, take on lease or in exchange or otherwise acquire any real or personal property, patents, licenses, rights or privileges which the company may think it necessary and convenient for the purposes of its business and to construct, maintain and alter any building or works necessary or convenient for the purposes of the company.
9. To enter into any arrangements with any government or authorities, supreme, municipal, local or otherwise that may seem conducive to the company's object or any of them and to obtain from any such Government or authority, any rights, privileges and concessions which the Company may think the desire to obtain, and to carry out, exercise and comply with any such arrangements, privileges and concessions.
10. Subject to the Provision of Section 73 to 76 of the Companies Act, 2013 and the Rules made there under and directives of Reserve Bank of India to borrow or raise money on deposit or loan or by the issue of debentures stock, perpetual or otherwise or in such other manner as the Company shall take fit and for the purpose aforesaid to secure the repayment of any money borrowed, raised or owing by the mortgage lien or charge up on all or any of the Company's property or asset, present and future, including its uncalled Capital collaterally or further to secure any securities of the company by a trust deed or other assurance.
11. To draw, make, accept, endorse, discount, execute and issue promissory note, bills of exchange, bill of lading, Warrants, debentures and other negotiable or transferable instruments.
12. To lend money or on any terms that may be thought fit, and particularly to customers or other persons having dealings with the company, but that the company will not do the business of banking.
13. To establish, provide maintain and conduct or otherwise subsidize research laboratories and experimental workshops for scientific and technical research and experiments and to undertake and carry on with all scientific and technical researches, experiments and tests of all kinds and to promote studies and research both scientific and technical investigation and inventions by providing subsidizing, endowing or assisting laboratories workshops, libraries, lectures, meetings and conferences by providing for the remunerations of scientific or technical professors or teachers and by providing for the awards to students or otherwise and generally to encourage, promote and reward studies. Researches, investigations, experiments, tests, and inventions of any kind that may be considered likely to assist any of the business, which the company is authorized to carry on.

To obtain any provisional order or Act of the Government of India or any provincial Government for enabling the company to carry any of its objects in effect, or for effecting any modification of the Company's constitution, or for any other purpose which may seem expedient and to oppose any proceeding or applications which may

16. To employee experts to investigate and examine in to the conditions prospect, value character and circumstances of any business concerned and undertaking and generally of any assets, concession, properties or Rights.
17. To establish or promote or concur in establishing or promoting any company or companies for the purpose of acquiring all or any of the property, rights and liabilities of the company or for any other purpose which, may seem directly or indirectly calculated to benefit the company.
18. To manufacture, buy, sell, exchange, alter, improve, manipulate, prepare for market and otherwise deal in all kinds of plant, machinery, apparatus, tools, utensils, receptacles, substances, materials, material, articles, and things necessary or convenient for carrying on any of the business or process of the company usually dealt in by persons engaged in the like business or process.
19. To repair, alter remodel, clean, renovate, convert, manipulate and prepare for sale and resale any goods from time to time belonging to the company.

### **SHARE CAPITAL**

5. The authorised share capital of the Company shall be as stated in Clause V of the Memorandum of Association of the Company, as altered from time to time in accordance with the provisions of the Companies Act, 2013 and the rules made thereunder.

8. Subject to the provisions of the Act and these Articles, the Board may allot and issue shares in the capital of the Company as payment or part-payment for any property or assets of any kind whatsoever sold or to be sold or transferred or to be transferred to the Company, or for goods or machinery supplied or to be supplied, or for services rendered or to be rendered, or for technical assistance or know-how made or to be made available to the Company or in connection with the conduct of its business.

The shares so allotted may be issued as fully paid-up or partly paid-up otherwise than in cash, subject to the provisions of the Act and the Applicable Law, and, if so issued, shall be deemed to be fully paid-up or partly paid-up, as the case may be.

9. The Company may increase its subscribed capital by the exercise of an option attached to any debentures issued or loans raised by the Company to convert such debentures or loans, or any part thereof, into shares in the Company, subject to the provisions of the Act and the terms and conditions governing such debentures or loans.

15. ### **FURTHER ISSUE OF SHARES**

16. The Board or the Company, as the case may be, may, in accordance with the Act and the Rules, issue further shares to-

(a) persons who, at the date of offer, are holders of equity shares of the Company; such offer shall be deemed to include a right exercisable by the person concerned to renounce the shares offered to him or any of them in favour of any other person; or

(b) employees under any scheme of employees' stock option; or

(c) any persons, whether or not those persons include the persons referred to in clause (a) or clause (b) above.

17. A further issue of shares may be made in any manner whatsoever as the Board may determine including by way of preferential offer or private placement, subject to and in accordance with the provisions of Section 42 and Section 62 of the Act and the Rules.

18. Nothing in the Article 16 and 17 shall apply to the increase of the subscribed capital of a Company caused by the exercise of an option as a term attached to the Debentures issued or loan raised by the Company to convert such Debentures or loans into shares in the Company.

Provided that the terms of issue of such Debentures or loan containing such an option have been approved before the issue of such Debentures or the raising of loan by a Special Resolution passed by the Company in a General Meeting.

19. Notwithstanding anything contained in Section 53 of the Act, but subject to the provisions of Section 54 of the Act, the rules made thereunder, and the applicable regulations and guidelines issued by the Securities and Exchange Board of India ("SEBI"), the Company may issue sweat equity shares of a class of shares already issued by the Company, in accordance with the provisions of the Act, the rules made thereunder and the applicable SEBI Regulations.

- ii. several certificates, each for one or more of his shares, upon payment of twenty rupees for each certificate after the first.

(b) Every certificate shall specify the shares to which it relates and the amount paid-up thereon and shall be signed by two directors or by a director and the Company secretary, wherever the Company has appointed a Company secretary.

(i) When a new share certificate has been issued in pursuance of sub-article (h) of this Article, it shall be in the form and manner stated under the Companies (Share Capital and Debentures) Rules, 2014.

(j) All blank forms to be used for issue of share certificates shall be printed and the printing shall be done only on the authority of a resolution of the Board. The blank forms shall be consecutively machine-numbered and the forms and the blocks, engravings, facsimiles and hues relating to the printing of such forms shall be kept in the custody of the Secretary or of such other person as the Board may authorize for the purpose and the Secretary or the other person aforesaid shall be responsible for rendering an account of these forms to the Board. Every forfeited or surrendered share held in material form shall continue to bear the number by which the same was originally distinguished.

(k) The Company Secretary of the Company shall be responsible for the maintenance, preservation and safe custody of all books and documents relating to the issue of share certificates including the blank forms of the share certificate referred to in sub- article (j) of this Article.

(l) All books referred to in sub-article (k) of this Article, shall be preserved in the manner specified in the Companies (Share Capital and Debentures) Rules, 2014.

### **COMMISSION FOR PLACING SHARES**

24. (a) The Company may exercise the powers of paying commissions conferred by sub-section (6) of Section 40 of the Act, provided that the rate percent or the amount of the commission paid or agreed to be paid shall be disclosed in the manner required by that section and rules made thereunder.

(b) The rate or amount of the commission shall not exceed the rate or amount prescribed in rules made under sub-section (6) of Section 40 of the Act.

(c) The commission may be satisfied by the payment of cash or the allotment of fully or partly paid shares or partly in the one way and partly in the other.

### **COMPANY'S LIEN**

25. The Company shall have a first and paramount lien:

(a) on every share (not being a fully paid share), for all monies (whether presently payable or not) called, or payable at a fixed time, in respect of that share; and

30. made in the register of members but no forfeiture shall be invalidated by any omission or neglect or any failure to give such notice or make such entry as aforesaid.

75. The forfeiture of a share shall involve extinction at the time of forfeiture, of all interest in and all claims and demands against the Company, in respect of the share and all other rights incidental to the share.
76. A forfeited share shall be deemed to be the property of the Company and may be sold or re-allotted or otherwise disposed of either to the person who was before such forfeiture the holder thereof or entitled thereto or to any other person on such terms and in such manner as the Board thinks fit.
77. At any time before a sale, re-allotment or disposal as aforesaid, the Board may cancel the forfeiture on such terms as it thinks fit.
78. A person whose shares have been forfeited shall cease to be a member in respect of the forfeited shares, but shall, notwithstanding the forfeiture, remain liable to pay, and shall pay, to the Company all monies which, at the date of forfeiture, were presently payable by him to the Company in respect of the shares.
79. All such monies payable shall be paid together with interest thereon at such rate as the Board may determine, from the time of forfeiture until payment or realisation. The Board may, if it thinks fit, but without being under any obligation to do so, enforce the payment of the whole or any portion of the monies due, without any allowance for the value of the shares at the time of forfeiture or waive payment in whole or in part.
80. The liability of such person shall cease if and when the Company shall have received payment in full of all such monies in respect of the shares.
81. A duly verified declaration in writing that the declarant is a director, the manager or the secretary of the Company, and that a share in the Company has been duly forfeited on a date stated in the declaration, shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the share.
82. The Company may receive the consideration, if any, given for the share on any sale, re-allotment or disposal thereof and may execute a transfer of the share in favour of the person to whom the share is sold or disposed of.
83. The transferee shall thereupon be registered as the holder of the share.
84. The transferee shall not be bound to see to the application of the purchase money, if any, nor shall his title to the share be affected by any irregularity or invalidity in the proceedings in reference to the forfeiture, sale, re-allotment or disposal of the share.
85. Upon any sale after forfeiture or for enforcing a lien in exercise of the powers hereinabove given, the Board may, if necessary, appoint some person to execute an instrument for transfer of the shares sold and cause the purchaser's name to be entered in the register of members in respect of the shares sold and after his name has been entered in the register of members in respect of such shares the validity of the sale shall not be impeached by any person.

86. Upon any sale, re-allotment or other disposal under the provisions of the preceding Articles, the certificate(s), if any, originally issued in respect of the relative shares shall (unless the same shall on demand by the Company has been previously surrendered to it by the defaulting member) stand cancelled and become null and void and be of no effect, and the Board shall be entitled to issue a duplicate certificate(s) in respect of the said shares to the person(s) entitled thereto.
87. The Board may, subject to the provisions of the Act, accept a surrender of any share from or by any member desirous of surrendering them on such terms as they think fit.
88. 89. The provisions of these Articles relating to forfeiture of shares shall mutatis mutandis apply to any other Securities including debentures of the Company.

### **ALTERATION OF CAPITAL**

90. Subject to these Articles and Section 61 of the Act, the Company may, by an Ordinary Resolution in General Meeting from time to time, alter the conditions of its Memorandum as follows, that is to say, it may:

(a) increase its Share Capital by such amount as it thinks expedient;

(b) consolidate and divide all or any of its Share Capital into shares of larger amount than its existing shares:

Provided that no consolidation and division which results in changes in the voting percentage of Shareholders shall take effect unless it is approved by the Tribunal on an application made in the prescribed manner;

(c) convert all or any of its fully Paid up shares into stock, and reconvert that stock into fully Paid up shares of any denomination;

(d) sub-divide its existing Shares, or any of them, into shares of smaller amount than is fixed by the Memorandum, so, however, that in the sub-division the proportion between the amount paid and the amount, if any, unpaid on each reduced share shall be the same as it was in the case of the share from which the reduced share is derived; and

(e) cancel its Shares which, at the date of the passing of the resolution in that behalf, have not been taken or agreed to be taken by any person, and diminish the amount of its Share Capital by the amount of the shares so cancelled. Cancellation of shares in pursuance of this Article shall not be deemed to be reduction of Share Capital within the meaning of the Act.

## **CONVERSION OF SHARES INTO STOCK AND RECONVERSION**

91. Where shares are converted into stock:

(a) The Company in General Meeting may, by Ordinary Resolution, convert any Paid-up shares into stock and when any shares shall have been converted into stock, the several holders of such stock may henceforth transfer their respective interest therein, or any part of such interests, in the same manner and subject to the same regulations as those subject to which shares from which the stock arose might have been transferred, if no such conversion had taken place or as near thereto as circumstances will admit. (c) such of the regulations of the Company as are applicable to paid-up shares shall apply to stock and the words “share” and “shareholder” in those regulations shall include “stock” and “stock-holder” respectively.

## **SHARE WARRANTS**

92. Share warrants may be issued as per the provisions of applicable Law.

93. Power to issue share warrants:

The Company may issue share warrants subject to, and in accordance with the provisions of the Act, and accordingly the Board may in its discretion, with respect to any share which is fully paid-up on application in writing signed by the persons registered as holder of the share, and authenticated, by such evidence (if any) as the Board may, from time to time, require as to the identity of the person signing the application, and on receiving the certificate (if any) of the share, and the amount of the stamp duty on the warrant and such fee as the Board may from time to time require, issue a share warrant.

(b) Not more than one person shall be recognised as depositor of the share warrant.

(c) The Company shall, on two days' written notice, return the deposited share warrant to the depositor.

95. Privileges and disabilities of the holders of share warrant:

(a) Subject as herein otherwise expressly provided, no person shall, as bearer of a share warrant sign a requisition for calling a meeting of the Company, or attend or vote or exercise any other privileges of a Member at a meeting of the Company, or be entitled to receive any notices from the Company.

(b) The bearer of a share warrant shall be entitled in all other respects to the same privileges and advantages as if he was named in the Register of Members as the holder of the share included in the warrant, and shall be a Member of the Company.

The Board may, from time to time, make rules as to the terms on which (if it shall think fit) a new share warrant or coupon may be issued by way of renewal in case of defacement, loss or destruct.

### **REDUCTION OF CAPITAL**

96. The Company may, subject to the applicable provisions of the Act, from time to time by a Special Resolution, reduce its Capital, any capital redemption reserve account and the securities premium account in any manner for the time being authorized by Law.

### **BUY-BACK OF SECURITIES**

97. Pursuant to a resolution of the Board or a Special Resolution of the Shareholders, as required under the Act, the Company may purchase its own Equity Shares or other Securities, as may be specified by the Act read with Rules made there under from time to time, by way of a buy- back arrangement, in accordance with Sections 68, 69 and 70 of the Act, the Rules and subject to compliance with the applicable Laws.

### **JOINT HOLDERS**

98. Where two or more persons are registered as joint holders (not more than three) of any share, they shall be deemed (so far as the Company is concerned) to hold the same as joint tenants with benefits of survivorship, subject to the following and other provisions contained in these Articles:

115. Minutes of Meetings:

Any decision made in good faith under this Article shall be final, and rights to attend and participate in the meeting concerned shall be subject to such decision.

**129. Continuing Director:**

(b) Any Committee so formed shall, in the exercise of the powers so delegated, conform to any regulations that may be imposed on it by the Board.

(c) The participation of directors in a meeting of the Committee may be either in person or through video conferencing or audio visual means or teleconferencing, as may be prescribed by the Rules or permitted under law.

(b) Unless permitted under the Act, the Company however, shall not appoint or employ at the same time more than one of the following categories of management personnel namely, a managing director and manager.

(c) The remuneration of Manager shall (subject to Sections 196, 197 and other applicable provisions of the Act, the Rules thereunder and of these Articles and of any contract between him and the Company) be paid in the manner permitted under the Act.

(b) The foreign register shall be open for inspection and may be closed, and extracts may be taken therefrom and copies thereof may be required, in the same manner, mutatis mutandis, as is applicable to the register of members.

## **THE SEAL**

150. The Board may provide for the Seal of the Company to be affixed on such document as may be decided by Board or as required under any law. The Seal shall be kept in the safe custody of such officer of the Company as the Board may decide.

151. The Seal of the Company shall not be affixed to any instrument except by the authority of a resolution of the Board or of a committee of the Board authorised by it in that behalf, and except in the presence of the secretary or such other person as the Board may appoint for

the purpose; and the secretary or other person aforesaid shall sign every instrument to which the Seal of the Company is so affixed in their presence.

## **DIVIDENDS AND RESERVES**

152. The Company in General Meeting may declare dividends, but no dividend shall exceed the amount recommended by the Board. However, the Company in General Meeting may declare a lesser dividend than that recommended by the Board.

153. Subject to the provisions of Section 123 of the Act, the Board may from time to time pay to the members such interim dividends as appear to it to be justified by the profits of the Company. (a) The Board may, before recommending any dividend, set aside out of the profits of the Company such sums as it thinks fit as a reserve or reserves which shall, at the discretion of the Board, be applicable for any purpose to which the profits of the Company may be properly applied, including provision for meeting contingencies or for equalising dividends; and pending such application, may, at the like discretion, either be employed in the business of the Company or be invested in such investments (other than shares of the Company) as the Board may, from time to time, think fit.

(b) The Board may also carry forward any profits which it may consider necessary not to divide, without setting them aside as a reserve.

154. Right to Dividend:

(a) Subject to the rights of persons, if any, entitled to shares with special rights as to dividends, all dividends shall be declared and paid according to the amounts paid or credited as paid on the shares in respect whereof the dividend is paid, but if and so long as nothing is paid upon any of the shares in the Company, dividends may be declared and paid according to the amounts of the shares.

(b) No amount paid or credited as paid on a share in advance of calls shall be treated for the purposes of this regulation as paid on the share.

(c) All dividends shall be apportioned and paid proportionately to the amounts paid or credited as paid on the shares during any portion or portions of the period in respect of which the dividend is paid; but if any share is issued on terms providing that it shall rank for dividend as from a particular date such share shall rank for dividend accordingly.

(d) Notice of any dividend that may have been declared shall be given to the persons entitled to share therein in the manner mentioned in the Act.

155. (a) The Board may deduct from any dividend payable to any member all sums of money, if any, presently payable by him to the Company on account of calls or otherwise in relation to the shares of the Company.

(b) The Board may retain dividends payable upon shares in respect of which any person is, under the Transmission Clause hereinbefore contained, entitled to become a member, until such person shall become a member in respect of such shares.

156. Dividend how Remitted:

(a) Any dividend, interest or other monies payable in cash in respect of shares may be paid by cheque or warrant sent through the post directed to the registered address of the holder or, in the case of joint holders, to the registered address of that one of the joint holders who is first named on the register of members, or to such person and to such address as the holder or joint holders may in writing direct.

(b) Every such cheque or warrant shall be made payable to the order of the person to whom it is sent.

(c) Payment in any way whatsoever shall be made at the risk of the person entitled to the money paid or to be paid. The Company will not be responsible for a payment which is lost or delayed. The Company will be deemed to having made a payment and received a good discharge for it if a payment using any of the foregoing permissible means is made.

157. Receipt of Joint Holder:

Any one of two or more joint holders of a share may give effective receipts for any dividends, bonuses or other monies payable in respect of such share.

158. Dividends not to bear Interest: No dividend shall bear interest against the Company.

159. The waiver in whole or in part of any dividend on any share by any document (whether or not under seal) shall be effective only if such document is signed by the member (or the person entitled to the share in consequence of the death or bankruptcy of the holder) and delivered to the Company and if or to the extent that the same is accepted as such or acted upon by the Board.

## **ACCOUNTS AND AUDIT**

160. Financials Statements to be laid in Annual General Meeting: The Directors shall, as required by the Act, cause to be prepared and laid before the Company in Annual General Meeting to be held as provided in these Articles hereof such Profit and Loss Account, Balance Sheet and Directors' and Auditors' Reports as are referred to in those provisions.

161. Accounts to be Audited: The financial statements, books of accounts and other relevant books and papers of the Company shall be examined and audited in accordance with the provisions of the Act and the Rules.

162. Inspection:

(a) The Board shall from time to time determine whether and to what extent and at what times and places and under what conditions or regulations, the accounts and books of the Company, or any of them, shall be open to the inspection of members not being directors.

(b) No member (not being a Director) shall have any right of inspecting any account or books or documents of the Company except as conferred by law or authorised by the Board or by the Company in general meeting.

#### **SERVICE ON MEMBERS HAVING NO REGISTERED ADDRESS**

163. If a Member has no registered address in India and has not supplied to the Company any address within India for giving notices to such Member, any document or notice required to be served on such Member may be served in such manner as may be permitted under the Act, the Rules made thereunder and other Applicable Law.

#### **NOTICE BY ADVERTISEMENT**

164. Subject to the applicable provisions of the Act, any document required to be served or sent by the Company on or to the Shareholders, or any of them and not expressly provided for by these Articles, shall be deemed to be duly served or sent if advertised in a newspaper circulating in the District in which the Office is situated.

#### **WINDING UP**

165. Subject to the provisions of Chapter XX of the Act and rules made thereunder:

(a) If the Company shall be wound up, the liquidator may, with the sanction of a special resolution of the Company and any other sanction required by the Act, divide amongst the members, in specie or kind, the whole or any part of the assets of the Company, whether they shall consist of property of the same kind or not.

(b) For the purpose aforesaid, the liquidator may set such value as he deems fair upon any property to be divided as aforesaid and may determine how such division shall be carried out as between the members or different classes of members.

(c) The liquidator may, with the like sanction, vest the whole or any part of such assets in trustees upon such trusts for the benefit of the contributories if he considers necessary, but

so that no member shall be compelled to accept any shares or other securities whereon there is any liability.

## **INDEMNITY AND INSURANCE**

### **166. Director's and Others' Right to Indemnity and Insurance:**

(a) Subject to the provisions of the Act, every director, managing director, whole-time director, manager, chief executive officer, chief financial officer, company secretary and other officer of the Company shall be indemnified by the Company out of the funds of the Company, to pay all costs, losses and expenses (including travelling expense) which such director, manager, chief executive officer, chief financial officer, company secretary and officer may incur or become liable for by reason of any contract entered into or act or deed done by him in his capacity as such director, manager, company secretary or officer or in any way in the discharge of his duties in such capacity including expenses.

(b) Subject as aforesaid, every director, managing director, manager, chief executive officer, chief financial officer, company secretary or other officer of the Company shall be indemnified against any liability incurred by him in defending any proceedings, whether civil or criminal in which judgement is given in his favour or in which he is acquitted or discharged or in connection with any application under applicable provisions of the Act in which relief is given to him by the Court.

(c) The Company may take and maintain any insurance as the Board may think fit on behalf of its present and/or former directors and key managerial personnel for indemnifying all or any of them against any liability for any acts in relation to the Company for which they may be liable but have acted honestly and reasonably.

## **AMENDMENT TO MEMORANDUM AND ARTICLES OF ASSOCIATION**

167. The Company may amend its Memorandum of Association and Articles of Association subject to Sections 13, 14 and 15 of the Act and such other provisions of the Companies Act, 2013, as may be applicable from time-to-time.

## **GENERAL POWER**

168. Wherever in the Act it has been provided that the Company or the Board shall have any right, privilege or authority or that the Company could carry out any transaction only if the Company or the Board is so authorized by its Articles, then and in that case these Articles hereby authorize and empower the Company and/ or the Board (as the case may be) to have all such rights, privileges, authorities and to carry out all such transactions as have been permitted by the Act without there being any specific regulation to that effect in these Articles save and except to the extent that any particular right, privilege, authority or transaction has been expressly negated or prohibited by any other Article herein.
