O R D E R

Since this deadline has expired and we have been informed that the suit has not been concluded, we direct the learned Civil Judge, Sr. Division, Nagpur, to complete the Special Civil Suit No.1353 of 2023 within the outer limit on 31.03.2027.

4. Subject to the above, Special Leave Petition is disposed of.
