Dear Sir/Madam,

We, vide our letter dated July 16, 2026, had informed the stock exchanges about execution of a share purchase agreement ("**SPA**") by Adani Defence Systems & Technologies Limited, ("**ADSTL**"), a wholly owned subsidiary of the Company with Flight Simulation Solutions Private Limited ("**FSSPL**") (in which ADSTL currently holds a 55.40% stake) and existing shareholders of FSSPL for acquisition of remaining 44.6% stake in FSSPL.

In this regard, we wish to inform you that ADSTL has informed that it has completed the acquisition of remaining 44.6% stake in FSSPL, in accordance with the terms of the SPA. With completion of the said acquisition, FSSPL and FSSPL's subsidiary namely Flight Simulation Technique Centre Private Limited ("**FSTC**") have become wholly-owned subsidiaries of ADSTL. The intimation of the same was received by the Company on August 4, 2026, at 11:37 AM IST.

The details of the above acquisition (as required to be furnished pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations and SEBI Circular No. SEBI/HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated 30th January, 2026) were provided vide our earlier intimation dated July 16, 2026.
