Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI master circular dated 30th January, 2026, we are disclosing that Nomination and Remuneration Committee of UTI Asset Management Company Limited has; on 12th June, 2026 at 0930 hrs IST; approved the allotment of 1250 equity shares of face value of ₹10 each pursuant to the exercise of options by eligible employee under ‘UTI AMC Employee Stock Option Scheme – 2007’.

Post the aforesaid allotment, the issued and paid-up share capital of the Company shall be increased from ₹ 1,28,52,32,450 (12,85,23,245 equity shares of face value of ₹10 each) to ₹ 1,28,52,44,950 (12,85,24,495 equity shares of face value of ₹10 each).

The new equity shares shall rank *pari-passu* in all respects with the existing equity shares.
