Pursuant to Regulation 30 of the Listing Regulations, it is hereby informed that **Prism Finance Limited** (“the Company”) has filed an appeal before the Income Tax Appellate Tribunal (ITAT), **Ahmedabad** Bench, against the order dated 19.06.2026 passed under section 250 of the Income Tax Act, 1961 (the “Act”) by the National Faceless Appeal Centre (NFAC), whereby the appeal filed by the Company against the reassessment order under section 147 for Assessment Year (AY) 2016-17 was dismissed and the additions of INR 76,56,360/- under section 68 and INR 1,91,410/- under section 69C were upheld. Further, the Company has also filed an appeal before the ITAT, Ahmedabad Bench, against the order dated 01.07.2026 passed under section 250 of the Act by the NFAC, whereby the appeal filed by the Company against the reassessment order under section 147 for AY 2018-19 was dismissed and the additions of INR 3,09,30,615/- under section 68 and INR 7,73,265/- under section 69C of the Act were made.

Quantum of claims, if any	Tax demand of INR 53,63,710 arising for AY 2016-17, as upheld by the order dated 19.06.2026 under section 250 of the Act, and tax demand of INR 4,62,09,520 arising for AY 2018-19 as upheld by the order dated 01.07.2026, have been challenged. The Company has preferred an appeal before the ITAT seeking deletion of the additions confirmed by the said order.
