A. WITHDRAWAL OF ITEM NO. 5 UNDER SPECIAL BUSINESS:

Subsequent to dispatch of the Notice of the 52nd AGM, Ministry of Defence, Department of Defence Production, vide Office Memorandum No. 8(29)/2026-D(Coord/DDP) dated September 17, 2026, has conveyed nomination of Ms. Meera Mohanty, JS (P&C) (DIN:03379561), as Government Nominee Director on the Board of MIDHANI, in place of Shri Prakash Rajpurohit, JS (DIP) (DIN: 06895578), with effect from September 17, 2026.

Consequent thereto, Shri Prakash Rajpurohit (DIN: 06895578) ceased to hold office as Government

Nominee Director on the Board of MIDHANI with effect from September 17, 2026.

Accordingly, the special business set out at Item No. 5 of the Notice relating to "Appointment of Shri Prakash Rajpurohit (DIN: 06895578) as Government Nominee Director of Company" stands withdrawn and shall not be placed before the Members for consideration or remote-e-voting/voting at the 52nd AGM.

EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

Item No. 9

Pursuant to Article 67 of Articles of Association (AoA) of the Company, the Chairman of the Board of Directors and the Government representatives on the Board of Directors shall be appointed by the President of India acting through Ministry of Defence (MoD).

Ministry of Defence, Department of Defence Production vide 8(29)/2026-D (Coord/DDP) dated September 17, 2026 conveyed the appointment of Ms. Meera Mohanty (DIN: 03379561), Joint Secretary (Personnel & Coordination), MoD, as Government Nominee Director on the Board of MIDHANI w.e.f. September 17, 2026.

Ms. Meera Mohanty (DIN: 03379561), will continue to hold office until further orders, conveyed by Administrative Ministry in this regard. She shall not be liable to retire by rotation pursuant to Section 152 of the Companies Act, 2013. The Government Nominee Director on the Board of Company does not draw any sitting fees, commission or remuneration from the Company.

Ms. Meera Mohanty is an Indian Administrative Service (IAS) officer of the Himachal Pradesh cadre, belonging to the 2005 batch. At present, she is Joint Secretary (P&C), Ministry of Defence, Department of Defence Production. Prior to her present assignment, she was Joint Secretary in the Prime Minister's Office (PMO). Ms. Mohanty is also a Government Nominee Director on the Board of Bharat Electronics Limited (BEL).

Pursuant to Regulation 17 of the SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015, the

appointment of Director is subject to the approval of shareholders.

In view of above, approval of Members of Company by way of ordinary resolution is sought for appointment of Ms. Meera Mohanty (DIN: 03379561), as Government Nominee Director of the Company for a period commencing from September 17, 2026 till further order conveyed by Ministry of Defence.
