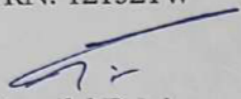

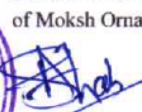

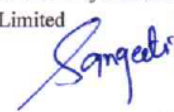
NOTES TO FINANCIAL RESULTS :-
