O R D E R

SLP(C) No. 20090-91/2026

Opportunity of respondent Nos. 1, 2, 7, 10, 18 to 21, 27, 30 to 32 & 35 to file counter affidavit has already been declined vide order dated 20.07.2026.

Service was complete on respondent No. 6 on 06.06.2026 but none has entered appearance.

Respondent Nos. 3, 26, 33 and 39 are duly represented and has filed vakalatnama on 18.07.2026. Counter affidavit, if any, be filed within two weeks time as last opportunity, if filed be taken on record, else further opportunity to file the same would stand declined.

Respondent Nos. 13, 14, 17, 22 to 25, 28, 29, 34 & 36 to 38 has filed vakalatnama on 18.07.2026. Counter affidavit, if any, be filed within two weeks time as last opportunity, if filed be taken on record, else further opportunity to file the same would stand declined.

Ld. Ld. Counsel for the petitioner is granted one weeks time as last opportunity to take fresh steps with regard to service on respondent Nos. 12 & 15. If the needful is done as above, list on 30.09.2026, else Registry to process the matter for listing before the Hon'ble Judge in Chambers for necessary directions.
