Sub: Clarification with regard to 'Spurt in volume'.

Subsequently, the Long term rating of the Company on the total bank facilities has been upgraded by Crisil Ratings Limited from 'Crisil BBB+/ Stable' to 'Crisil A / Stable' and the said information was also furnished promptly to the stock exchanges.
