Dear Sir/Ma'am,

Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform the Stock Exchanges that Jeena Sikho Lifecare Limited ("the Company") has executed a **Memorandum of Understanding cum Research Facility Usage Agreement** for establishment of a dedicated Research Institute and Research Facility at Chandigarh. The proposed centre will focus on research, innovation, education, evidence generation and knowledge development in the fields of Ayurveda, Integrative Healthcare, Preventive Wellness and allied disciplines.

The aforesaid agreement was executed on June 12, 2026. The Company received complete information and documentation pertaining to the execution of the agreement on June 15, 2026, and is making the present disclosure immediately upon receipt of such information.

This initiative represents a significant step towards strengthening the Company's institutional research capabilities and expanding its contribution to the healthcare and wellness sector.
