O R D E R

1. By our order dated 05.12.2025, we had referred the parties for mediation.
2. We appointed Hon'ble Mr. Justice L. Nageswara Rao, former Judge of this Court to act as a Mediator between the parties.
3. The parties appeared before the learned Mediator. We have the report of the learned Mediator. It appears that the mediation between the parties has been successful.
4. In the course of today's hearing, the report of the learned Mediator was produced before us. Mr. Huzefa Ahmadi and Mr. K. Parameshwar, the learned senior counsel appearing for their respective clients submitted that they have strong objection insofar as the settlement being accepted by this Court. According to them, their clients have a direct interest in this litigation. They brought to our notice that they have preferred their

respective applications seeking impleadment as party defendants in the suit. According to them, these applications are still pending for consideration before the concerned civil court.

5. The application(s) filed by the clients of Mr. Ahmadi and Mr. Parameshwar is numbered as I.A. No.758/2023, pending as on date in the court of Ld. IV Additional District Judge, Ranga Reddy District at L.B. Nagar, Hyderabad.

6. Registry shall call for the report of the concerned court as regards the status of the application referred to above and also details of other interlocutory application(s), if any, pending as on date before the court.

7. The Civil Court while forwarding its report shall also indicate the date on which the application(s) seeking impleadment was filed.

8. Let the appropriate report reach this Court by Friday, i.e., 31.07.2026.

9. Post the Special Leave Petitions on Monday, i.e., on 03.08.2026.
