**UPON hearing the counsel the Court made the following
O R D E R**

Pursuant to order dated 01.09.2026, the affidavit on behalf of respondent-State has been filed. The said affidavit is duly signed by Sh. Arun Kumar Singh, Additional District Magistrate (Land Acquisition). Perusal of the same would indicate that in para 11(b) it has been stated that notice under Section 12(2) of the Land Acquisition Act, 1894, was issued in the prescribed form and land owners were duly intimated.

This Court had called upon the State to produce the proof of despatch of such notice. However, the same has not been found along with the affidavit. Hence, further opportunity is granted to the respondent-State to place on record the proof of service of notice issued under Section 12(2) of the Land Acquisition Act, 1894 or alternatively proof of despatch of the same before the next date of hearing.

IA No. 56491 of 2025

Petitioner-society is permitted to withdraw the amount in deposit before the District Judge, Gautam Budh Nagar and the jurisdictional court shall disburse the said amount in favour of petitioner-Society after due verification and identification and on society placing on record a Resolution passed by the Committee. Cheque shall be drawn in favour of the Society and disbursed to the authorised officer of the Society or transmit the said amount to the petitioner-society through RTGS/NEFT on furnishing the bank details.

Accordingly, IA No. 56491 of 2025 is allowed in part.
