Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) and in continuation of our earlier intimations dated 11th September, 2025 for acquisition of brownfield Rail Siding in Kudathini, Ballari, Karnataka through JSW Port Logistics Private Limited, wholly owned subsidiary of the Company, with the object of developing Multi-Modal Logistics Park, including a fully equipped Inland Container Depot (“ICD”), and dated 10th March, 2026 for commencement of interim operations at the aforesaid rail siding, we further wish to inform you that JSW Port Logistics Private Limited has received Letter of Intent (“LOI”) from the Inter-Ministerial Committee, Ministry of Finance, Department of Revenue, Central Board of Indirect Taxes and Customs, for setting up of an ICD at Village Kudathini, Ballari District, Karnataka, which is the first ICD in the Ballari region, for handling of Import / Export cargo subject to the terms and conditions as mentioned in the LOI.
