NOTICE is hereby given that the 54th Annual General Meeting of the Members of **Perfectpac Limited** will be held on **Wednesday, the 16th day of September, 2026 at 12:30 P.M. (IST)** through Video Conferencing ('VC')/Other Audio-Visual Means ('OAVM') to transact the following business:

ORDINARY BUSINESS

1. To consider and adopt the Audited Financial Statements of the Company for the Financial Year ended March 31, 2026, together with the Reports of the Board of Directors and Auditors thereon.
2. To declare the final dividend of Re. 1.00/- (i.e. 50%) per equity share on face value of Rs. 2/- per equity share for the Financial Year 2025-26.
3. To appoint a Director in place of Shri Raj Gopal Sharma (DIN: 09666890), who retires by rotation and being eligible, offers himself for re-appointment.

SPECIAL BUSINESS

4. **To Re-appoint Shri Sanjay Rajgarhia (DIN: 00154167) as Managing Director of the Company.**

To consider and if thought fit, to pass the following resolution as **Special Resolution**:

"RESOLVED THAT pursuant to the provisions of Sections 196, 197, 198, 203 and all other applicable provisions, if any, of the Companies Act, 2013 ('Act') and the rules made thereunder read with Schedule V of the Act (including any statutory modification(s), amendments(s) or re-enactment(s) thereof for the time being in force) and applicable provisions, if any, of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (including any amendments, statutory modification(s) and/or re-enactment thereof for the time being in force), the Articles of Association of the Company and subject to such other approvals, permissions and sanctions if and when necessary, desirable and expedient in law, based on the recommendation of Nomination and Remuneration Committee, Audit Committee and the Board of Directors, the consent of the Members of the Company be and is hereby accorded for the re-appointment of Shri Sanjay Rajgarhia (DIN: 00154167), whose current term as Managing Director of the Company is due to expire on June 30, 2027, as the Managing Director of the Company for further period of three years effective from July 01, 2027 up to June 30, 2030, not liable to retire by rotation, upon the terms and conditions including remuneration as set out in the Explanatory Statement annexed to the Notice convening this meeting, with liberty to the Board of Directors (hereinafter referred to as 'the Board' which term shall be deemed to include any Committee of the Board constituted to exercise its powers, including the powers conferred by this resolution or any person authorized by the Board or its committee for such purpose) to alter, vary or modify the terms and conditions of the said re-appointment, in such manner as may be agreed upon by and between the Board and Shri Sanjay Rajgarhia.

RESOLVED FURTHER THAT in the event of absence or inadequacy of profits in any financial year during the tenure of Shri Sanjay Rajgarhia as Managing Director, the remuneration, including salary, perquisites, allowances and other benefits, as set out in the Explanatory Statement annexed to the Notice, shall be paid to Shri Sanjay Rajgarhia as the minimum remuneration as prescribed under Schedule V of the Act.

RESOLVED FURTHER THAT in the event of any statutory amendment, modification or relaxation to the provisions of Schedule V to Act or any other applicable provisions of the Act or any statutory re-enactment(s) thereof, the Board be and is hereby authorised to vary, revise or increase the remuneration, including salary, perquisites, allowances and other benefits payable to Shri Sanjay Rajgarhia, within such limits as may be prescribed under the Act or Schedule V, as amended from time to time, and to suitably modify the terms and conditions of his re-appointment, without any further approval of the Members, to the extent permitted under the applicable law.

RESOLVED FURTHER THAT the Board of Directors of the Company and/or its Committee thereof, be and is hereby authorized to regulate the payment of remuneration to Shri Sanjay Rajgarhia, Managing Director within the limits as mentioned in Explanatory Statement, from time to time.

RESOLVED FURTHER THAT Shri Sanjay Rajgarhia be and is hereby authorized to exercise such powers of management as may be delegated to him by the Board of Directors of the Company, from time to time, subject however, to the overall superintendence, control and direction of the Board of the Company.

RESOLVED FURTHER THAT the Board of Directors of the Company be and is hereby authorized to do all such acts, deeds, matters and things and to take all such steps as may be necessary, proper or expedient to give effect to this resolution."

5. **To increase the borrowing limits of the Company under Section 180(1)(c) of the Companies Act, 2013.**

To consider and if thought fit, to pass the following resolution as **Special Resolution**:

"RESOLVED THAT in supersession of the resolution passed by the Members of the Company at the Annual General Meeting held on September 18, 2017 and pursuant to the provisions of Section 180(1)(c) and other applicable provisions, if any, of the Companies Act, 2013 ('the Act') read with the rules made thereunder (including any statutory modification(s) or re-enactment thereof for the time being in force) and subject to such other approvals as may be required, the consent of the Members of the Company, be and is hereby accorded to the Board of Directors of the Company (hereinafter referred to as the 'Board', which term shall be deemed to include any Committee of the Board constituted by the Board to exercise the powers conferred by this resolution), to borrow from time to time any sum or sums of monies (exclusive of interest) on such terms and conditions as the Board may determine, from any one or more of the Company's bankers and/or from any one or more other banks, persons, firms, companies/bodies corporate, financial institutions, institutional investor(s), mutual funds, insurance companies, pension funds and/or any entity/entities or authority/ authorities, whether in India or abroad, and whether by way of cash credit, advances, deposits, loans, bill discounting, issue of

debentures, commercial papers, long/short term loans, suppliers' credit securities instruments such as floating rate notes, fixed rate notes, syndicated loans, commercial borrowing from the private sector window of multilateral financial institutions, either in rupees and/or in such other foreign currencies as may be permitted by law from time to time and/or any other instruments/securities or otherwise and whether unsecured or secured by mortgage, charge, hypothecation or lien or pledge of the Company's assets, licenses and properties, whether immovable or movable and all or any of the undertaking of the Company, notwithstanding that the moneys to be borrowed together with the moneys already borrowed by the Company (apart from temporary loans obtained from the Company's bankers in the ordinary course of business) will or may exceed the aggregate of the paid-up share capital, free reserves and securities premium of the Company, provided that the total amount upto which the moneys may be borrowed by the Board and outstanding at any time shall not exceed the sum of Rs. 50 Crore (Rupees Fifty Crore only) plus the paid-up capital, free reserves and securities premium of the Company.

"RESOLVED THAT in supersession of the resolution passed by the Members of the Company at the Annual General Meeting held on September 18, 2017 and pursuant to the provisions of Section 180(1)(a) and other applicable provisions, if any, of the Companies Act, 2013 ('the Act') read with the rules made thereunder (including any statutory modification(s) or re-enactment thereof for the time being in force) and subject to such other approvals as may be required, the consent of the Members of the Company, be and is hereby accorded to the Board of Directors of the Company (hereinafter referred to as the 'Board', which term shall be deemed to include any Committee of the Board constituted by the Board to exercise the powers conferred by this resolution), to mortgage and / or create charge, in addition to the mortgages / charges created / to be created by the Company in such form and manner and with such ranking and at such time and on such terms and conditions as the Board of Directors of the Company may determine, on all or any of the movable and / or immovable properties of the Company and / or the interest held by the Company in all or any of the movable and / or immovable assets and properties, both present and future and / or the whole or any part of the undertaking(s) of the Company, in favour of banks, financial institutions, lenders, agents or trustees for securing the borrowings, financial assistance, credit facilities and/or other indebtedness availed or to be availed by the Company, whether in Indian Rupees or in foreign currency, by way of loans and securities issued / to be issued by the Company, from time to time, subject to the limit of Rs. 50 Crore (Rupees Fifty Crore only) plus the paid-up capital, free reserves and securities premium of the Company, approved under Section 180(1)(c) of the Act, from time to time, together with interest at the respective agreed rates, additional interest, compound interest in case of default, accumulated interest, liquidated damages, commitment charges, premia on prepayment, remuneration of the agent(s) and / or trustees, premium (if any) on redemption, all other costs, charges and expenses, including any increase as a result of devaluation, revaluation or fluctuation in the rates of exchange and all other monies payable by the Company in terms of the Loan Agreements, Debenture Trust Deeds or any other agreement / document, entered into / to be entered into between the Company and the lenders / investors / agents and / or trustees, in respect of the said loans, borrowings / debentures and containing such specific terms and conditions and covenants in respect of enforcement of security as may be stipulated in that behalf and agreed to between the Board and the lenders, agents and / or trustees, etc.

NOTES:

1. In accordance with the provisions of the Companies Act, 2013 ('the Act'), read with the Rules made thereunder and General Circular No. 03/2025 dated September 22, 2025 issued by the Ministry of Corporate Affairs ('MCA') and such other applicable circulars issued by MCA and SEBI ('the Circulars') read with the provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('the Listing Regulations'), Companies are allowed to hold Annual General Meeting ('AGM') through video conference or other audio-visual means ('VC/OAVM'), without the physical presence of members at a common venue. Accordingly, the 54th AGM of the members of the Company is being held through VC/OAVM. The venue of the AGM shall be deemed to be the Registered

Office of the Company at 910, Chiranjiv Tower-43, Nehru Place, New Delhi-110019. In compliance with the MCA Circulars, items of special business as mentioned in this Notice are considered unavoidable and forms part of this Notice.

2. An Explanatory Statement pursuant to Section 102 of the Act, in respect of Item nos. 4 to 6 of the Notice set out above, is annexed hereto.

Further, the information required pursuant to the provisions of Secretarial Standard on general meeting ('SS-2') issued by the Institute of Company Secretaries of India ('ICSI') and Regulation 36(3) of the Listing Regulations for item nos. 3 and 4, is attached as Annexure to this Notice.

3. As the AGM is being conducted through VC/OAVM, physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxy by the Members under Section 105 of the Act will not be available for the AGM and hence the Proxy Form, Attendance Slip and Route Map are not annexed to this Notice.

However, in pursuance of Section 112 and Section 113 of the Act, Corporate Members are entitled to appoint their authorized representatives to attend the AGM through VC/ OAVM on their behalf and to vote through electronic means.

4. The Members attending the AGM through VC/OAVM shall be counted for the purpose of reckoning the quorum under Section 103 of the Act.

5. In case of joint holders, the Member whose name appears as the first holder in the order of names as per the Register of Members of the Company will be entitled to vote during the AGM.

6. The Board of Directors of the Company has recommended a payment of final dividend of Re. 1/- (i.e. 50%) per equity share of the face value of Rs. 2/- each fully paid up for the financial year 2025-26, subject to the approval of shareholders of the Company at the ensuing 54th AGM. The record date for the purpose of payment of final dividend is **Wednesday, September 09, 2026**.

As per SEBI Notification dated November 18, 2025 read with Master Circular for Registrars to an Issue and Share Transfer Agents, as amended, Companies must pay dividend to shareholders only through electronic mode. Accordingly, dividend will be withheld by the Company where bank details are inadequate or not registered for electronic remittance and a letter in lieu of the dividend instrument will be sent to the concerned holders.

Final Dividend if approved by the Members at this AGM will be directly credited to the bank accounts of the shareholders whose names appear, as at the Record Date, in the register of members or the beneficiary position data furnished by the Depositories.

The shareholders holding shares in physical form are requested to register their PAN and KYC details with the Company/RTA. While the shareholders holding shares in demat form are requested to update their bank details with their Depository Participant(s), for release of final dividend and unclaimed dividend pending, if any, with the Company.

7. As per the Income Tax Act, 2025, dividends paid or distributed by the Company is taxable in the hands of the shareholders. Therefore, the Company is required to deduct the tax at source ('TDS') from the dividend to be paid to the shareholders at the prescribed rates.

A separate email communication was sent to the members informing the relevant procedure to be adopted by them/documents to be submitted for availing the applicable tax rate. The said communication and draft of the exemption forms and other documents are available on the Company's website at <https://perfectpac.com/forms-for-tds-exemption/>.

The resident and non-resident shareholders should send the scanned copies of the requisite documents at complianceofficer@perfectpac.com on or before **Wednesday, September 09, 2026** to enable the Company to determine the appropriate TDS/withholding tax rate, as may be applicable.

Members are requested to note that in case the tax on dividend is deducted at a higher rate in the absence of receipt of the requisite details/documents, there would still be an option available to file the return of income and claim an appropriate refund, if eligible. No claim shall lie against the Company for such taxes deducted.

8. Members are requested to note that, dividends if not encashed or remaining unclaimed/unpaid for a period of seven (7) consecutive years from the date of transfer to Company's Unpaid Dividend Account, are liable to be transferred to the Investor Education and Protection Fund ('IEPF') established by the Central Government. Further, all shares in respect of which dividend has remained unclaimed for seven (7) consecutive years or more from the date of transfer to unpaid dividend account shall also liable to be transferred to IEPF Authority in terms of Section 124 of the Act read with IEPF Rules made thereunder.

9. SEBI vide Master Circular for Registrars to an Issue and Share Transfer Agents, as amended, has prescribed common and simplified norms for processing investor's service request by RTAs and norms for furnishing PAN, KYC (Contact Details, Bank Details and Specimen Signature) and Nomination details.

As per the provision of the said Master Circular, all shareholders holding shares in physical form are mandated to update their PAN, address, mobile number, bank account details and specimen signature with the RTA. In view of the same, it may be noted that any service request can be processed only after the folio is KYC compliant. In the case, wherein any one of the above details are not updated, such shareholders will be able to:

- lodge any grievance or avail any service only after furnishing all necessary details required above; and
- receive any payments including dividend in respect of such folios only electronically with effect from April 01, 2024, upon registering the required details.

The Company has been sending individual letters to all the shareholders holding shares of the Company in physical form for furnishing their PAN, KYC and nomination details. The relevant Circular(s) and necessary forms in this regard have been made available on the website of the Company at <https://perfectpac.com/update-of-kyc-details/>.

In terms of the SEBI Master Circular for Registrars to an Issue and Share Transfer Agents, as amended, all investors are encouraged in their own interest, to provide choice of nomination by contacting the RTA, if shares are held in physical form or their respective Depository Participant(s) ('DPs'), if shares are held in dematerialised form. Further, all new investors are mandatorily required to provide the choice of nomination for their demat accounts (except for jointly held demat accounts).

Accordingly, the members are advised to register their details with the RTA or DPs, in compliance with the aforesaid SEBI guidelines for smooth processing of their service requests and trading without any hindrance.

10. In terms of Regulation 40 of the Listing Regulations, as amended, mandates that transfer, transmission and transposition of securities held in physical form shall be effected only in demat mode. Further SEBI vide Master Circular No. HO/38/13/(4)2026-MIRSD-POD/I/4298/2026 dated February 06, 2026 mandated the listed companies to issue securities in dematerialized form only while processing service requests viz. issue of duplicate securities certificate, claim from unclaimed suspense account, renewal/exchange of securities certificate, endorsement, sub-division/splitting of securities certificate, consolidation of securities certificates/folios, transmission and transposition. Accordingly, Members are requested to make service requests by submitting a duly filled and signed Form ISR-4 available on the Company's website <https://perfectpac.com/compulsory-issue-of-shares-in-dematerialized-form/>. Members can contact the Company or RTA, for any assistance in this regard. Please note that any service request can be processed only after the folio is KYC compliant.
11. SEBI has made available an online dispute resolution mechanism through the SMART ODR Portal for the investors to raise disputes arising in the Indian Securities Market. After exhausting the options to resolve their grievances directly with the Company/RTA and through the SCORES platform, investors can initiate dispute resolution through the SMART ODR Portal at <https://smartodr.in/login>.
12. In response to feedback received from Investors, Companies and RTAs, SEBI vide its Circular No. SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97 dated July 02, 2025, opened a special window for a period of 6 months from July 07, 2025 till January 06, 2026 to facilitate re-lodgement of transfer requests of physical shares of the Company in dematerialised form, which were sold/ purchased prior to April 01, 2019 and/or were rejected/returned/not attended to due to deficiency in the documents/process or otherwise. Further, SEBI vide its Circular No. HO/38/13/11(2)2026-MIRSD-POD/I/3750/2026 dated January 30, 2026, has decided to open another special window for a period of one year from February 05, 2026 to February 04, 2027 to facilitate transfer and dematerialisation of physical shares of the Company.

During the further extended period, the re-lodged transfer requests that are found to be in order and complete in all respects in line with the SEBI Circular, will be issued only in dematerialised form and shall be under lock-in for a period of one year from the date of registration of transfer. Such shares shall not be transferred, lien-marked or pledged during the said lock-in period.

13. As per the provisions of Section 72 of the Act and SEBI Circular, the facility for making a nomination is available for the members in respect of the shares held by them. Members who have not yet registered their nominations are requested to register the same by submitting Form No. SH-13. If a member desires to opt-out or cancel the earlier nomination and record a fresh nomination, they may submit the same in Form ISR-3 or SH-14 as the case may be. The said forms can be downloaded from the Company's website at <https://perfectpac.com/updation-of-kyc-details/>. Members are requested to submit the said details to their DP in case the shares are held by them in dematerialized form and to Company's RTA in case the shares are held in physical form.
14. Pursuant to SEBI Circular No. HO/38/13/(3)2026-MIRSD-POD/I/3763/2026 dated January 30, 2026, the requirement for issuance of a Letter of Confirmation ('LOC') for investor service requests has been dispensed with, with effect from April 02, 2026. Accordingly, the Depositories have implemented a mechanism enabling RTAs and listed companies to credit securities directly to the investor's demat account after completion of the necessary due diligence, thereby reducing processing timelines and mitigating the risk of loss or pilferage.

Letters of Confirmation issued on or before April 02, 2026 may be submitted by the concerned investors to their DP for dematerialisation within 120 days from the date of issuance of the LOC.

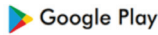

As per the Regulation 23 of the Listing Regulations, the payment of remuneration to a promoter Director qualifies as a Related Party Transaction ('RPT'), however the same is not the material transaction as per Regulation 23(1) of the Listing Regulations.

In terms of the applicable provisions of the Act and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations'), the Company has received the requisite declarations and disclosures from Shri Sanjay Rajgarhia, namely: (i) consent in writing to act as Managing Director in the prescribed Form DIR-2; (ii) a declaration in Form DIR-8 to the effect that he is not disqualified from being appointed as a Director; (iii) a declaration confirming that he is not debarred from holding the office of Director by virtue of any order of SEBI or any other authority; (iv) a notice under Section 160 of the Act proposing his candidature for the office of Director; and (v) all other necessary information and declarations.

On the recommendation of Nomination and Remuneration Committee and Audit Committee, the Board of Directors of the Company at its meeting held on dated August 07, 2026 reviewed the performance of Shri Sanjay Rajgarhia and appreciated his valuable contributions to the growth and management of the Company. Shri Sanjay Rajgarhia also fulfilled his responsibilities with commitment, diligence and integrity. After evaluating his continued suitability for the role and considering the strategic needs of the Company, the Board found it appropriate to re-appoint him for a further period of 3 years (Three Years) effective from July 01, 2027 to June 30, 2030, subject to the approval of the shareholders.

In terms of the provisions of Sections 197 and 198 read with Schedule V to the Act, the proposed remuneration payable to Shri Sanjay Rajgarhia exceeds the limits specified under Section 197 of the Act based on the net profits computed under Section 198. Accordingly, approval of the Members by way of a Special Resolution is being sought in accordance with the applicable provisions of the Act. Further, in the event of absence or inadequacy of profits in any financial year during the tenure of Shri Sanjay Rajgarhia as Managing Director, the proposed remuneration shall be payable as the minimum remuneration in accordance with Schedule V to the Act.

The Nomination and Remuneration Committee, Audit Committee and Board have recommended the remuneration as detailed below for Shri Sanjay Rajgarhia having regards to the industry standards and keeping in mind growth aspirations of the Company. The overall remuneration of Shri Sanjay Rajgarhia has been structured having regards to responsibilities entrusted on him and contributions made by him in terms of achievement of revenue growth and profitability and his key contributions to further improve the Company operations and productivity.

The remuneration and terms and conditions of the re-appointment of Shri Sanjay Rajgarhia, as approved and recommended by the Nomination & Remuneration Committee, Audit Committee and the Board of Directors of the Company, in pursuance to the Section 197, Schedule V of the Act and the Listing Regulations are as under:

1. **Basic Salary:** Rs. 6,00,000/- (Rupees Six Lakhs only) per month with effect from July 01, 2027, with such increments as may be determined by the Board of Directors from time to time, subject to a maximum Basic Salary of Rs. 7,00,000/- (Rupees Seven Lakhs only) per month.
2. **Perquisites and Allowances:** In addition to the aforesaid salary, Shri Sanjay Rajgarhia shall be entitled to the following perquisites and allowances:
 - (i) Residential Accommodation: Rent-free furnished residential accommodation, including electricity, the monetary value of which shall be determined in accordance with Rule 3 of the Income-tax Rules, 1962.
OR
In case self-owned premises are occupied, House Rent Allowance shall be payable in accordance with the rules of the Company, subject to a maximum of 60% of the Basic Salary per month. The cost of electricity shall be borne by the Company.
 - (ii) Medical Benefits: The total cost to the Company towards medical reimbursement/allowance shall not exceed one month's Basic Salary in a year.
 - (iii) Leave Travel Allowance/Concession: Leave Travel Allowance/Concession for self and family, once in a year, shall not exceed one month's Basic Salary in a year.
 - (iv) Club Membership: Reimbursement of membership fees in respect of clubs shall be restricted to a maximum of two clubs.
 - (v) Insurance: Personal Accident Insurance and Mediclaim Insurance premium, subject to a maximum limit of Rs. 25,000/- (Rupees Twenty-Five Thousand only) per annum.
 - (vi) Provident Fund: The Company's contribution towards Provident Fund shall be in accordance with the rules and policies of the Company.
 - (vii) Gratuity: Gratuity shall be payable in accordance with the rules and policies of the Company.
 - (viii) Motor Car Facility: Use of the Company's car along with driver for official as well as personal purposes.
 - (ix) Other Facilities: Telephone at residence, internet charges, gas bills and gardener expenses at the Company's cost.

3. Other Terms & Conditions

- (i) No sitting fees shall be paid to Shri Sanjay Rajgarhia for attending meetings of the Board of Directors or any Committee thereof.
- (ii) Shri Sanjay Rajgarhia shall not be liable to retire by rotation during his tenure as Managing Director.
- (iii) Shri Sanjay Rajgarhia shall perform such duties and exercise such powers as may, from time to time, be entrusted to or vested in him by the Board of Directors of the Company.
- (iv) Shri Sanjay Rajgarhia may resign from the services of the Company at any time by giving three months' prior notice in writing. Similarly, his services may be terminated by the Company by giving three months' prior notice in writing.
- (v) If at any time Shri Sanjay Rajgarhia ceases to be a Director of the Company for any reason whatsoever, he shall automatically cease to hold office as Managing Director and Chairman of the Company.
- (vi) Shri Sanjay Rajgarhia shall be entitled to reimbursement of all legitimate expenses incurred by him in the performance of his duties and such reimbursement shall not form part of his remuneration.
- (vii) If in any financial year, during the term of office of Shri Sanjay Rajgarhia as Managing Director the Company has in-adequate profits as computed under the applicable provisions of the Act, he shall be entitled to receive the aforementioned remuneration as the minimum remuneration as prescribed under Schedule V of the Act.
- (viii) The aggregate of the aforesaid salary, allowances, perquisites and other benefits, as per Company policy, shall not exceed Rs. 1.50 Crores (Rupees One Crore Fifty Lakhs only) per annum. For this purpose, the following shall not be included in the aggregate:
 - a. Contribution to Provident Fund
 - b. Contribution to Gratuity

The Board of Directors the term 'Board of Directors' includes any Committee of the Board constituted to exercise its powers, including the powers conferred by this resolution or any person authorized by the Board or its committee for such purpose of the Company is authorized to regulate the payment of remuneration to Shri Sanjay Rajgarhia, Managing Director of the Company within the aforesaid limits, from time to time.

This Explanatory Statement may also be considered as the requisite abstract under Section 190 of the Act setting out the terms and conditions of appointment of Shri Sanjay Rajgarhia as Managing Director of the Company.

Pursuant to Regulation 36(3) of the Listing Regulations, as amended read with the provisions of the Secretarial Standard on General Meetings ('SS-2') issued by the Institute of Company Secretaries of India, brief profile and other details of Shri Sanjay Rajgarhia are provided in Annexure to this Notice.

The Company satisfies the conditions specified under Section II of Part II of Schedule V to the Companies Act, 2013 for payment of managerial remuneration in case of inadequate profits. The disclosures required under Schedule V are provided below.

Except Shri Sanjay Rajgarhia, Shri Ajay Rajgarhia and their relatives to the extent of their shareholding interest, if any, in the Company, none of the other Directors, Key Managerial Personnel and their relatives are in any way, concerned or interested, financially or otherwise, in the proposed resolution mentioned at Item No. 4.

The Board of Directors recommends the Special Resolution as set out at Item No. 4 of the Notice of the AGM for approval of the members.

Item No. 5

In terms of provisions of Section 180(1)(c) of the Companies Act, 2013 ('the Act'), the Board of Directors of a Company cannot borrow monies, where the amount to be borrowed together with the monies already borrowed by the Company (apart from temporary loans obtained from the Company's bankers in the ordinary course of business), exceeds the aggregate of the paid-up share capital, free reserves and securities premium of the Company, without the consent of the Members by way of a Special Resolution.

The Members of the Company had, at the Annual General Meeting held on September 18, 2017, authorised the Board of Directors to borrow monies in excess of the limits specified under Section 180(1)(c) of the Act up to Rs. 20 Crore (Rupees Twenty Crore only) over and above the aggregate of the paid-up share capital, free reserves and securities premium of the Company.

Considering the Company's present and future business requirements, including meeting working capital requirements, capital expenditure, refinancing of existing borrowings and other general corporate purposes, the Company may need to avail additional financial assistance from banks, financial institutions and/or other lenders from time to time. Accordingly, it is proposed to enhance the borrowing limits from Rs. 20 Crore to Rs. 50 Crore over and above the aggregate of the paid-up share capital, free reserves and securities premium of the Company.

The proposed enhancement is an enabling approval to provide adequate financial flexibility to the Company to meet its funding requirements as and when required. The actual borrowings shall be made by the Board depending upon the business needs and financial requirements of the Company from time to time.

Accordingly, the approval of the Members is sought by way of a Special Resolution pursuant to Section 180(1)(c) of the Act.

None of the Directors, Key Managerial Personnel of the Company or their respective relatives is, in any way, concerned or interested, financially or otherwise, in the proposed Resolution except to the extent of their shareholding, if any, in the Company.

The Board of Directors recommends the Special Resolution set out at Item No. 5 of the Notice of the AGM for approval of the members.

Item No. 6

In terms of the provisions of Section 180(1)(a) of the Companies Act, 2013 ('the Act'), the Board of Directors of a Company can sell, lease or otherwise dispose of the whole or substantially the whole of the undertaking of the Company only with the consent of the Members by way of a Special Resolution. The creation of mortgages, charges, hypothecation or other security interests over the whole or substantially the whole of the undertaking(s) of the Company to secure borrowings is regarded as falling within the scope of the said provision.

The Members of the Company had, at the Annual General Meeting held on September 18, 2017, authorised the Board of Directors to create mortgages, charges and other security interests over the assets of the Company in connection with the borrowings of the Company.

As the Company proposes to enhance its borrowing limits under Section 180(1)(c) of the Act, it may also be necessary to create appropriate security by way of mortgage, charge, hypothecation or other encumbrance on the movable and/or immovable properties and assets of the Company, whether present or future, and/or the whole or substantially the whole of the undertaking(s) of the Company, in favour of banks, financial institutions and other lenders for securing such borrowings.

Accordingly, the approval of the Members is sought by way of a Special Resolution under Section 180(1)(a) of the Act to authorise the Board to create such mortgages, charges and other security interests in connection with the borrowings of the Company within the borrowing limits approved by the Members under Section 180(1)(c) of the Act.

None of the Directors, Key Managerial Personnel of the Company or their respective relatives is, in any way, concerned or interested, financially or otherwise, in the proposed Resolution except to the extent of their respective shareholding, if any, in the Company.

The Board recommends the Special Resolution set out at Item No. 6 of the Notice for approval by the Members.

The Board of Directors are pleased to present the 54th (Fifty-fourth) Annual Report of the Company, together with the Audited Financial Statements for the financial year ended March 31, 2026.

2. STATE OF COMPANY AFFAIRS & OPERATIONS

The Company is engaged in the business of manufacturing of packaging material and operates in one segment only. During the financial year 2025-26:

- Revenue from operations increased to Rs. 11,373.48 lakhs, as against Rs. 11,345.88 lakhs in the previous year.
- Profit before tax stood at Rs. 420.81 lakhs as against Rs. 424.88 lakhs in the previous year.
- Profit after tax stood at Rs. 314.95 lakhs as against Rs. 315.20 lakhs in the previous year.
- Basic and Diluted EPS remained unchanged at Rs. 4.73 per share as compared to the previous year.

The performance of the Company remained stable during the year despite challenging market conditions. The management continues to focus on operational efficiency, cost optimization, energy conservation and value-added products. The Company remains confident of sustaining its performance and achieving improved results in the coming years.

The Company has provided depreciation on property, plant and equipment in accordance with the provisions of Schedule II of the Companies Act, 2013 (the Act). The Financial Statements for the financial year 2025-26 have been prepared in compliance with the applicable provisions of Indian Accounting Standards (IND-AS), as prescribed under the Act.

3. CHANGE IN THE NATURE OF BUSINESS, IF ANY

There is no change in the nature of business of the Company during the year under review.

4. TRANSFER TO RESERVES

The Board of Directors have not transferred any amount out of the profit for the year under review to the General Reserve.

5. DIVIDEND

The Board of Directors have recommended the final dividend of Re. 1.00/- (i.e. 50%) per equity share of Rs. 2/- each fully paid up for the financial year 2025-26. The payment of the final dividend is subject to the approval of the shareholders at the ensuing 54th Annual General Meeting ('AGM') of the Company and shall be subject to deduction of tax at source.

6. EXPANSION

The Company has applied for allotment of land to the Government of Uttar Pradesh for setting up its second manufacturing unit. In this regard, the Company has received a Letter of Intent from the concerned authorities. The proposed project is contingent upon getting allotment of Land from the authorities.

7. CAPITAL STRUCTURE**Authorised Share Capital**

The authorised equity share capital of the Company as at March 31, 2026, was Rs. 2,00,00,000/- (Rupees Two Crore only) comprising of 1,00,00,000 (One Crore) equity shares of Rs. 2/- (Rupees Two) each and Preference Share Capital was Rs. 1,25,00,000/- (Rupees One Crore and Twenty-Five Lakh only) comprising of 1,25,000 (One Lakh and Twenty-Five Thousand) preference shares of Rs. 100/- (Rupees One Hundred) each i.e. total authorised share capital was Rs. 3,25,00,000/- (Rupees Three Crore and Twenty-Five Lakh only).

Paid up Share Capital

The Paid-up share capital of the Company as at March 31, 2026 stands at Rs. 1,33,19,000/- (Rupees One Crore Thirty-Three Lakh and Nineteen Thousand only), comprising 66,59,500 (Sixty-Six Lakh Fifty-Nine Thousand and Five Hundred) equity shares of Rs. 2/- (Rupees Two) each fully paid up.

During the financial year 2025-26, there was no change in the share capital of the Company.

The requisite declarations and eligibility confirmations under the provisions of the Companies Act, 2013 ('Act') and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') were received from Shri Sanjay Rajgarhia for considering his re-appointment as Managing Director of the Company.

The resolution for the re-appointment of Shri Sanjay Rajgarhia is being placed for the approval of the shareholders of the Company at its ensuing 54th AGM.

Retirement by rotation and subsequent re-appointment

In terms of Articles of Association of the Company and provisions of Section 152 and other applicable provisions, if any, of the Act, Shri Raj Gopal Sharma (DIN: 09666890), Whole time Director of the Company, is liable to be retire by rotation at the ensuing 54th AGM and being eligible, offers himself for re-appointment. Based on the recommendation of the Nomination and Remuneration Committee and outcome of performance evaluation, the Board of Directors at its Meeting held on August 07, 2026 have recommended his re-appointment as Whole time Director of the Company, liable to be retire by rotation, subject to the approval of the shareholders of the Company at the ensuing 54th AGM.

The resolution for the re-appointment of Shri Raj Gopal Sharma is being placed for the approval of the shareholders of the Company at its ensuing 54th AGM.

The required information as stipulated under Regulation 36 of the Listing Regulations and Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India ('ICSI'), including the brief profile for all the aforementioned Directors proposed to be re-appointed have been disclosed in the Annexure to the Notice of the 54th AGM.

The Auditors Report read together with Annexures referred to in the Auditor's Report for the financial year ended March 31, 2026 does not contain any qualification, reservation or adverse remark.

Secretarial Auditors

In terms of the amended provisions of Regulation 24A of the Listing Regulations, the Board of Directors, based on the recommendation of the Audit Committee, appointed M/s. RSM & Co. (Peer Review Certificate No.: 7415/2025 and ICSI Firm Registration No.: P1997DE017000), as the Secretarial Auditors of the Company for a term of 5 (five) consecutive years from the financial year 2025-26 up to financial year 2029-30. 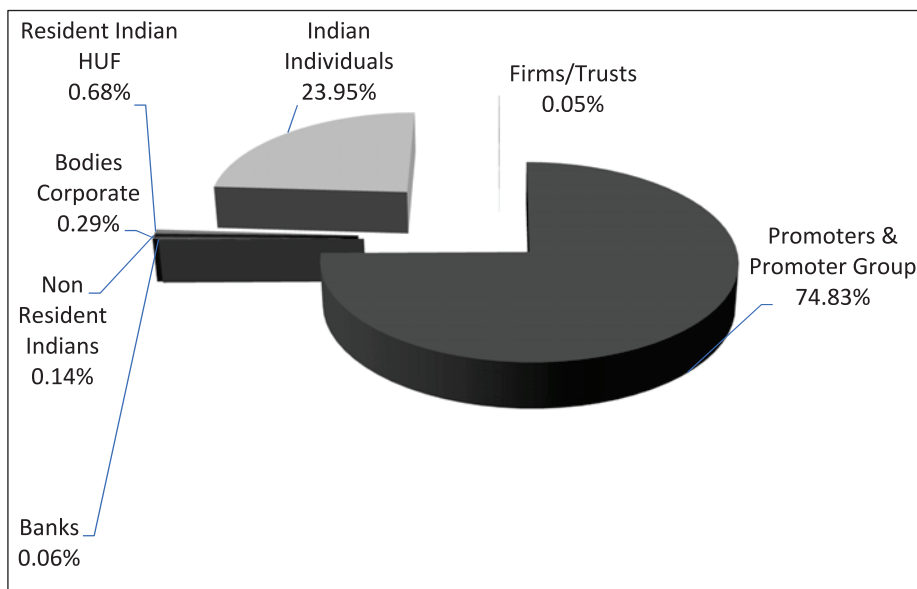

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

[Schedule V Regulation 34(3) of SEBI (LODR) Regulations, 2015]

1. INDUSTRY STRUCTURE AND DEVELOPMENTS

The packaging industry plays a vital role in India's economic growth and consumption ecosystem. Packaging today is no longer limited to protecting products during storage and transportation, it has evolved into a strategic business function that influences branding, consumer experience, product differentiation, sustainability and supply chain efficiency.

The Indian packaging industry continues to witness robust growth driven by increasing urbanization, rising disposable incomes, changing consumer preferences, growth in organised retail, expansion of e-commerce and quick commerce, and increasing demand for packaged products across sectors such as FMCG, food & beverages, pharmaceuticals, personal care, electronics, textiles and industrial goods.

According to industry estimates, the Indian packaging market was valued at approximately Rs. 5.4 trillion in financial year 2025 and is expected to reach around Rs. 8.3 trillion by financial year 2030. Growth in packaging consumption continues to outpace overall consumption growth, making the industry an important indicator of economic activity and consumer demand.

The corrugated packaging industry forms a significant segment of the packaging sector owing to its cost-effectiveness, durability, recyclability and versatility. Corrugated boxes are extensively used for packaging products across diverse industries including FMCG, e-commerce, pharmaceuticals, textiles, consumer durables and industrial products. Growing environmental awareness and increasing preference for recyclable packaging solutions continue to support demand for corrugated packaging products.

The industry is witnessing increasing investments in automation, process modernization, digital printing technologies and sustainable packaging solutions. Regulatory initiatives relating to waste management, recycling and Extended Producer Responsibility (EPR) are encouraging manufacturers to adopt environmentally responsible practices and develop sustainable packaging alternatives.

Despite strong growth prospects, the industry remains highly fragmented, particularly in the corrugated packaging segment, resulting in intense competition. However, increasing emphasis on quality, compliance, operational efficiency and sustainability is expected to create opportunities for organised and technologically advanced players.

2. OPPORTUNITIES & THREATS

Opportunities

India continues to be one of the fastest-growing major economies in the world. Rising consumption levels, increasing urbanisation, growth of organised retail and rapid expansion of e-commerce and quick commerce are expected to create significant opportunities for the packaging industry.

The growing demand for packaged food, pharmaceuticals, personal care products, consumer goods and industrial products is expected to support sustained demand for packaging solutions. Increasing awareness regarding sustainable packaging and regulatory emphasis on recyclable materials are creating new opportunities for eco-friendly corrugated packaging products.

The packaging industry is also witnessing increasing adoption of automation, digital technologies and smart packaging solutions aimed at enhancing operational efficiency, product traceability and customer engagement. Growing export opportunities and increasing preference for customised and value-added packaging solutions provide additional avenues for growth.

Threats

The Corrugated packaging industry continues to face challenges arising from intense competition, pricing pressures and the fragmented nature of the industry. Low entry barriers in certain segments often result in excess capacity and margin pressures.

Volatility in raw material prices, particularly kraft paper can adversely impact profitability. Increases in energy, labour, transportation and logistics costs further add to operational challenges.

The industry is also exposed to evolving environmental regulations, sustainability requirements and compliance obligations relating to recycling and waste management. Economic slowdowns, changes in consumer demand patterns and global supply chain disruptions may also impact business performance.

The Company continuously monitors these developments and undertakes appropriate measures to mitigate risks while leveraging emerging opportunities.

3. SEGMENT-WISE PERFORMANCE

The Company operates in a single business segment, namely Packaging. Accordingly, separate, segment-wise or product-wise performance disclosures are not applicable. The Company does not have any operations outside India and, therefore, geographical segment-wise disclosures are also not applicable.

4. OUTLOOK

The outlook for the Indian packaging industry remains positive, supported by favourable demographic trends, increasing consumer spending, rapid urbanization, expansion of organised retail, growing e-commerce penetration and rising demand for packaged products across various sectors.

India's packaging consumption per person remains significantly lower than that of developed economies, indicating substantial long-term growth potential for the packaging industry. As consumers increasingly shift towards branded products and seek greater convenience, safety, hygiene and product quality, packaging usage across industries is expected to increase steadily in the coming years.

The corrugated packaging segment is expected to continue benefiting from growth in e-commerce, logistics, food processing, pharmaceuticals, consumer goods and manufacturing sectors. Sustainability initiatives and increasing preference for recyclable packaging materials are expected to further strengthen demand for corrugated packaging products.

The industry is also expected to witness increased adoption of automation and higher capacity/productivity plants by newer entrants. Industry consolidation and increasing focus on organised players are expected to create opportunities for efficient manufacturers with strong operational capabilities.

While challenges such as raw material price volatility, competitive pressures and regulatory changes may continue to impact the industry, the long-term growth fundamentals remain strong.

Your Company remains committed to enhancing operational efficiency, improving product quality, strengthening customer relationships, modernising manufacturing facilities and maintaining prudent financial discipline. The Company believes that its focus on quality, customer satisfaction and continuous improvement positions it favourably to capitalize on future growth opportunities and create long-term value for stakeholders.

5. RISKS AND CONCERNS

Risk management forms an integral part of the Company's business strategy and operational framework. The Company has established processes to identify, assess, monitor and mitigate various risks that may impact its business objectives, operational performance, financial results and reputation.

The Board of Directors and senior management regularly review the risk management framework to ensure effective monitoring and timely mitigation of identified risks. The Company also maintains an internal audit mechanism that assists in identifying emerging risks and evaluating the effectiveness of internal controls.

The key risks faced by the Company include:

Raw Material Price Risk: Prices of major raw materials such as kraft paper and other packaging inputs are subject to fluctuations due to demand-supply dynamics, market conditions and global economic factors, which may impact profitability.

Competitive Intensity: The packaging industry remains highly fragmented with significant competition from organised and unorganised players, resulting in pricing pressures and margin challenges.

Regulatory and Environmental Risk: Increasing environmental regulations, sustainability requirements and compliance obligations relating to waste management and recycling may require additional investments and operational changes.

Economic and Demand Risk: Slowdown in economic activity, reduction in consumer spending or lower demand from key customer industries may adversely affect business volumes.

Operational Risk: Disruptions in supply chains, logistics constraints, energy cost increases and technological changes may impact operational efficiency and business continuity.

The Company continuously evaluates these risks and adopts suitable mitigation strategies to ensure sustainable business growth and value creation.

6. INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY

The Company has established adequate internal financial controls commensurate with the size, scale and complexity of its operations. These internal controls are designed to provide reasonable assurance regarding the reliability of financial reporting, compliance with applicable laws and regulations, safeguarding of assets and the orderly and efficient conduct of business operations.

The Company's internal financial control framework includes documented policies and procedures for authorization and approval of transactions, safeguarding of assets, prevention and detection of frauds and errors, maintenance of accurate accounting records and timely preparation of reliable financial information. The controls are periodically reviewed to ensure their continued effectiveness and adequacy.

The Company has a well-defined organizational structure, established authority levels and internal policies governing business operations. Management regularly reviews actual performance against budgets and business plans and takes appropriate corrective actions, wherever necessary.

The Audit Committee of the Board provides oversight on financial reporting, internal controls, risk management and audit functions. The Company has appointed independent Internal Auditors who periodically review the adequacy and effectiveness of internal controls and submit their reports to the Audit Committee. The Statutory Auditors also evaluate the effectiveness of internal financial controls over financial reporting as part of their audit procedures.

Based on the reviews carried out by Management, Internal Auditors, Statutory Auditors and the Audit Committee, the Board is of the opinion that the Company's internal financial control systems were adequate and operating effectively during the financial year under review.

Opinion

NOTES FORMING PART OF THE FINANCIAL STATEMENTS**1 (A) Corporate Information**

Perfectpac Limited ("the Company") is a public limited Company incorporated in India with its Registered Office at Delhi and is listed on the Bombay Stock Exchange Limited (BSE). The Company has manufacturing facilities at Greater Noida and is engaged inter-alia, in the business of manufacturing of Packaging products.

The financial statements are approved for issue by the Company's Board of Directors on May 13th, 2026.

1 (B) Material Accounting Policies**(a) Statement of Compliance**

The Financial Statements have been prepared as a going concern in accordance with Indian Accounting Standards (Ind AS) notified under Section 133 of the Companies Act, 2013 ("the Act") including the Companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) and presentation requirements of Division II of Schedule III to the Companies Act, 2013, (Ind AS compliant) as applicable to the financial statements.

(b) Functional & Presentational Currency

The Financial Statements of the Company are presented in Indian Rupees. The Company has operations in India. All values are rounded to nearest Lakhs (INR 00,000) except when otherwise indicated.

(c) (i) Basis for Preparation & Presentation

The Financial Statements have been prepared under the historical cost convention on accrual basis with the exception of certain assets and liabilities carried at fair values. The Assets and Liabilities have been classified as Current/Non-Current as per the Company's normal operating cycle and other criteria set out in the Act. Based on the nature of products and the time between the acquisition of assets for processing and their realization in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of Current/Non-Current classification of Assets and Liabilities. The statement of Cash Flows has been prepared under indirect method.

Accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy hitherto in use. The material accounting policy information used in preparation of the audited standalone financial statements have been discussed in the respective notes.

(ii) Use of Estimates and Critical Accounting Judgements

The preparation of Financial Statements is in conformity with Generally Accepted Accounting Principles which requires management to make estimates and assumptions.

The estimates and the associated assumptions are based on historical experience, opinions of experts and other factors that are considered to be relevant. Actual results may differ from these estimates.

Significant judgements and estimates are made in areas relating to useful life of Property, Plant and Equipment, impairment of Property, Plant and Equipment, Investments, actuarial assumptions relating to recognition and measurement of employee defined benefit obligations and recognition of provisions and exposure of contingent liabilities relating to pending litigations or other outstanding claims etc.

(d) Property, Plant and Equipment-Tangible Assets

Property, Plant and Equipment are stated at cost, net of recoverable taxes, trade discounts and rebates less accumulated depreciation and impairment losses, if any. Such cost includes purchase price, borrowing cost and any cost directly attributable to bringing the assets to its working condition for its intended use, net changes on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the assets.

Subsequent costs are included in the asset's carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the entity and the cost can be measured reliably. All other repairs and maintenance are charged to the Statement of profit and loss during the reporting period in which they are incurred.

An item of Property, Plant and Equipment is de-recognized upon disposal or when no future economic benefits are expected to arise from continued use of asset.

Depreciation Method and Estimated Useful Life

- i. Depreciation is calculated using the straight-line method on a pro-rata basis from the date on which each asset is available for use to allocate their cost net of their residual values, over their estimated useful lives. The estimated useful lives are those prescribed under Schedule II to the Companies Act, 2013.
- ii. Gains and losses on disposals are determined by comparing proceeds with carrying amount and such gains or losses are recognized as income or expense in the Statement of Profit and Loss.
- iii. Cost of items of Property, Plant and Equipment not ready for intended use as on the Balance Sheet date is disclosed as capital work in progress. Advances given towards acquisition of Property, Plant and Equipment outstanding at each Balance Sheet date are disclosed as Capital Advance under Other Non-Current Assets.

(e) Intangible Assets and Amortization

Intangible assets are stated at cost, net of recoverable taxes, trade discounts and rebates less accumulated amortization and impairment loss, if any. The cost comprises of purchase price, borrowing costs and any cost directly attributable to bringing the asset to its working condition for the intended use.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are recognized as income or expense in the Statement of Profit and Loss.

Cost of items of intangible assets not ready for intended use as on the Balance Sheet date is disclosed as intangible assets under development.

An intangible asset is de-recognised when no future benefits are expected from use.

Amortization Method and Estimated Useful Life

Amortization is charged on a straight-line basis over the estimated useful life. The estimated useful life and amortization method is reviewed at the end of each annual reporting period with the effect of any changes in the estimate being accounted for on a prospective basis.

(f) Impairment

Tangible and Intangible assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognized for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. Non-financial assets that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

(g) Leases

Company as a lessor:

The Company classifies the leases as either a finance lease or an operating lease depending on whether the risks and rewards incidental to ownership of an underlying asset are transferred and recognizes finance income over the lease term.

Company as a lessee:

In accordance with Ind AS-116, the Company assesses whether a contract contains a lease at inception of a contract. At the date of commencement of the lease, the Company recognizes a "right of use" asset and a corresponding liability for all lease arrangements in which it is the lessee, except for leases with a term of twelve months or less (short term leases) and low value leases. For these short term and low value leases, the Company recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease. The right of use assets are depreciated using the straight line method from the commencement date over the shorter of lease term or useful life of right to use asset.

The lease payments are discounted using the interest rate implicit in the lease or if not readily determinable using the incremental borrowing rates. Lease Liabilities are re measured with a corresponding adjustment to the related right of use asset if the Company changes its assessment of whether it will exercise an extension or termination option.

(h) Financial Instruments

Financial Assets and Financial Liabilities are recognized when the Company becomes a party to the contractual provisions of the relevant instrument. Since the transaction price does not differ significantly from the fair value of the financial asset or financial liability, the transaction price is assumed to be the fair value on initial recognition. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities are added to or deducted from the fair value on initial recognition of financial assets or financial liabilities. Purchase and sale of financial assets are recognized using trade date accounting.

i. Financial Assets

Financial assets include Trade Receivables, Advances, Security Deposits, Cash and Cash Equivalents etc which are classified for measurement at amortized cost. The Company accounts its investments in subsidiaries and associates, if any, at cost. However, all other equity investments are measured at fair value, with value changes recognized through "Other Comprehensive Income."

Management determines the classification of an asset at initial recognition depending on the purpose for which the assets were acquired. The subsequent measurement of financial assets depends on such classification.

Impairment:

The Company assesses at each reporting date whether a financial asset (or a group of financial assets) are tested for impairment based on available evidence or information. Expected credit losses are assessed and loss allowances recognized if the credit quality of the financial asset has deteriorated significantly since initial recognition.

De-Recognition:

Financial assets are derecognized when the right to receive cash flow from the assets has expired, or has been transferred and the Company has transferred substantially all of the risks and rewards of ownership.

Income Recognition:

Interest income is recognized in the Statement of Profit and Loss using the effective interest method. Dividend income is recognized in the Statement of Profit and Loss when the right to receive the same is established.

ii. Financial Liabilities:

Borrowings, Trade Payables and other Financial Liabilities are initially recognized at the value of the respective contractual obligations. They are subsequently measured at amortized cost using the effective interest method.

For trade and other payables maturing within one year from the Balance Sheet date, the carrying amounts approximate fair value due to short maturity of these instruments.

De-Recognition:

Financial Liabilities are derecognized when the liability is extinguished, that is, when the contractual obligation is discharged, cancelled and on expiry.

(i) Inventories

Inventories are valued at lower of cost and net realizable value except waste which is valued at estimated realizable value as certified by the management. The basis of determining cost for various categories of inventories are as follows:

Stores, Spare Parts, Packing Materials and Raw Materials	First in First out basis.
Work in Progress and Finished Goods	Material cost plus appropriate share of production overheads.
Waste & Scrap	At estimated realizable value.

(j) Revenue

Revenue is recognized when the performance obligation is satisfied by transferring promised goods or services (*i.e.* an asset) to a customer. An asset is transferred when (or as) the customer obtains control of that asset. Revenue is measured at the fair value of the consideration received or receivable net of discounts, taking into account contractually defined terms and excluding taxes and duties collected on behalf of the Government.

Dividend income from investments is recognized when the right to receive payment has been established. Interest income is accrued on time proportion basis, by reference to the principal outstanding and the effective interest rate applicable.

Rental income from investment properties is recognized on a straight line basis over the term of the relevant leases. Income from services is accounted over the period of rendering of services.

(k) Foreign Currency Transactions

Items included in the Financial Statements are measured using the currency of the primary economic environment in which the entity operates (the functional currency). The Ind AS Financial Statements are presented in Indian Rupee (INR) which is Company's functional and presentation currency.

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognized in Statement of Profit and Loss except on transactions entered into to hedge certain foreign currency risks.

(l) Cash and Cash Equivalents

For the purpose of presentation in the statement of Cash Flows, Cash and Cash Equivalents includes cash in hand, cheques/drafts in hand, demand deposits with banks, short term balances, highly liquid investments that are readily convertible into known amounts of cash and which are subject to insignificant risk of changes in value. Bank overdrafts are shown within Other Financial Liabilities in the Balance Sheet and form part of Cash and Cash Equivalents in the Cash Flow Statement.

(m) Income Tax

Income tax expense represents the sum of the current tax and deferred tax.

Current tax charge is based on taxable profit for the year. Taxable profit differs from profit as reported in the Statement of Profit and Loss because some items of income or expense are taxable or deductible in different years or may never be taxable or deductible. The Company's liability for current tax is calculated using Indian tax rates and laws that have been enacted by the reporting date.

Current tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority.

The Company periodically evaluates positions taken in the tax returns with respect to situations in which applicable tax regulations are subject to interpretation and establishes provisions where appropriate.

Deferred tax is the tax arising from temporary differences between the carrying amounts of assets and liabilities in the Balance Sheet and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognized for all taxable temporary differences and deferred tax assets are recognized to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilized. Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset realized, based on tax rates that have been enacted or substantively enacted by the reporting date.

Deferred income tax assets and liabilities are off set against each other and the resultant net amount is presented in the Balance Sheet if and only when the Company currently has a legally enforceable right to set off the current income tax assets and liabilities.

Deferred tax assets include Minimum Alternate Tax (MAT) paid in accordance with the tax laws in India, to the extent it would be available for set off against future current income tax liability. Accordingly, MAT is recognised as deferred tax asset in the Balance Sheet when the asset can be measured reliably and it is probable that the future economic benefit associated with the asset will be realised.

Current and deferred tax is recognized in profit or loss, except to the extent that it relates to items recognized in Other Comprehensive Income or directly in equity. In this case the tax is also recognised in Other Comprehensive Income or directly in equity respectively.

(n) Employee Benefits

(i) Short Term Employee Benefits

Short term employee benefits are expensed as the related service is provided. A liability is recognized for the amount expected to be paid if the Company has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

(ii) Post Employment Benefits

Defined Contribution Plans

The Company's defined contribution plans are Superannuation and Employees Provident Fund, Employee State Insurance/Labour Fund and Employees' Pension Scheme (under the provisions of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952) since the Company has no further obligation beyond making the contributions. The Company's contributions to these plans are charged to the Statement of Profit and Loss as incurred.

Defined Benefits Plans

Liability for defined benefit plans is provided on the basis of valuations as at the Balance Sheet date, carried out by an independent actuary.

Gratuity

The gratuity fund benefits are administered by a Trust recognized by Income Tax Authorities through Group Gratuity Schemes. The liability for gratuity at the end of the each financial year is determined on the basis of actuarial valuation carried out by the independent Actuary. The method used for measuring the liability for gratuity is Projected Unit Credit Method. Actuarial gains and losses are recognized in the Statement of Other Comprehensive Income in the period of occurrence of such gains and losses. The obligations for gratuity are measured at the present value of estimated future cash flows discounted at rates reflecting the prevailing market yields of Indian Government securities as at the Balance Sheet date for the estimated term of the obligations. The estimate of future salary increases considered takes into account the inflation, seniority, promotion and other relevant factors. The expected rate of return of plan assets is the Company's expectation of the average long-term rate of return expected on investments of the fund during the estimated term of the obligations. Plan assets are measured at fair value as at the Balance Sheet date.

(iii) Other Long Term Benefit Plans

The liabilities for earned leave are not expected to be settled wholly within 12 months after the end of the period in which the employees render the related service. They are therefore measured as the present value of expected future payments to be made in respect of services provided by employees up to the end of the reporting period using the Projected Unit Credit Method. The benefits are discounted using the market yields at the end of the reporting period that have terms approximating to the terms of the related obligation. Re-measurements as a result of experience adjustments and changes in actuarial assumptions are recognized in Other Comprehensive Income.

(o) Earnings Per Share

Basic earnings per Share is calculated by dividing the profit for the period attributable to the owners of Company by the weighted average number of equity shares outstanding during the period. The weighted average number of equity shares outstanding during the period and for all periods presented is adjusted for events, such as bonus shares, other than the

conversion of potential equity shares that have changed the number of equity shares outstanding without a corresponding change in resources. For the purposes of calculating diluted earnings per share the profit for the period attributable to the owners of the Company and the weighted average number of shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares.

(p) Exceptional Items

When items of income or expense are of such nature, size and incidence that their disclosure is necessary to explain the performance of the Company for the year, the Company makes a disclosure of the nature and amount of such items separately under the head "Exceptional Items."

(q) Government Grants

Government grants are recognized when there is a reasonable assurance that the Company will comply with the conditions attaching to them and the grants will be received. Government grants are recognised in the Statement of Profit and Loss on a systematic basis over the periods in which the Company recognizes as expense the related cost for which the grants are intended to compensate. Government grants related to assets, including non-monetary grants at fair value, are presented in the Balance Sheet by setting up the same as deferred income.

(r) Provisions and Contingent Liabilities

A provision is recognized if as a result of a past event, the Company has a present obligation (legal or constructive) that can be estimated reliably and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are recognized at the best estimate of the expenditure required to settle the present obligation at the Balance Sheet date. If the effect of time value of money is material, provisions are discounted using a current pre tax rate that reflects, when appropriate the risks specific to the liability.

A contingent liability exists when there is a possible but not probable obligation, or a present obligation that may, but probably will not, require an outflow of resources, or a present obligation whose amount cannot be estimated reliably. Contingent liabilities do not warrant provisions but are disclosed unless the possibility of outflow of resources is remote. Contingent assets are neither recognized nor disclosed in the Ind AS Financial Statements. However, when the realization of income is virtually certain then the related asset is not a contingent asset and its recognition is appropriate.

(s) Rounding of Amounts

All amounts disclosed in the Financial Statements and accompanying notes have been rounded off to the nearest lakhs as per the requirement of Schedule III of the Companies Act, 2013 unless otherwise stated.

(t) Dividends

Dividend proposed (including income tax thereon) is recognized in the period in which interim dividends are approved by the Board of Directors or in respect of final dividend when approved by shareholders.

(u) Borrowing Cost

Borrowing costs directly attributable to the acquisition or construction of qualifying assets are capitalized as part of the cost of such assets. A qualifying asset is one that necessarily takes substantial period of time to get ready for its intended use. All other borrowing costs are charged to the Statement of Profit and Loss for the period for which they are incurred.

(v) Recent pronouncements

Ministry of Corporate Affairs ("MCA") notifies new Standards or amendments to the existing Standards under Companies (Indian Accounting Standards) Rules as issued from time to time. For the Year ended March 31, 2026, MCA has notified amendments to Ind AS-1 "Presentation of Financial Instruments", Ind AS-7 "Statement of Cash Flows", Ind AS-107 "Financial Instruments: Disclosures" applicable w.e.f. April 1, 2025 and Ind AS-12 regarding International Tax Reform-Pillar Two Model Rules applicable immediately. The Company has reviewed the new pronouncements and based on its evaluation has determined that it does not have any significant impact in its financial statements.

Level 3: The fair value of financial instruments that are measured on the basis of entity specific valuations using inputs that are not based on observable market data (unobservable inputs). Fair value of investment in unquoted equity shares is determined using discounted cash flow technique.

The carrying amounts of all financial instruments are considered to be the same as their fair values.

c) Financial Risk Management

In the course of its business, the Company is exposed to a number of financial risks: credit risk, liquidity risk, market risk. This note presents the Company's objectives, policies and processes for managing its financial risk and capital.

i) Credit Risk

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations, and arises principally from the Company's receivables from customers.

Trade and other receivables

The Company's Trade Receivables are largely from sales made to wholesale customers. The Company's exposure to credit risk is influenced mainly by the individual characteristics of each customer, demographics of the customer and the default risk of the industry.

The Company manages credit risk through credit approvals, establishing credit limits and continuously monitoring the creditworthiness of customers to which the Company grants credit terms in the normal course of business.

Exposures to customers outstanding at the end of each reporting period are reviewed to determine incurred and expected credit losses and the Company establishes an allowance for doubtful debts and impairment that represents its estimate of expected losses in respect of trade receivables. Historical trends of impairment of Trade Receivables do not reflect any significant losses.

Market risk is the risk of loss of future earnings, fair values or future cash flows that may result from adverse changes in market rates and prices (such as interest rates and foreign currency exchange rates) or in the price of market risk-sensitive instruments as a result of such adverse changes in market rates and prices. Market risk is attributable to all market risk-sensitive financial instruments, all foreign currency receivables and payables. The Company is exposed to market risk primarily relates to foreign exchange rate risk.

Currency risk

The fluctuation in foreign currency exchange rates may have potential impact on the profit and loss account, where any transaction references more than one currency or where assets/liabilities are denominated in a currency other than the functional currency of the entity. The Company is exposed to currency risk on account of its payables in foreign currency. The functional currency of the Company is Indian Rupee. The Company is exposure to USD. The Company has not hedged this foreign currency exposure.
