Based on our review conducted and procedures performed as stated in paragraph 3 above, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with recognition and measurement principles laid down in the aforesaid Ind AS 34 prescribed under Section 133 of the Companies Act, 2013, as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of the Listing Regulations, including the manner in which it is to be disclosed, or that it contains any material misstatement.

The accompanying Statement includes unaudited interim financial results and other unaudited financial information in respect of one subsidiary, whose interim financial results and other financial information reflect Total Income of Rs. 81.48 lakhs for the quarter ended June 30, 2026 and Rs. 1160.66 lakhs for the year ended March 31, 2026. Total Net Profit after tax of Rs. 38.39 lakhs for the quarter ended June 30, 2026 and Rs. 236.15 lakhs for the year ended March 31, 2026, and Total Comprehensive Income of Rs. 3515.08 lakhs for the quarter ended June 30, 2026 and Rs. 1006.09 lakhs for the year ended March 31, 2026, as considered in the Statement whose interim financial results and other financial information have not been reviewed by its auditors. These unaudited interim financial results and other unaudited financial information have been approved and furnished to us by the Management and our conclusion on the Statement, in so far as it relates to the affairs of this subsidiary, is based solely on such unaudited interim financial results and other unaudited financial information. According to the information and explanations given to us by the Management, these interim financial results are not material to the Group.

Our conclusion on the Statement in respect of matters stated in para 6 above is not modified with respect to our reliance on the financial results certified by the Management.
