Sub: Disclosure of information pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 - Update on Case no. 32/09 filed for adjudication of Charter of Demands.

This is with reference to intimation filed by the Company on September 12, 2025 informing of the development in relation to the ongoing litigation wherein an Award was passed by the Industrial Tribunal Panjim-Goa dated 25/05/2021 which is being challenged by the Company vide writ petition no. WP/358/2021 filed before the Hon'ble High Court of Bombay at Goa.

Simultaneously, the said matter was also pending before the office of The Labour Commissioner for execution of the Award , and in relation to this the Labour Commissioner vide Order dated September 04, 2025 , passed an Order for the recovery of Rs. 8,82,00,856/- from the Company.

In continuation to the above, we would further like to inform you that in respect of the said Order passed by the Labour Commissioner, the Company has now received a "Notice of Demand" from the Office of the Mamlatdar of Bardez Taluka, Mapusa , Goa, on Monday, July 13, 2026 at 5:00 P.M. (IST) for recovery of said dues within a period of 10 days.

The details of the development on the said Order is provided in Annexure I as per the requirements of Regulation 30 of the SEBI Listing Regulations read with SEBI Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026.

The Company in consultation with its legal counsel will be challenging this Order before the Hon'ble High Court of Bombay by filing a writ petition seeking appropriate relief.
