The Results were reviewed by the Audit Committee of the Company today, in its meeting held on August 14, 2026, and further approved by the Board of Directors of the Company.

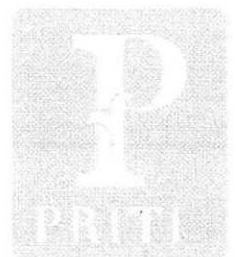

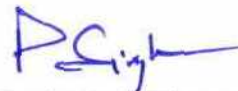

1. The above Financial Results have been prepared in accordance with the recognition and measurement principles laid down in the applicable Indian accounting standards ("Ind AS") prescribed under Section 133 of the Companies Act, 2013 read with the relevant rules issued thereunder.
2. The above Standalone Financial Results for the quarter ended 30th June, 2026 were reviewed by the Audit Committee and were approved by the Board of Directors at its meeting held on 14th August, 2026 and have been Limited Reviewed by Statutory Auditors of the Company.
3. The Company is not having any subsidiary, associate or joint venture, therefore it has prepared only standalone financial results as consolidation requirement is not applicable to the Company. Further, the Company has a branch office in Bangalore, the financial balances of the branch office are incorporated in the books of head office (Jodhpur).
4. The Company is engaged in Manufacturing and Selling of Handicraft items and Textile items and Trading of Solar products. The Company has reported segment information as per Ind AS 108 "Operating Segments". The identification of operating segments is consistent with performance assessment and resource allocation by the management.
5. All the amounts included in the Unaudited Standalone Quarterly Financial Results are rounded off to the nearest lakhs, except per share data and unless stated otherwise.
6. On November 21, 2025; the Government of India notified provisions of The Labour Codes. These Labour Codes consolidate twenty-nine existing labour laws into a unified framework governing employee benefit during employment and post-employment and amongst other things introduce changes, including a uniform definition of wages and enhanced benefits relating to leave. There is no such impact on gratuity liability arising out of past service cost on account of adjustments for Labour Codes as per provisional actuarial report provided by the company management as on date for the quarter ended 30th June, 2026. However, once Central/ State Rules are notified by the Government on all aspects of the Codes, the Company will evaluate impact, if any, on the measurement of employee benefits and would provide appropriate accounting treatment.
