Brief details of litigation	As informed by the Company vide its intimation dated August 14, 2023, the Company had filed a petition before the Hon'ble Bombay High Court challenging the demand notice dated January 8, 2013, of Rs. 5,201.2 Cr (revised to Rs. 8,414 Cr in 2018), issued by the Department of Telecommunications towards one-time spectrum charge (OTSC). This included OTSC demand of Rs.473.7 Cr pertaining to the Company's subsidiary, Bharti Hexacom Limited, in relation to its two telecom circles namely, Rajasthan and NESAs.
