The Monarch Surveyors and Engineering Consultants Limited is pleased to announce that it has recently received Letter of Acceptance Appointment of Consultant for ADB/PISC Consulting Services for Program Implementation Support Consultant for Maharashtra Green Roads Connectivity for Inclusive Growth Program and the project have been awarded under a Joint Venture (JV), in which the Monarch Surveyors and Engineering Consultants Limited holds a 70% partnership stake and total order value of the project is Rs. 23,53,47,000/- (Rupees Twenty-Three Crores Fifty-Three Lakhs Forty-Seven Thousand Only). As per MOU signed with a third-party, share of Monarch is 70% of the total order value.
