O R D E R

1. Leave granted.
2. These Civil Appeals are against the judgment and order of the Delhi High Court in O.M.P. (T) (COMM.) Nos. 89/2024, 88/2024 and 90/2024 dated 09.07.2025, dismissing the appellant's application filed under Section 14 of the Arbitration & Conciliation Act, 1996 seeking the termination of the mandate of the Sole Arbitrator appointed by the respondent through a composite reference.
3. The appellant and the respondent have taken instructions to request for referring the dispute to Delhi International Arbitration Centre (DIAC) for institutional arbitration.

4. The DIAC being the institutional arbitration, shall consider the arbitration clause as also the claims of the respective parties and decide the method and manner of initiation, conduct and conclusion of the arbitral proceedings. Learned counsel for the parties have expressed their willingness to explore the possibility of the arbitral proceedings be conducted through a single arbitrator. DIAC will assist them in this regard.

5. All contentions are kept open for the parties to raise and contest before the Arbitral Tribunal.

6. In view of the agreement, the judgment and order passed by the High Court in O.M.P. (T) (COMM.) Nos. 89/2024, 88/2024 and 90/2024 dated 09.07.2025 is set aside and the Civil Appeals stand disposed of. The parties are referred to DIAC for resolution of disputes through arbitration.

7. Pending application(s), if any, shall stand disposed of.
