Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that an inadvertent fire incident taking place since the Afternoon hours of 19th August 2026 at our Raw Material Godown situated at our Factory premises ,143-146, Vaduganpatti Village, Nadukallur to Tirunelveli, Tirunelveli Taluk, Tirunelveli 627010, Tamil Nadu, India.

The incident yet to be brought under control, on-site safety personnel in close coordination with the local fire-fighting authorities are continuing the extinguishing of fire. The Company is presently undertaking a comprehensive assessment to ascertain the extent of damage of Raw material and operational infrastructure. As of the current stage, no human injury or loss of life has been reported.

In view of the prevailing circumstances, production activities have been temporarily suspended as a precautionary and safety-oriented measure. The Company is actively implementing requisite measures to safeguard personnel, contain losses, and facilitate the earliest possible resumption of operations.

The requisite details in accordance with SEBI Master Circular No. SEBI /HO/ CFD/ PoD2/ CIR/P/0155 dated 11 November 2024 are given in Annexure-I.
