Subject: Request for Re-classification of Siemens Energy Holding B.V. and Siemens Energy Holdco B.V. from "Promoter" Shareholder Category to "Public" Shareholder Category of Siemens Limited under Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Members of the Board,

1. We write on behalf of Siemens Energy Holding B.V. ("**SEH**"), a company incorporated under the laws of the Netherlands, and Siemens Energy Holdco B.V. ("**SE Holdco**"), a company incorporated under the laws of the Netherlands, both currently classified as promoters of Siemens Limited ("**Company**"), a company listed on BSE Limited and the National Stock Exchange of India Limited (collectively, "**Stock Exchanges**").
2. As on date, SEH and SE Holdco do not hold any equity shares of the Company or exercise control over the Company. Consequently, SEH and SE Holdco hereby request the Board of Directors of the Company to initiate the process for re-classification of SEH and SE Holdco from the "Promoter" shareholder category to the "Public" shareholder category (i.e., removal of SEH and SE Holdco from the list of Promoters / Promoter group of the Company), in accordance with Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time ("**SEBI LODR Regulations**").
3. As required under Regulation 31A(3)(b) of the SEBI LODR Regulations, as on the date of this request letter, it is hereby confirmed that SEH and SE Holdco along with the persons related to us (as defined in Regulation 31A(1)(b) of the SEBI LODR Regulations):
 - (a) do not, together, hold any equity shares of the Company;
 - (b) do not exercise control over the affairs of the Company, directly or indirectly;
 - (c) do not have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;

- (d) are not represented on the board of directors (including through nominee directors) of the Company;
 - (e) do not act as key managerial personnel of the Company;
 - (f) are not categorized as 'wilful defaulters' as per the Reserve Bank of India guidelines;
 - (g) are not categorized as fugitive economic offenders.
4. SEH and SE Holdco shall continue to comply with the conditions mentioned in sub-clauses (i), (ii) and (iii) of clause (b) of sub-regulation (3) of Regulation 31A of the SEBI LODR Regulations, at all times from the date of re-classification, failing which we acknowledge and understand that SEH and SE Holdco will again be reclassified as "promoters" of the Company.
5. SEH and SE Holdco shall continue to comply with the conditions mentioned in sub-clauses (iv), (v) of clause (b) of sub-regulation (3) of Regulation 31A of the SEBI LODR Regulations for a period of not less than three years from the date of re-classification, failing which we acknowledge and understand that SEH and SE Holdco will again be reclassified as "promoters" of the Company.
6. In view of the above, SEH and SE Holdco respectfully requests the Board of Directors of the Company to take all actions necessary or desirable in accordance with Regulation 31A of the SEBI LODR Regulations for the reclassification of SEH and SE Holdco from the "Promoter" to "Public" shareholder category of the Company
7. SEH and SE Holdco hereby confirm their willingness and commitment to fully cooperate with the Company, its Board of Directors, the Stock Exchanges, SEBI, and any other relevant regulatory authority in connection with the re-classification process. SEH and SE Holdco undertake to provide such information, documents, confirmations, undertakings, and declarations as may be required by the Company, the Stock Exchanges, or SEBI for the purposes of effecting the re-classification in a timely manner.

We would be grateful for your prompt attention to this matter.

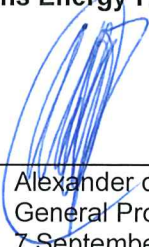
