The Ministry of Corporate Affairs (MCA) vide General Circular No. 14/2020 dated 08.04.2020, General Circular No. 17/2020 dated 13.04.2020 and subsequent circulars issued in this regard, the latest being 03/2025 dated September 22, 2025 (collectively referred to as "MCA Circulars") has permitted holding of AGM through Video Conferencing (VC) or Other Audio Visual Means (OAVM) without the physical presence of the members at a common venue. Further, the Securities and Exchange Board of India ('SEBI') vide its circulars dated May 12, 2020, and subsequent circulars issued in this regard, the latest being October 3, 2024 ('SEBI Circulars') has provided certain relaxations from compliance with certain provisions of the SEBI Listing Regulations.
2. In compliance with the applicable provisions of the Companies Act, 2013 ('the Act'), the SEBI Listing Regulations and the MCA Circulars, the 36<sup>th</sup> AGM of the Company is being held through VC / OAVM on Wednesday, September 30, 2026 at 11.45 a.m. (IST). 3. #### **ITEM NO. 2**

This Explanatory Statement is provided though strictly not required as per Section 102 of the Act.

Mr. M.R. Gautham and his relatives may be deemed to be interested in the Ordinary Resolution about his re-appointment as set out in Item No. 2 of the Notice.

#### **ITEM NO. 3**

This Explanatory Statement is provided though strictly not required as per Section 102 of the Act.

Mrs. M. Sasikala and her relatives may be deemed to be interested in the Ordinary Resolution about her re-appointment as set out in Item No. 3 of the Notice.

#### **ITEM NO. 4**

As per Regulation 2(1)(zb) of SEBI (Listing Obligations and Disclosure Requirements) 2015 ("SEBI LODR"), related party means a related party as defined under Section 2(76) of the Companies Act, 2013 ("the Act") or under the applicable accounting standards and, inter-alia, includes any person or entity forming part of the promoter or promoter group of a company and any person or entity holding 10% or more equity shares of the Company either directly or on a beneficial interest basis, at any time, during the immediate preceding financial year shall be deemed to be a related party.

Further, Regulation 2(1)(zc) of the SEBI LODR, as amended, inter-alia, provides that a transaction involving transfer of resources, services or obligations between:

- i) A listed entity or any of its subsidiaries on one hand and a related party of the listed entity or any of its subsidiaries on the other hand;
- ii) A listed entity or any of its subsidiaries on one hand, and any other person or entity on the other hand, the purpose and effect of which is to benefit a related party of the listed entity or any of its subsidiaries is a "Related Party Transaction" (RPT). The RPT shall be construed to include a single transaction or a group of transactions in a contract.

As per the proviso to Regulation 23(1) of the SEBI LODR read with Schedule XII, as amended, specifies that a transaction with a related party shall be considered material, if the transaction(s) to be entered into individually or taken together with previous transactions during a financial year, exceeds 10% of the annual consolidated turnover of the listed entity (as applicable to the Company) as per the last audited financial statements of the listed entity. Further, the transaction exceeds the materiality threshold prescribed under Regulation 23 of SEBI LODR, being 10% of the annual consolidated turnover of the Company (as applicable to the Company). As per the audited financial statements for the year ended 31 March 2026, the Company's turnover is Rs.3,55,000/- and the materiality threshold is Rs.35,500/- ("Materiality Threshold"). Regulation 23(4) of the SEBI LODR provides for obtaining prior approval of the Members of the Company for all RPTs which exceeds Materiality Threshold and subsequent material modifications thereof.

Regulation 23(2) provides that the prior approval of the Audit Committee is required for all RPTs where a listed entity is a party. Further, as per Regulation 23(3) of SEBI LODR and Rule 6A of Companies (Meetings of Board and its Powers) Rules, 2014 (Rules), for transaction which are repetitive in nature, the Audit Committee may grant omnibus approval for such RPTs. The transactions entered into are placed before the Audit Committee on quarterly basis for review. In line with the same, the Audit Committee at its meeting held on 22nd May 2026, has granted its approval for transactions proposed to be entered into during FY 2026-27 with the Related Parties.

The transactions, which are not part of omnibus approval, are executed after seeking approval of the Audit Committee and Members, if applicable. These transactions generally relate to related-party transactions that are proposed to be undertaken to support and achieve the Company's business objectives from time to time. Accordingly, the Company has sought requisite approvals for related party transactions relating to availing fund based support, based on the business requirements, as may be required from time to time from its promoters.

The shareholders at their 35th Annual General Meeting held on 27th September 2025 approved material related party transactions with Mr.E.V.Muthukumara Ramalingam, the Chairman & Managing Director (a Promoter of the Company) for an aggregate amount not exceeding Rs.20 Crore for a period from 35th AGM upto next AGM to be held thereafter in relation to the material related party transactions envisaged for availing fund based support and/or any transfer of resources or obligations to meet its objectives / requirements and any transfer of resources to meet its objectives/requirements.

It is proposed to consider and approve the limits approved for the purpose of transaction relating to availing fund based support and re-payment of principle and interest/charges, if any ("borrowings"), from Mr.E.V.Muthukumara Ramalingam, the Chairman & Managing Director (a Promoter of the Company) not exceeding Rs.20 Crores. The proposed approval is an enabling provision for undertaking Related Party Transactions based on the business needs and requirements of the Company.

The Audit Committee and the Board of Directors at their respective meetings held on 22nd May 2026 have considered, approved and recommended the material RPT with Mr.E.V.Muthukumara Ramalingam, the Chairman & Managing Director (a Promoter of the Company) as mentioned in Item No.4 of this notice, for approval of the members.

Further, in terms of Regulation 23(4) of SEBI LODR, the approval granted by the shareholders for material related party transactions in an annual general meeting shall be valid till the date of the next annual general meeting held within the timelines prescribed under Section 96 of the Companies Act, 2013 or rules, notifications, or circulars issued thereunder from time to time. In case of approvals for material related party transactions, granted by shareholders in general meetings other than annual general meeting, the validity of such omnibus approvals shall not exceed one year from the date of such approval.

The Audit Committee and the Board of Directors at their respective meetings held on 22nd May 2026 have considered, approved and recommended the modification to the material related party transactions as envisaged in this notice in Item No.4 for approval of the members. Further, at the said meeting the Audit Committee has also reviewed the Certificate from the Managing Director and the Chief Financial Officer

(CFO) of confirming that the terms of RPTs proposed to be entered into are in the interest of the Company.

The RPTs placed for members' approval will be reviewed/ monitored on quarterly basis by the Audit Committee of the Company as per Regulation 23 of the SEBI LODR and Section 177 of the Act and shall remain within the proposed amount(s) being placed before the Members. Any subsequent material modifications in the proposed transactions, as defined by the Audit Committee as a part of the Company's Policy on Materiality of and dealing with Related Party Transactions, shall be placed before the members for approval, in terms of Regulation 23(4) of the SEBI LODR.

As per Regulation 2(1)(zb) of SEBI (Listing Obligations and Disclosure Requirements) 2015 ("SEBI LODR"), related party means a related party as defined under Section 2(76) of the Companies Act, 2013 ("the Act") or under the applicable accounting standards and, inter-alia, includes any person or entity forming part of the promoter or promoter group of a company and any person or entity holding 10% or more equity shares of the Company either directly or on a beneficial interest basis, at any time, during the immediate preceding financial year shall be deemed to be a related party.

Further, Regulation 2(1)(zc) of the SEBI LODR, as amended, inter-alia, provides that a transaction involving transfer of resources, services or obligations between:

- i) A listed entity or any of its subsidiaries on one hand and a related party of the listed entity or any of its subsidiaries on the other hand;
- ii) A listed entity or any of its subsidiaries on one hand, and any other person or entity on the other hand, the purpose and effect of which is to benefit a related party of the listed entity or any of its subsidiaries is a "Related Party Transaction" (RPT). The RPT shall be construed to include a single transaction or a group of transactions in a contract.

As per the proviso to Regulation 23(1) of the SEBI LODR read with Schedule XII, as amended, specifies that a transaction with a related party shall be considered material, if the transaction(s) to be entered into individually or taken together with previous transactions during a financial year, exceeds 10% of the annual consolidated turnover of the listed entity (as applicable to the Company) as per the last audited financial statements of the listed entity. Further, the transaction exceeds the materiality threshold prescribed under Regulation 23 of SEBI LODR, being 10% of the annual consolidated turnover of the Company (as applicable to the Company). As per the audited financial statements for the year ended 31 March 2026, the Company's turnover is Rs.3,55,000/- and the materiality threshold is Rs.35,500/- ("Materiality Threshold"). Regulation 23(4) of the SEBI LODR provides for obtaining prior approval of the Members of the Company for all RPTs which exceeds Materiality Threshold and subsequent material modifications thereof.

Regulation 23(2) provides that the prior approval of the Audit Committee is required for all RPTs where a

listed entity is a party. Further, as per Regulation 23(3) of SEBI LODR and Rule 6A of Companies (Meetings of Board and its Powers) Rules, 2014 (Rules), for transaction which are repetitive in nature, the Audit Committee may grant omnibus approval for such RPTs. The transactions entered into are placed before the Audit Committee on quarterly basis for review. In line with the same, the Audit Committee at its meeting held on 22nd May 2026, has granted its approval for transactions proposed to be entered into during FY 2026-27 with the Related Parties.

The transactions, which are not part of omnibus approval, are executed after seeking approval of the Audit Committee and Members, if applicable. These transactions generally relate to related-party transactions that are proposed to be undertaken to support and achieve the Company's business objectives from time to time. Accordingly, the Company has sought requisite approvals for related party transactions relating to availing fund based support, based on the business requirements, as may be required from time to time from its promoter group.

The shareholders at their 35<sup>th</sup> Annual General Meeting held on 27<sup>th</sup> September 2025 approved material related party transactions with Mr.Muthukumararamalingam Gautham @ M.R.Gautham, Executive Director (a member of Promoter Group of the Company) for an aggregate amount not exceeding Rs.20 Crore for a period from 35th AGM upto next AGM to be held thereafter in relation to the material related party transactions envisaged for availing fund based support and/or any transfer of resources or obligations to meet its objectives / requirements and any transfer of resources to meet its objectives/requirements.

It is proposed to consider and approve the limits approved for the purpose of transaction relating to availing fund based support and re-payment of principle and interest/charges, if any ("borrowings"), from Mr.Muthukumararamalingam Gautham @ M.R.Gautham, Executive Director (a member of Promoter Group of the Company) not exceeding Rs.20 Crores. The proposed approval is an enabling provision for undertaking Related Party Transactions based on the business needs and requirements of the Company.

The Audit Committee and the Board of Directors at their respective meetings held on 22nd May 2026 have considered, approved and recommended the material RPT with Mr.Muthukumararamalingam Gautham @ M.R.Gautham, Executive Director (a member of Promoter Group of the Company) as mentioned in Item No.5 of this notice, for approval of the members.

Further, in terms of Regulation 23(4) of SEBI LODR, the approval granted by the shareholders for material related party transactions in an annual general meeting shall be valid till the date of the next annual general meeting held within the timelines prescribed under Section 96 of the Companies Act, 2013 or rules, notifications, or circulars issued thereunder from time to time. The Audit Committee and the Board of Directors at their respective meetings held on 22nd May 2026 have considered, approved and recommended the modification to the material related party transactions as envisaged in this notice in Item No.5 for approval of the members. Further, at the said meeting the Audit

Committee has also reviewed the Certificate from the Managing Director & Chief Executive Officer (CEO)/ and Chief Financial Officer (CFO) of confirming that the terms of RPTs proposed to be entered into are in the interest of the Company.

The RPTs placed for members' approval will be reviewed/ monitored on quarterly basis by the Audit Committee of the Company as per Regulation 23 of the SEBI LODR and Section 177 of the Act and shall remain within the proposed amount(s) being placed before the Members. Any subsequent material modifications in the proposed transactions, as defined by the Audit Committee as a part of the Company's Policy on Materiality of and dealing with Related Party Transactions, shall be placed before the members for approval, in terms of Regulation 23(4) of the SEBI LODR.

As per Regulation 2(1)(zb) of SEBI (Listing Obligations and Disclosure Requirements) 2015 ("SEBI LODR"), related party means a related party as defined under Section 2(76) of the Companies Act, 2013 ("the Act") or under the applicable accounting standards and, inter-alia, includes any person or entity forming part of the promoter or promoter group of a company and any person or entity holding 10% or more equity shares of the Company either directly or on a beneficial interest basis, at any time, during the immediate preceding financial year shall be deemed to be a related party.

Further, Regulation 2(1)(zc) of the SEBI LODR, as amended, inter-alia, provides that a transaction involving transfer of resources, services or obligations between:

- i) A listed entity or any of its subsidiaries on one hand and a related party of the listed entity or any of its subsidiaries on the other hand;
- ii) A listed entity or any of its subsidiaries on one hand, and any other person or entity on the other hand, the purpose and effect of which is to benefit a related party of the listed entity or any of its subsidiaries is a "Related Party Transaction" (RPT). The RPT shall be construed to include a single transaction or a group of transactions in a contract.

As per the proviso to Regulation 23(1) of the SEBI LODR read with Schedule XII, as amended, specifies that a transaction with a related party shall be considered material, if the transaction(s) to be entered into individually or taken together with previous transactions during a financial year, exceeds 10% of the annual consolidated turnover of the listed entity (as applicable to the Company) as per the last audited financial statements of the listed entity. Further, the transaction exceeds the materiality threshold prescribed under Regulation 23 of SEBI LODR, being 10% of the annual consolidated turnover of the Company (as applicable to the Company). As per the audited financial statements for the year ended 31 March 2026, the Company's

turnover is Rs.3,55,000/- and the materiality threshold is Rs.35,500/- ("Materiality Threshold"). Regulation 23(4) of the SEBI LODR provides for obtaining prior approval of the Members of the Company for all RPTs which exceeds Materiality Threshold and subsequent material modifications thereof.

Regulation 23(2) provides that the prior approval of the Audit Committee is required for all RPTs where a listed entity is a party. Further, as per Regulation 23(3) of SEBI LODR and Rule 6A of Companies (Meetings of Board and its Powers) Rules, 2014 (Rules), for transaction which are repetitive in nature, the Audit Committee may grant omnibus approval for such RPTs. The transactions entered into are placed before the Audit Committee on quarterly basis for review. In line with the same, the Audit Committee at its meeting held on 22nd May 2026, has granted its approval for transactions proposed to be entered into during FY 2026-27 with the Related Parties.

The transactions, which are not part of omnibus approval, are executed after seeking approval of the Audit Committee and Members, if applicable. These transactions generally relate to related-party transactions that are proposed to be undertaken to support and achieve the Company's business objectives from time to time. Accordingly, the Company has sought requisite approvals for related party transactions relating to availing fund based support, based on the business requirements, as may be required from time to time from its promoter group company.

The shareholders at their 35th Annual General Meeting held on 27<sup>th</sup> September 2025 approved material related party transactions with Shree Vallee Enterprises Pvt Ltd, a promoter group Company for an aggregate amount not exceeding Rs.30 Crore for a period from the 35<sup>th</sup> AGM upto the next AGM to be held thereafter in relation to the material related party transactions envisaged for availing fund based support and/or any transfer of resources or obligations to meet its objectives / requirements and any transfer of resources to meet its objectives/requirements.

It is proposed to consider and approve the limits approved for the purpose of transaction relating to availing fund based and/or non-fund based support including Inter-corporate deposits ("ICD"), and re-payment of principle and interest/charges thereon ("borrowings"), from Shree Vallee Enterprises Private Limited, the promoter group company not exceeding Rs.30 Crores. The proposed approval is an enabling provision for undertaking Related Party Transactions based on the business needs and requirements of the Company.

The Audit Committee and the Board of Directors at their respective meetings held on 22nd May 2026 have considered, approved and recommended the material RPT with Shree Vallee Enterprises Pvt Ltd, the promoter group company as mentioned in Item No.6 of this notice, for approval of the members.

Further, in terms of Regulation 23(4) of SEBI LODR, the approval granted by the shareholders for material related party transactions in an annual general meeting shall be valid till the date of the next annual general meeting held within the timelines prescribed under Section 96 of the Companies Act, 2013 or rules, notifications, or circulars issued thereunder from time to time. In case of approvals for material related party transactions, granted by shareholders in general meetings other than annual general meeting, the validity of such omnibus approvals shall not exceed one year from the date of such approval.

**Material Terms & Justification:**

The existing/proposed transactions would be purely operational of the operations of the Company and are/will be entered in the ordinary course of business with terms and conditions agreed between the Company and the related party.

Loans, if availed, shall be unsecured and at a prevailing market rate of interest on arm's length basis and subject to terms and conditions as approved by the Audit Committee and/or the Board of Directors, as may be applicable from time to time and acceptable to the Related Party.

The loan shall be availed or provided for short/long term basis and can be availed / provided in tranches, from time to time, during the period upto one year from the date of approval of this resolution in accordance with the limits as specified under the SEBI LODR and shareholders' approved limits, from time to time.

The proposed approval is an enabling provision for undertaking Related Party Transactions with the promoter group company, as may be required, based on the business needs and requirements of the Company.

The Audit Committee and the Board of Directors at their respective meetings held on 22nd May 2026 have considered, approved and recommended the modification to the material related party transactions as envisaged in this notice in Item No. 6 for approval of the members. Further, at the said meeting the Audit Committee has also reviewed the Certificate from the Managing Director & Chief Executive Officer (CEO)/ and Chief Financial Officer (CFO) of confirming that the terms of RPTs proposed to be entered into are in the interest of the Company.

The RPTs placed for members' approval will be reviewed/ monitored on quarterly basis by the Audit Committee of the Company as per Regulation 23 of the SEBI LODR and Section 177 of the Act and shall remain within the proposed amount(s) being placed before the Members. Any subsequent material modifications in the proposed transactions, as defined by the Audit Committee as a part of the Company's Policy on Materiality of and dealing with Related Party Transactions, shall be placed before the members for approval, in terms of Regulation 23(4) of the SEBI LODR.

It is pertinent to note that no related party of the Company shall vote to approve Resolution(s) at item no. 6 of the Notice, whether the entity is a related party to the particular transaction or not.

**ITEM NO.7**

To pay the debts of the Company to RARE Asset Reconstruction Limited in terms of the OTS, Mr.E.V.Muthukumara Ramalingam, Managing Director, Shree Vallee Enterprises Pvt Ltd, a promoter group Company and Mr.M.R.Gautham, Executive Director of the Company have provided the un-secured loan to the Company to the tune of Rs.3551.44 lakhs upto 31st March 2026. Considering the financial position of the Company and its inability to repay the said unsecured loans to them, in the opinion of the Board, the sale of

properties of the Company to them jointly or severally or to their nominees or willing purchasers (non-related parties) is the only option to settle their dues.

In February 2026, the Members of the Company approved the sale of property to the related parties as mentioned in the resolution through Postal Ballot process to complete the sale process before February 2027. However, there may be a delay in completion of the sale process; the proposed resolution is placed before the members again for availing more time.

The related party/parties will purchase the assets. If the property's final transaction value exceeds the buyer's loan balance, the buying party will bring in the cash differential. This cash differential will then be deployed to settle the ledger balances of the non-purchasing related parties, or it will be squared off directly via inter-corporate adjustments in the books of accounts.

Accordingly, the Promoter-Directors/Promoter group company being the related parties with whom the Company may happen to enter into transaction(s) / contract(s) / arrangement(s) / agreement(s) relating to the sale of assets / properties of the Company that consist of vacant lands only and have no buildings or structures thereon in the absence of any other willing purchaser (non-related parties) for settlement of unsecured loans due to them. Hence, Resolutions No. 7 is placed for approval of public shareholders.

Under the provisions of Section 188 of the Companies Act, 2013, the Companies (Meeting of Board and its Powers) Rules, 2014, the Related Party Transactions as mentioned in clause (a) to (g) of the said section require a Company to obtain approval of the Board of Directors and subsequently the Shareholders of the Company by way of a resolution in case the value of the Related Party Transactions exceeds the stipulated thresholds prescribed in Rule'15 of the said Rules and transactions other than in ordinary course of business and on arm's length basis.

Because the unsecured loans were originally brought in as a cash transaction, and any current financial year (2026-27) movements are strictly cash-based, the property adjustment against this book debt constitutes a transaction for cash/monetary consideration. Consequently, this arrangement does not qualify as a non-cash transaction under Section 192 of the Companies Act, 2013. The specialized valuation report mandated under Section 192(1) for non-cash director asset transfers is not legally required.

As per the proviso to Regulation 23(1) of the SEBI LODR read with Schedule XII, as amended, specifies that a transaction with a related party shall be considered material, if the transaction(s) to be entered into individually or taken together with previous transactions during a financial year, exceeds 10% of the annual consolidated turnover of the listed entity (as applicable to the Company) as per the last audited financial statements of the listed entity. Further, the transaction exceeds the materiality threshold prescribed under Regulation 23 of SEBI LODR, being 10% of the annual consolidated turnover of the Company (as applicable to the Company). As per the audited financial statements for the year ended 31 March 2026, the Company's turnover is Rs.3,55,000/- and the materiality threshold is Rs.35,500/- ("Materiality Threshold"). Regulation 23(4) of the SEBI LODR provides for obtaining prior approval of the Members of the Company for all RPTs which exceeds Materiality Threshold and subsequent material modifications thereof.

Accordingly, the transaction has been reviewed and unanimously recommended exclusively by the Independent Directors of the Audit Committee at their meeting held on 22nd May 2026 and the Board of Directors at their meeting held on 22nd May 2026 approved the proposed related party transactions and now seek approval of the shareholders by way of Special Resolution under Section 188 of the Companies Act, 2013, the Companies (Meeting of Board and its Powers) Rules, 2014 and SEBI (LODR) Regulations, 2015 read with Section 180 1 (a) of the Companies Act, 2013 and Rules made there-under to enable the Company

to enter into following related Party Transactions in one or more tranches for effecting the proposed sale of assets mentioned in the resolution.

The above Related Parties with whom the Company may happen to enter into transaction(s) / contract(s) / arrangement(s) / agreement(s) relating to the sale of properties that consist of vacant lands only and have no buildings or structures thereon which may / would / are presumed to exceed the applicable thresholds limit under the Act / SEBI-LODR during the financial year 2026-2027 and in the next financial year 2027-2028 until the date of the Annual General Meeting of the Company to be held during the calendar year 2027.

The sale of assets / undertaking of the Company are an item required to be transacted through postal ballot under the provisions of section 110 of the Companies Act, 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014. However, in terms of the proviso to section 110 of the Companies Act, 2013 introduced as per the Companies (Amendment) Act, 2017, read with Rule 20 and 22 of the Companies (Companies Management and Administration) Rules, 2014 including any statutory modifications and amendments thereto, approval of shareholders for any item of business required to be transacted through postal ballot may be transacted at a general meeting by a company which is required to provide the facility of voting by electronic means to its shareholders. The Company, being a listed Company is required to provide the facility of voting by electronic means to its shareholders and hence, may obtain the approval of its shareholders to sale of assets / undertaking at ensuing Annual General Meeting.

Regulation 37A of SEBI (Listing Obligations and Disclosure Requirements), 2015 (Second Amendment) Regulations, 2023 regarding the sale, lease or disposal of an undertaking outside Scheme of Arrangement shall require prior approval of public shareholders by way of a special resolution. Such a special resolution shall be acted upon only if the votes cast by the public shareholders in favour of the resolution exceed the votes cast by such public shareholders against the resolution.

The members are further apprised that the remaining/adjacent land parcel of the Company admeasuring 9150 Sq.Ft stands earmarked/aligned for a designated "scheme road" / master plan alignment by the Local Town Planning Department / Tirupur Municipal Authority, restricting commercial utilization of that specific segment. Appropriate disclosures and adjustments reflecting this master plan alignment have been factored into the overall property records and municipal submissions.

#### **Item No. 8 :**

The current tenure of Mr. Muthukumararamalingam Gautham @ M.R.Gautham (DIN: 00046187) as the Executive Director of the Company expired on August 8, 2026. Considering his extensive leadership experience, strategic industry insights, and long-standing association with the Company, the Board of Directors at its meeting held on 07th August 2026 with recommendation of the Nomination & Remuneration Committee has re-appointed for a further period of 3 years with effect from August 7, 2026, subject to the approval of the shareholders of the Company at the ensuing AGM.

#### **Material Disclosure on Regulatory Matter & Portal Technical Glitch:**

In line with the highest standards of transparency and corporate governance, the Board wishes to apprise the members regarding an ongoing procedural matter on the Ministry of Corporate Affairs (MCA) Portal. The Registrar of Companies (RoC), Tamilnadu, Coimbatore, issued an Adjudication Order No. PO/ADJ/01-2026/CB/01339 dated 06/01/2026, imposing a penalty of Rs. 40,000/- on Mr.Muthukumararamalingam Gautham in his capacity as an Officer-in-Default for a 30-day delay in filing Form MGT-15 for the Financial Year 2021-22.

Mr. Muthukumararamalingam Gautham maintained a clear, bona fide intent to discharge the penalty within the statutory 90-day window (which ended on 06/04/2026). However, remittance was entirely prevented due to severe infrastructure glitches on the MCA V3 electronic portal. The system consistently trapped his profile status as a "Registered User" and blocked the mandatory upgrade to a "Business User (Director)" login, displaying recurring validation faults ("Personal Details Mismatch" and "Something went wrong") despite entering flawless OTP credentials.

The matter was immediately escalated via a continuous trail of official MCA Service Desk complaints under Ticket IDs: FO\_202603053111064, FO\_202605043240177, FO\_202605133263048, and FO\_202607212667048. Physical letters offering alternative offline treasury payments (such as a Demand Draft) were also formally delivered to the RoC office on 04/04/2026, 01/07/2026 and 22/07/2026. While the backend login error was eventually rectified by the MCA technical desk on 21/07/2026, the electronic payment window currently remains locked due to the automatic system-driven lapse of the statutory timeline.

Due to a temporary lack of procedural clarity regarding the specific electronic mechanism required to bypass the portal lock, as well as the exact steps needed to execute the payment in the system post - 90 days, the Executive Director along with corporate law experts, is actively evaluating the correct legal course of action to regularize this position and clear the penalty at the earliest available opportunity.

### **Board Evaluation and Eligibility Status:**

The Board of Directors has thoroughly evaluated these circumstances and notes that the technical non-payment is entirely procedural, non-willful, and caused by state portal architecture constraints rather than any personal or professional misconduct.

The Board clarifies that the non-payment of an adjudication penalty under these specific technical constraints and procedural uncertainties does not attract statutory disqualification under Section 164 or Section 167 of the Companies Act, 2013. Mr. Muthukumararamalingam Gautham continues to fulfill all eligibility criteria specified under Schedule V of the Act and remains fully eligible to continue his directorship. The Board believes his re-appointment is in the best interest of the Company and its stakeholders.

### **Terms & Remuneration:**

In view of the present operational environment, Mr. Muthukumararamalingam Gautham has proposed to serve the Company entirely without any remuneration, salary, perquisites, or pecuniary benefits for his upcoming term, save for standard out-of-pocket business expense reimbursements and sitting fees, if any. The appointment may be terminated by either side at any time by giving three months' notice in writing.

The Company has received consent in writing from Mr. Muthukumararamalingam Gautham to act as an Executive Director. Copies of the relevant draft letter of re-appointment, the RoC adjudication order, and the technical service desk logs are open for inspection by members at the Registered Office of the Company during business hours.

### **A brief resume of Mr.Muthukumararamalingam Gautham (M.R.Gautham) is given below :**

Mr. M.R. Gautham is 49 years of age with an active business involvement of over 26 years. He is basically from a family of philanthropists into agriculture and holding large commercial Land banks, and is the sixth generation at Tirupur region.

He is a Commerce and Finance Graduate from the University of Western Australia. As his rich industry experience is of immense advantage to the Company, he was appointed as Executive Director of the Velan Hotels Limited since 2001. He is primarily instrumental in structuring its finance, and along with his father, is primarily responsible for the day-to-day activities of the Velan Group of Companies. The same was approved by the Nomination & Remuneration Committee.

He holds 64,20,750 equity shares of the Company by himself, representing 20.09% of total shareholding. He holds Directorship in Shree Vallee Enterprises Pvt Ltd and Managing Director in Statex Engineering Private Ltd as well.

In terms of the provisions of the Companies Act, 2013, consent of the shareholders is required for re-appointment of Mr.Muthukumararamalingam Gautham (M.R.Gautham) as Executive Director of the Company. The Board recommends the resolution for approval of the members as an ordinary resolution.

The terms as set out in the resolution and the explanatory statement may be treated as an abstract of the terms and conditions governing the appointment and memorandum of interest pursuant to Section 190 of the Companies Act, 2013.

Mr. Muthukumararamalingam Gautham (M.R.Gautham) is concerned or interested in this resolution as it relates to his re-appointment. Mr. E.V. Muthukumara Ramalingam and Smt.M.Sasikala being related to Mr. Muthukumararamalingam Gautham (M.R.Gautham) and his relatives may be deemed to be concerned or interested in the resolution.

None of the other Director, Key Managerial Personnel or their respective relatives is concerned or interested, financial or otherwise in the Resolution.

The Board recommends the ordinary resolutions set out at the item no. 08 of the Notice for member's approval of the Company.

#### **Item No. 9 :**

Based on the recommendation of the Nomination and Remuneration Committee, the Board of Directors at their meeting held on 07th August 2026 had re-appointed Mr.Eswaramoorthy Venkatachalam Muthukumara Ramalingam @ Mr.E.V.Muthukumara Ramalingam as Managing Director for 3 year period, notwithstanding that his current ongoing tenure was originally scheduled to expire on 20th May 2027.

By the provisions of Section 196(3) and 203 read with Schedule V of the Companies Act, 2013 (the 'Act'), a person who has attained the age of 70 years can be appointed/re-appointed as Managing Director only by passing a special resolution, in which case, the explanatory statement annexed to the notice for such motion shall indicate the justification for appointing such person. Mr.E.V.Muthukumara Ramalingam has attained the age of 75 years now. The present terms of re-appointment of Mr.E.V.Muthukumara Ramalingam are expiring on 20th May 2027. As per applicable listing regulations, any appointment/re-appointment shall be approved by the members of the Company within three months from the date of appointment/re-appointment. To avoid approval delays in general meeting, the resolution is placed before the members for their approval at this AGM.

#### **Disclosure of Adjudication Penalty Paid to RoC, Tamilnadu, Coimbatore & Compliance Status:**

The members are informed that the Company and its Officers-in-Default had previously received an Adjudication Order No. PO/ADJ/01-2026/CB/01339 dated 06/01/2026 from the Registrar of Companies (RoC), Tamil Nadu, Coimbatore, under Section 454 of the Companies Act, 2013. The order was issued regarding a procedural, technical lapse involving a 30-day delay in filing Form MGT-15 (Report on Annual General Meeting) for the Financial Year 2021-22 under Section 121(1) of the Act. In compliance with Section 454(8) of the Act, the Company and all individual Officers-in-Default-including the appointee Managing Director-duly remitted their respective penalties within the stipulated 90-day statutory period except the Executive Director. The total penalty of ₹1,95,000/- for these complying entities was paid via the Ministry of Corporate Affairs Portal. However, the Executive Director of the Company could not remit their individual penalty within the initial 90-day timeline due to documented system-side technical glitches on the MCA portal while attempting to switchover of the user role/category from the Registered User (Authorised Representative) to Business User (Director). The Executive Director has taken immediate remedial steps to resolve the technical error with the MCA helpdesk. Necessary applications/appeals are being pursued to finalize the individual payment without delay. The default concerning the Managing Director seeking re-appointment stands entirely closed, rectified, and unblemished. The underlying procedural delay in filing

Form MGT-15 has already been fully regularized. The Board has evaluated the nature of the default and believes it was a procedural non-compliance rather than an act of fraud or malfeasance.

Considering his knowledge of various aspects relating to the Company's affairs and long business experience and in terms of the provisions of the Act and the Articles of Association of the Company, the Board of Directors of the Company at its meeting held on 07<sup>th</sup> August 2026 and on the recommendation of the Nomination and Remuneration Committee approved the re-appointment of Mr.E.V.Muthukumara Ramalingam as Managing Director (KMP) of the Company subject to the approval of members / shareholders of the Company in ensuing Annual General Meeting to be held on 30<sup>th</sup> September, 2026 as a Special Resolution for a period of three years from 07<sup>th</sup> August 2026 to 06<sup>th</sup> August 2029.

Mr.E.V.Muthukumara Ramalingam is not disqualified from being re-appointed as a Director in terms of Section 164 of the Companies Act, 2013 and has given his consent to act as a Managing Director.

Mr.E.V.Muthukumara Ramalingam satisfies all the conditions set out in Part-I of Schedule V of the Act and also conditions set out under Section 196 (3) of the Act for being eligible for his reappointment.

**Brief particulars of the terms of re-appointment of and remuneration payable to Mr.E.V.Muthukumara Ramalingam are as under:**

- a. The term of the Managing Director's re-appointment is for three year period with effect from August 07, 2026. He shall not be liable to retire by rotation.
- b. The re-appointment of the Managing Director shall be without any remuneration. Further, no sitting fees shall be payable to the Managing Director during his tenure for attending any meeting of the Board or a committee thereof.
- c. The Managing Director shall be reimbursed for all the expenses incurred by him for travelling, boarding and lodging during his business trips conducted on behalf of the Company. These reimbursements of expenses will not be included in the calculation of the remuneration of the Managing Director.
- d. The Managing Director shall adhere to various policies, codes of conduct and staff rules of the Company as may be applicable by his office to discharge his official duties/powers as delegated by the Board from time to time.
- e. The Managing Director shall act the Articles of Association of the Company and shall abide by the provisions contained in Section 166 of the Act concerning duties of Directors.
- f. The office of the Managing Director may be terminated by the Company or the concerned Director by giving the other 3 (three) months prior notice in writing.

**The brief resume of Mr. Eswaramoorthy Venkatachalam Muthukumara Ramalingam @ Mr. E.V. Muthukumara Ramalingam Managing Director, nature of his expertise in functional areas, disclosure of relationships between Directors, Directorships and Memberships of Committees of the Board of Listed entities and shareholding as required under Regulation 36(3) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended is set out below :**

Mr. E.V. Muthukumara Ramalingam, aged 75 years, is a Commerce Graduate from Madras University. He has been a director ever since the incorporation of the Company. He started his career as a bus fleet operator and diversified into the finance business and later into the hospitality business.

He holds a Directorship in Shree Vallee Enterprises Pvt Ltd and Sarju International Ltd.

He holds 1,10,33,592 equity shares of the Company by himself, representing 34.52% of total shareholding and 1,29,39,497 equity shares held by his immediate relatives, representing 40.48% of the shareholding of the Company.

Since Mr.E.V.Muthukumara Ramalingam as Managing Director has already attained the age of 70 years, a special resolution, per proviso to Section 196 (3)(a) of the Act, is included in the notice seeking approval of the shareholders for the re-appointment of Mr.E.V.Muthukumara Ramalingam as Managing Director of the Company without remuneration.

The Board believes that the re-appointment of Mr.E.V.Muthukumara Ramalingam as Managing Director would be in the interest of the Company and it is desirable to continue to avail services of Mr.E.V.Muthukumara Ramalingam, Managing Director due to his extensive experience regardless of his age. Accordingly, the Board recommends the resolution about the re-appointment of Mr.E.V.Muthukumara Ramalingam Managing Director, for approval by the shareholders of the Company.

The above explanatory statement (together with Annexure thereto) shall be construed to be memorandum setting out the terms of the re-appointment as specified under Section 190 of the Companies Act, 2013 and all the material documents as referred above will be available for inspection at the Registered office of the Company by any Member of the Company without any fee during normal business hours on working days from the date of dispatch of the notice up to the last date of meeting.

Mr.E.V.Muthukumara Ramalingam is concerned or interested in this resolution as it relates to his re-appointment. Mr.M.R.Gautham, Executive Director and Mrs.M.Sasikala, Director being related to Mr.E.V.Muthukumara Ramalingam & their respective relatives may be deemed to be concerned or interested in the resolution.

None of the other Directors, Key Managerial Personnel or their respective relatives is concerned or interested, financial or otherwise in the Resolution.

The Board recommends the Special Resolution set out in Item No.9 of the Special Business of the Notice for approval by the shareholders.

### OPERATIONAL REVIEW :

The Company suspended all the revenue-generating operations w.e.f. 24 March 2020 due to COVID-19 and has not carried out any business activities during the year as well, resulting in, the entire year being completely washed out.

During the year under consideration, the gross receipts of your company stood Rs.3.55 Lacs from Rs.0.18 Lacs logged in the previous year. Profit / (Loss) before Interest, Depreciation and Taxation was Rs.(45.93) lacs against Rs. (89.03) Lacs recorded in the previous year. Similarly, the Profit / (Loss) after Tax for the year ended March 31, 2026 stood at (Rs.850.03) lacs as against Profit/Loss of (Rs.1280.67) registered in the previous year.

### STATE OF THE COMPANY'S AFFAIRS

During the year under review, the Company did not make any progress as the operations at the Company were halted since March, 2020.

Members may be aware that the Company's account was categorized as NPA by Allahabad Bank and Andhra Bank during the year 2014. In April, 2017, the said Banks assigned the entire debts of the Company alongwith all underlying security interest, all rights, title & benefits to M/s.RARE Asset Reconstruction Limited (previously known as Raytheon Asset Reconstruction Private Limited) under the applicable provisions of the SARFAESI Act. The Company opted for One-Time Settlement offer with the said ARC and obtained in-principle approval from them during March, 2021 and also final approval has been received in May 2021.



The Company remitted Rs.100.95 Crore to the said ARC upto 31st March 2026 from the disposal / sale of assets of the Company, borrowings from the Directors / the Promoter Group Company and the receipt of an advance amount for sale of hotel property from the purchaser.

During the current financial year, the Company successfully divested its revenue-generating hotel property located at Tirupur. This strategic decision was made to pay off entire debt burdens of RARE ARC. On 28th April 2026, the Company remitted the entire OTS amount to RARE ARC on receipt of part of sale amount from M/s.J.P.Associates Asia Pacific Private Limited, the purchaser of the property and the sale process completed on 02nd July 2026 after receiving entire sale consideration.

In line with this ongoing restructuring, the Board intends to sell certain identified non-revenue properties in the near future to the related parties. The proceeds from these sales are repaying of unsecured loan provided by the Directors / the Promoter Group Company (the related parties)

Despite the sale of the primary operational asset, the Board has conducted a detailed assessment of the Company's financial position. The realization of assets and discharge of liabilities will continue in the normal course of business. The management has prepared these financial statements on a going concern basis, as the Company has the intention and realistic alternatives to continue its operations in the foreseeable future from other business opportunity available in main object clause in the Memorandum of Association of the Company.

#### **DIVIDEND:**

Given the accumulated losses, your directors have not recommended any dividend on Equity Shares for the Financial Year 2025-26.

#### **SHARE CAPITAL:**

During the year under review, your Company's Authorized Share Capital is Rs. 50,00,00,000 comprising 5,00,00,000 Equity Shares of Rs. 10/- each. The Company's paid-up capital is Rs.31,96,41,190 comprising of 3,19,64,119 Equity Shares of Rs. 10/- each fully paid up.

Further, the Company has not issued:

- a. Any shares with differential rights as per provisions of Section 43 (a) (ii) of the Act read with Rule 4 (4) of the Companies (Share Capital and Debenture) Rules, 2014.
- b. Any sweat equity shares as per provisions of Section 54 (1) (d) of the Act read with Rule 8 (13) of the Companies (Share Capital and Debenture) Rules, 2014.
- c. Any equity shares under the Employees Stock Option Scheme as per provisions of Section 62(1)(b) of the Act read with Rule 12(9) of the Companies (Share Capital and Debenture) Rules, 2014.

#### **TRANSFER OF AMOUNT TO RESERVE:**

Given the Loss incurred during the year and due to accumulated losses of earlier years, the Company had not transferred any amount to the Reserves.

#### **FIXED DEPOSITS:**

During the year under review, the Company has not accepted or renewed any amount falling within the purview of provisions of Section 73 of the Companies Act 2013 ("the Act") read with the Companies (Acceptance of Deposit)



Rules, 2014. Hence, the requirement for furnishing details relating to deposits covered under Chapter V of the Act or the details of deposits that are not in compliance with Chapter V of the Act is not applicable.

During the financial year under review, the Company borrowed the loans from Director(s) and the respective directors gave a declaration in writing to the Company to the effect that the amount was not being given out of funds acquired by them by borrowing or accepting loans or deposits from others as per requirement of proviso of Rule 2(1)(c)(viii) of Companies (Acceptance of Deposits) Rules, 2014.

## **PARTICULARS OF LOANS, GUARANTEES OR INVESTMENTS:**

During the financial year under review, the Company has not given any loans or guarantees covered under the provisions of Section 186 of the Companies Act, 2013 and has not made any investments. Hence, the details of loans and advances that are required to be disclosed in the Annual Report under Regulation 34(3) read with Schedule V of the SEBI Listing Regulations are not furnished.

## **INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY:**

The Company has an Internal Control System, commensurate with the size, scale and complexity of its operations. The scope and authority of the Internal Audit function are defined in the Internal Audit Manual. To maintain its objectivity and independence, the Internal Audit function reports to the Chairman of the Audit Committee / the Managing Director.

The Internal Auditor monitors and evaluates the efficacy and adequacy of the internal control system in the Company, and its compliance with operating systems, accounting procedures and policies at all locations of the Company.

## **CORPORATE SOCIAL RESPONSIBILITY INITIATIVES:**

Under Section 135 of the Companies Act, 2013, every company having a net worth of at least Rs 500 crore, turnover of Rs 1,000 crore or more, or a minimum net profit of Rs.5 crores during the immediately preceding financial year has to make CSR expenditure. Since the Company does not fall under the criteria as are referred above, not applicable.

## **DIVIDEND DISTRIBUTION POLICY:**

According to Regulation 43A of the SEBI (Listing Obligations and Disclosures) Regulations 2015 as amended, only the top 1000 listed companies (based on the market capitalization of every financial year) shall formulate a Dividend Distribution Policy, which shall be disclosed in their annual reports and on their website as well.

Since your company does not fall under the top 1000 listed companies, no such report is provided in the Annual Report.

Under the provisions of Section 152 of the Companies Act, 2013 read with Section 149 of the said Act, at least 2/3rd of the total number of Directors, excluding Independent Directors, shall be liable to retire by rotation and out of the Directors liable to retire by rotation, at least 1/3rd of the Directors shall retire by rotation at every Annual General Meeting.

In view of the above, Mr.M.R.Gautham and Mrs.M.Sasikala retiring by rotation and being eligible, offer themselves for re-appointment, a resolution seeking shareholders' approval for their re-appointment forms part of the Notice.

### **b. Appointment / Re-appointment**

Mr.Nagaraj Saveethkumar (DIN:09130676) : His first term as Independent Director will expire on 30th March 2026. On recommendation of the Nomination and Remuneration Committee and the Board, Mr.Nagaraj Saveethkumar was re-appointed as an Independent Director for a second and final term of five years w.e.f. 31st March 2026 to 30th March 2031. His re-appointment was approved at the 35th AGM held on 27th September 2025.

By way of a resolution passed at the 35th AGM held on 27th September 2025, Mr.Muthukumararamalingam Gautham (M.R.Gautham) was re-appointed as Whole-Time Director designated as Executive Director for a further period of 1 year.

The Board at its meeting held on 07th August 2026 re-appointed Mr.E.V.Muthukumara Ramalingam as the Managing Director for a further period of three years and Mr.Muthukumararamalingam Gautham @ M.R.Gautham as an Executive Director for a further period of three years. Resolutions for the both re-appointments have been placed before the members of the Company for their approval.

### **c. Status of KMP:**

During the year under review, Mr.E.V.Muthukumara Ramalingam, Managing Director, Mr.M.R.Gautham, Executive Director, Mr.R.Lalitha, Chief Financial Officer and Ms.Garima Maheshwari, Company Secretary are other KMPs as per the provisions of the Act and were already in the office. Mr.M.Srinivasan, the former Company Secretary passed away due to ill health during the month of October 2025. None of the KMPs resigned during the year.

## **d. Declaration by Independent Director:**

Under the provisions of Section 149 of the Act, the Independent Directors have submitted declarations that each of them meets the criteria of independence as provided in Section 149(6) of the Act along with Rules framed there-under and Regulation 16(1)(b) of SEBI Listing Regulations. There has been no change in the circumstances affecting their status as Independent Directors of the Company. In terms of Regulation 25(8) of SEBI Listing Regulations, they have confirmed that they are not aware of any circumstance or situation, which exists or may be reasonably anticipated, that could impair or impact their ability to discharge their duties with an objective independent judgment and without any external influence. The Board of Directors of the Company has taken on record the declaration and confirmation submitted by the Independent Directors

## **e. Disqualification of Directors:**

None of the directors of the Company are disqualified under the provisions of Section 164 of the Companies Act, 2013 or debarred or disqualified from being appointed or continuing as directors of companies by the Securities and Exchange Board of India or Ministry of Corporate Affairs or any such statutory authority. ## **f. Woman Director :**

## MANAGEMENT DISCUSSION AND ANALYSIS REPORT

### A. INDUSTRY STRUCTURE AND DEVELOPMENTS:

India's hospitality sector is a massive economic driver valued at nearly \$60 billion. It features a highly fragmented structure dominated by independent, unorganized properties (over 55% market share) alongside expanding global chains. Development is shifting from major metros to Tier-2 and Tier-3 cities, propelled by rising domestic travel, regional infrastructure, and an "asset-light" expansion model. The Indian hospitality market operates on several key pillars, categorized by service type and scale: ie. Lodging, Food and Beverage (F&B), Recreation & Travel and Business Organization.

### B. OPPORTUNITIES

Growth of the hospitality industry in India is driven by a larger domestic travel base, a rising middle-income population, and improved air and road connectivity that increases travel frequency. Domestic visitor spending has been rising and is expected to continue, highlighting the sector's reliance on local travelers across leisure, pilgrimage, and business segments. Over 88% of tourism spending comes from domestic travelers. Development is booming outside major cities. In 2025, a record number of new hotel properties were signed, targeting Tier-2 and Tier-3 markets like Ayodhya, Varanasi, and Guwahati.

Airports in India have more than doubled over the past decade, while government programs are expanding destination and pilgrimage infrastructure, creating new investable locations. Foreign tourist arrivals are recovering, supported by destination marketing and digital tools that simplify planning and booking. Overall, the market demonstrates strong growth potential fueled by domestic demand, improved connectivity, and strategic industry adaptation.

### C. SEGMENTWISE PERFORMANCE :

During the year under review, the Company has only one reportable business segment as it deals only in Operation and running of Hotels in terms of Ind-AS108 "Operating Segment".

### D. THREATS, RISKS AND CONCERNS :

The current GST structure imposes a higher tax on rooms above a certain tariff threshold, which reduces net yields for premium city hotels and upscale leisure resorts. This limits India's price competitiveness compared to some Southeast Asian destinations for high-value leisure and MICE travelers.

Inflation pushes up prices for basic supplies, food, and energy. Hotels have to balance raising prices with keeping guests happy. Finding and keeping good workers is a massive problem globally. The reputation for long hours and low pay drives people away, leading to understaffed locations and poor service. Guests now expect eco-friendly practices, forcing hotels to spend money on green upgrades to stay competitive.

Connectivity challenges continue to constrain supply expansion in smaller cities and remote destinations with high leisure potential. Limited flight options, inadequate last-mile road infrastructure, and inconsistent local utilities can increase project timelines and development costs, delaying hotel openings and discouraging private investment. These infrastructure gaps will continue to limit the growth of the hospitality market in Tier-2 and Tier-3 locations.

## E. OUTLOOK:

The Indian hospitality sector outlook for 2026-27 is highly positive. Industry experts project robust revenue growth of 7% to 9%. This growth is driven by rising domestic leisure travel, weddings, and corporate events. Premium hotel occupancy rates will hold steady at 72% to 74% . The majority of new hotel signings are now happening outside major cities. Brands are shifting to tier-2 and tier-3 cities to meet growing local demand. The government's focus on infrastructure and destination development continues to improve accessibility. This supports private investment and capacity additions across the country.

The day-to-day operations of the Company are managed by Mr.E.V.Muthukumara Ramalingam, Chairman & Managing Director and Mr.M.R.Gautham - Executive Director, under the active guidance of the Board.

The Board of Directors have taken on record the confirmation received from all Directors, Promoters, Key Managerial Personnel and other employees that they have not entered into any agreement for themselves or on behalf of any other person with any shareholder or any other third party about compensation or profit sharing in connection with dealings in securities of the Company during the year ended 31st March 2026 under regulation 26(6) of SEBI (LODR) Regulations, 2015.

#### **Independent - Non-Executive Director**

Mr.Katpadi Muthukrishnan Ananthasayanam, Mr..Pachaimuthu Kumar and Mr.Nagaraj Saveethkumar are Non-Executive, Independent Directors who constitute 1/2 of the total strength of the Board where the Chairman of the Board is Executive.

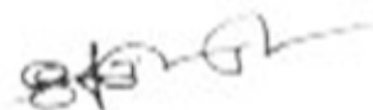

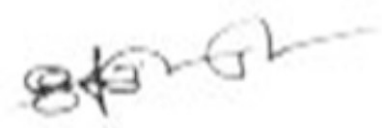

#### a. Details of Audit Qualification:

##### i) Going Concern

We draw attention to Note No. 4 of the attached Financial Results for the year ended 31st March 2026. The Company's borrowings were taken over by M/s. RARE Asset Reconstruction Company Limited ("ARC") commencing from April 1, 2017 and out of the final One-time settlement amount of Rs. 115.96 crores agreed with the ARC, the company has made a payment of Rs. 82.52 crore upto 31st March 2025 and during the year, the company has repaid a further sum of Rs.18.43 crore from the Advance received for Sale of Hotel at Tiruppur and as on the date of this report the company has fully repaid the Loan and obtained No Due Certificate form ARC. The company has sold all the Income generating Assets as on date of the report and has some land which is pending to be disposed. In addition, as per the financial statements for the year ended March 31, 2026, the net worth has been eroded indicating the existence of a material uncertainty that may cast significant doubt about the Company's ability to continue as a going concern.

Further, we draw attention to Note No. 3, the Company having suspended all business operations and with no revenue being generated, the ability of the Company to repay its debts depends on the quantum of realisation from the sale of Assets, there exists a concern on the ability of the Company continuing as a Going Concern.

##### ii) Delays in remittance of statutory dues:

There has been significant delay in the remittance of Tax Deducted at Source, Goods and Service Tax, Value Added tax, Service Tax, Provident Fund and Employees' State Insurance to appropriate authorities. There were no amount outstanding pertaining to the accounting year 2024-25.



### iii) **Gratuity and Leave Encashment accounted on estimated basis**

- a. The Company has not made provision for gratuity and leave encashment on Actuarial Basis.

- d. For Audit Qualification(s) where the impact is quantified by the auditor, Management's Views:

The Company's account was categorized as NPA by Allahabad Bank and Andhara Bank during the year 2014. In April, 2017, the said Banks assigned the entire debts of the Company along with all underlying security interest, all rights, title & benefits to M/s.RARE Asset Reconstruction Limited (previously known as Raytheon Asset Reconstruction Private Limited) under the applicable provisions of the SARFAESI Act. The Company opted for One-Time Settlement offer with the said ARC and obtained in-principle approval from them during March, 2021 and the final approval has been received.

In view of the above, the Company has remitted Rs.82.52 crores to ARC upto 31st March, 2025, from the disposal / sale of assets of Company.

During the quarter, the company has additionally repaid Rs.18.43 Crore from the Advance Received on Sale of Hotel at Tiruppur and as on the date of results, the Company has fully repaid the loan and obtained No due Certificate from ARC.

The revenues of the Velan Greenfields Hotel Tirupur was severely impacted due to the Covid-19 Novel Corona Virus pandemic forcing the closure of operations. With this closure all revenue generating operations of the Company has been suspended. The Company is exploring options of selling remaining part of assets. In view of the above, the Company's ability of continuing as a Going concern is dependent on the value that can be generated by the sale of assets and the surplus, if any, available subsequent to the settlement of all liabilities.

The Company is taking necessary steps to regularise the Statutory Dues. During the year, the company has paid dues relating to Provident Fund, Sales Tax, Service Tax and Tax Deducted at sources for Earlier Years amounting to Rs.54.10 Lacs.

- i) Management's estimation on the impact of audit qualification:

Management is unable to estimate the impact on the above audit qualification. Reason is for same is stated below.

- ii) If management is unable to estimate the impact, reasons for the same:

Impact on Audit qualification is not estimable due to the following reasons,

- a) After COVID-19 pandemic, the business operation of the company has been forced to closure, With this closure all revenue generating operations of the Company has been suspended. The company is exploring options of selling a part or all of its revenue generating assets to settle all liabilities including Statutory Liabilities. In view of the above, the Company's going Concern is affected.

- b) No Provision for Gratuity /Leave encashment has been considered during the period due to all the employees of the company except KMP have resigned and there are no eligible employees during the year under review.
- iii) Auditors' Comments on (i) or (ii) above:
  - a) In respect of Going Concern, the company's ability to run business as going concern is dependent on the value that can be generated by the sale of remaining assets and the surplus, if any, available subsequent to the settlement of all liabilities.

## SIGNIFICANT ACCOUNTING POLICIES AND NOTES FARMING PART OF ACCOUNTS

### 1. The Company overview

Velan Hotels Limited is a public limited company incorporated and domiciled in India. The company is in the business of providing Hospitality Services including running of restaurants with bar. The corporate office of the company is located at Kangeyam Road, Tiruppur - 641 604. The shares of the Company is Listed in Bombay Stock Exchange (BSE).

### 2. Basis of preparation of financial statements

#### A) Statement of compliance and basis of preparation

The Standalone Financial Statements comply, in all material aspects, with Indian Accounting Standards ('Ind AS') notified under Section 133 of the Companies Act, 2013 ('the Act') read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and other relevant provisions of the Act.

These financial statements have been prepared in accordance with the Generally Accepted Accounting Principles in India ('Indian GAAP') to comply with the Accounting Standards specified under Section 133 of the Companies Act, 2013, read with Rule 7 of the Companies (Accounts) Rules, 2014 and the relevant provisions of the Companies Act, 2013. The financial statements have been prepared under the historical cost convention on accrual basis, except for certain items which are measured at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants the measurement date, regardless of the price is directly observable or estimated using another valuation technique.

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III of the Companies Act, 2013 and Ind AS, based on the nature of products and the time between the acquisition of assets or processing and their realisation in cash and cash accruals.

#### B) Basis of measurement

These financial statements have been prepared on a historical cost convention and on an accrual basis, except for the following material items which have been measured at fair value as required by relevant Ind AS:-

- a) Derivative financial instruments;
- b) Financial instruments classified as fair value through other comprehensive income or fair value through profit or loss; and
- c) The defined benefit asset/(liability) is recognised as the present value of defined benefit obligation less the fair value of plan assets.

#### C) Use of estimates and judgment

The preparation of the financial statements in conformity with Ind AS requires management to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from those estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected. In particular, information about significant areas of estimation, uncertainty and critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements are included in the following notes:

- a) **Impairment testing:** Investments in subsidiaries, goodwill and intangible assets are tested for impairment at least annually and when events occur or changes in circumstances indicate that the recoverable amount of the asset or cash generating units to which these pertain is less than its carrying value. The recoverable amount of cash generating units is higher of value-in-use and fair value less cost to dispose. The calculation of value in use of a cash generating unit involves use of significant estimates and assumptions which includes turnover and earnings multiples, growth rates and net margins used to calculate projected future cash flows, risk-adjusted discount rate, future economic and market conditions.
- b) **Deferred taxes:** Deferred tax is recorded on temporary differences between the tax bases of assets and liabilities and their carrying amounts, at the rates that have been enacted or substantively enacted at the reporting date. The ultimate realization of deferred tax assets is dependent upon the generation of future taxable profits during the periods in which those temporary differences and tax loss carry forwards become deductible. The Company considers the expected reversal of deferred tax liabilities and projected future taxable income in making this assessment. The amount of the deferred tax assets considered realizable, however, could be reduced in the near term if estimates of future taxable income during the carry-forward period are reduced.
- c) **Defined benefit plans and compensated absences:** The cost of the defined benefit plans, compensated absences and the present value of the defined benefit obligation are based on actuarial valuation using the projected unit credit method. An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, future salary increases and mortality rates. Due to the complexities involved in the valuation and its long-term nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each reporting date.

### 3. Significant Accounting Policies

- i) **Functional and presentation currency :** These financial statements are presented in Indian rupees, the national currency of India, which is the functional currency of the Company.
- ii) **Foreign currency transactions and translation :** Transactions in foreign currency are translated into the functional currency using the exchange rates prevailing at the date of the transaction. Foreign exchange gains and losses resulting from the settlement of such transactions and from translation at the exchange rates prevailing at the reporting date of monetary assets and liabilities denominated in foreign currencies are recognized in the statement of profit and loss and reported within foreign exchange gains/(losses), net within results of operating activities. Gains/(losses) relating to translation or settlement of borrowings denominated in foreign currency are reported within finance expense. Nonmonetary assets and liabilities denominated in foreign currency and measured at historical cost are translated at the exchange rate prevalent at the date of transaction. Translation differences on nonmonetary financial assets measured at fair value at the reporting date.

#### iii) Equity

##### a) **Share capital and share premium**

The authorized share capital of the Company as of March 31, 2026 and March 31, 2025 is 50,00,00,000 divided into 5,00,00,000 equity shares of ₹ 10 each. Par value of the equity shares is recorded as share capital and the amount received in excess of par value is classified as share premium.



Every holder of the equity shares, as reflected in the records of the Company as of the date of the shareholder meeting shall have one vote in respect of each share held for all matters submitted to vote in the shareholder meeting.

b) **Revaluation Reserve**

Revaluation reserve amounting to Rs. 5,50,61,359 (March 31, 2025 Rs. 5,57,40,214) is not freely available for distribution.

c) **Retained earnings**

Retained earnings comprises of the Company's undistributed earnings after taxes.

d) **Other comprehensive income**

Changes in the fair value of financial instruments measured at fair value through other comprehensive income and actuarial gains and losses on defined benefit plans are recognized in other comprehensive income (net of taxes), and presented within equity as other comprehensive income.

iv) **Property, plant and equipment**

a) **Recognition and measurement**

Property, plant and equipment are measured at cost less accumulated depreciation and impairment losses, if any. Cost includes expenditures directly attributable to the acquisition of the asset. General and specific borrowing costs directly attributable to the construction of a qualifying asset are capitalized as part of the cost.

b) **Depreciation**

The Company depreciates property, plant and equipment over the estimated useful life on a straight-line basis from the date the assets are available for use. Assets acquired under finance lease and leasehold improvements are amortized over the shorter of estimated useful life of the asset or the related lease term. Term licenses are amortized over their respective contract term. Freehold land is not depreciated. The estimated useful life of assets are reviewed and where appropriate are adjusted, annually.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment. Subsequent expenditure relating to property, plant and equipment is capitalized only when it is probable that future economic benefits associated with these will flow to the Company and the cost of the item can be measured reliably.

The cost of property, plant and equipment not available for use as at each reporting date is disclosed under capital work-in-progress.

v) **Intangible assets**

Intangible assets acquired separately are measured at cost of acquisition. Intangible assets acquired in a business combination are measured at fair value as at the date of acquisition. Following initial recognition, intangible assets are carried at cost less accumulated amortization and impairment losses, if any.

The amortization of an intangible asset with a finite useful life reflects the manner in which the economic benefit is expected to be generated. The estimated useful life of amortizable intangibles are reviewed and where appropriate are adjusted, annually.

## **vi) Leases**

The determination of whether an arrangement is, or contains, a lease is based on the substance of the arrangement at the inception date. The arrangement is, or contains a lease if, fulfillment of the arrangement is dependent on the use of a specific asset or assets or the arrangement conveys a right to use the asset or assets, even if that right is not explicitly specified in an arrangement.

### **a) Arrangements where the Company is the lessee**

Leases of property, plant and equipment, where the Company assumes substantially all the risks and rewards of ownership are classified as finance leases. Finance leases are capitalized at lower of the fair value of the leased property and the present value of the minimum lease payments. Lease payments are apportioned between the finance charge and the outstanding liability. The finance charge is allocated to periods during the lease term at a constant periodic rate of interest on the remaining balance of the liability.

Leases where the lessor retains substantially all the risks and rewards of ownership are classified as operating leases. Payments made under operating leases are recognized in the statement of profit and loss on a straight-line basis over the lease term.

### **b) Arrangements where the Company is the lessor**

In certain arrangements, the Company recognizes revenue from the sale of products given under finance leases. The Company records gross finance receivables, unearned income and the estimated residual value of the leased equipment on consummation of such leases. Unearned income represents the excess of the gross finance lease receivable plus the estimated residual value over the sales price of the equipment. The Company recognizes unearned income as finance income over the lease term using the effective interest method.

## **vii) Inventories**

Inventories are valued at lower of cost and net realizable value, including necessary provision for obsolescence. Cost includes all direct costs and applicable overheads to bring the goods to present location and condition.

## **viii) Impairment**

Goodwill and intangible assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non- financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

## ix) Employee benefits

### a) Post-employment and pension plans

The Company participates in various employee benefit plans. These employment benefits are classified as either defined contribution plans or defined benefit plans.

Under a defined contribution plan, the Company's only obligation is to pay a fixed amount with no obligation to pay further contributions if the fund does not hold sufficient assets to pay all employee benefits. The related actuarial and investment risks fall on the employee.

The expenditure for defined contribution plans is recognized as an expense during the period when the employee provides service.

Under a defined benefit plan, it is the Company's obligation to provide agreed benefits to the employees. The related actuarial and investment risks fall on the Company. The present value of the defined benefit obligations is calculated by an independent actuary using the projected unit credit method. All actuarial gains or losses are immediately recognized in other comprehensive income, net of taxes and permanently excluded from profit or loss. Further, the profit or loss will no longer include an expected return on plan assets. Instead net interest recognized in profit or loss is calculated by applying the discount rate used to measure the defined benefit obligation to the net defined benefit liability or asset. The actual return on the plan assets above or below the discount rate is recognized as part of remeasurement of net defined liability or asset through other comprehensive income, net of taxes.

The Company has the following employee benefit plans:

#### A. Provident fund

Employees receive benefits from a provident fund, which is a defined benefit plan. The employer and employees each make periodic contributions to the plan. The contributions to the provident fund are charged to the statement of profit and loss for the year when the contributions are due.

#### B. Gratuity

In accordance with the Payment of Gratuity Act, 1972, applicable for Indian companies, the Company provides for a lump sum payment to eligible employees, at retirement or termination of employment based on the last drawn salary and years of employment with the Company. The Company's obligation in respect of the gratuity plan, which is a defined benefit plan, is provided for based on actuarial valuation using the projected unit credit method. The Company recognizes actuarial gains and losses in other comprehensive income, net of taxes.

### b) Termination benefits

Termination benefits are expensed when the Company can no longer withdraw the offer of those benefits.

### c) Short-term benefits

Liabilities for wages and salaries, including non-monetary benefits that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.

**d) Compensated absences**

The employees of the Company are entitled to compensated absences. The employees can carry forward a portion of the unutilized accumulating compensated absences and utilize it in future periods or receive cash at retirement or termination of employment. The Company records an obligation for compensated absences in the period in which the employee renders the services that increases this entitlement. The Company measures the expected cost of compensated absences as the additional amount that the Company expects to pay as a result of the unused entitlement that has accumulated at the end of the reporting period. The Company recognizes accumulated compensated absences based on actuarial valuation using the projected unit credit method.

Non-accumulating compensated absences are recognized in the period in which the absences occur.

**x) Provisions**

Provisions for legal claims, service warranties, volume discounts and returns are recognised when the group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period.

**xi) Revenue**

Income from Guest Accommodation is recognised on a day to day basis after the Guest Checks into the hotel. Sale of Food and beverage is recognised at the point of serving those items to the guest.

Revenues are shown net of sales tax, value added tax, service tax and Good and Service Tax.

**xii) Borrowing cost**

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

Other borrowing costs are expensed in the period in which they are incurred.

**xiii) Other income**

Other income comprises interest income on deposits and dividend income.

- a) Interest income is recognized using the effective interest method.
- b) Dividend income is recognized when the right to receive payment is established.

## xiv) Income tax

Income tax comprises current and deferred tax. Income tax expense is recognized in the statement of profit and loss except to the extent it relates to a business combination, or items directly recognized in equity or in other comprehensive income.

### a) Current income tax

Current income tax for the current and prior periods are measured at the amount expected to be recovered from or paid to the taxation authorities based on the taxable income for the period. The tax rates and tax laws used to compute the current tax amount are those that are enacted or substantively enacted as at the reporting date and applicable for the period. The Company offsets current tax assets and current tax liabilities, where it has a legally enforceable right to set off the recognized amounts and where it intends either to settle on a net basis, or to realize the asset and liability simultaneously.

### b) Deferred income tax

Deferred income tax is recognized using the balance sheet approach. Deferred income tax assets and liabilities are recognized for deductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount in financial statements, except when the deferred income tax arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profits or loss at the time of the transaction.

Deferred income tax assets are recognized to the extent it is probable that taxable profit will be available against which the deductible temporary differences and the carry forward of unused tax credits and unused tax losses can be utilized. Deferred income tax liabilities are recognized for all taxable temporary differences except in respect of taxable temporary differences associated with investments in subsidiaries, associates and foreign branches where the timing of the reversal of the temporary difference can be controlled and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred income tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred income tax asset to be utilized. Deferred income tax assets and liabilities are measured at the tax rates that are expected to apply in the period when the asset is realized or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date.

The Company offsets deferred income tax assets and liabilities, where it has a legally enforceable right to offset current tax assets against current tax liabilities, and they relate to taxes levied by the same taxation authority on either the same taxable entity, or on different taxable entities where there is an intention to settle the current tax liabilities and assets on a net basis or their tax assets and liabilities will be realized simultaneously.

## xv) Earnings per share

Basic earnings per share is computed using the weighted average number of equity shares outstanding during the period adjusted for treasury shares held. Diluted earnings per share is computed using the weighted-average number of equity and dilutive equivalent shares outstanding during the period, using the treasury stock method for options and warrants, except where the results would be anti-dilutive.

The amendment also introduces guidance on classification of liabilities with covenants. The Company has no impact of these amendments in its classification criteria of current and non-current liabilities.
- b. Ind AS 7, Statement of Cash Flows and Ind AS 107, Financial Instruments: Disclosures, applicable w.e.f. April 1, 2025 - The amendment in Ind AS 7 requires to inform users of financial statements of the existence of supplier finance arrangements and explain the nature of the arrangements, the carrying amount of liabilities and the range of payment due dates.
