I further confirm that there are no material reasons for my resignation other than personal reasons.

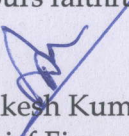

Kindly acknowledge receipt of this resignation and take the necessary steps to record the same in the Company's records.

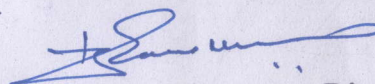
