O R D E R

IA No. 180011 of 2026

1. The petitioner has filed this application seeking modification of our order dated 05.06.2026 with the following prayers :-

(a) Issue directions modifying Paragraph 3 of the order dated 05.06.2026 passed in SLP (Crl) Diary No. 34294/2026 to clarify that the Petitioner be released on interim bail forthwith, subject to conditions imposed by the Trial Court and to deposit such sum as the Hon'ble Court may

decide within a period of 8 weeks after interim bail is granted to the Petitioner.

(b) Issue directions to modify the deposit sum of Rs. 75,00,000/- to a lower amount, as may be considered by this Hon'ble Court"

2. Learned senior counsel appearing for the petitioner submits that she is ready with a Demand Draft of Rs. 20,00,000/- (Rupees Twenty Lakhs).

3. Having heard learned senior counsel appearing for the petitioner, we modify our order dated 05.06.2026 to the effect that subject to the petitioner depositing a sum of Rs. 20,00,000/- (Rupees Twenty Lakhs), he shall be released on bail, subject to such terms and conditions as may be imposed by the Trial Court.

4. The balance amount of Rs. 55,00,000/- (Rupees Fifty Five Lakhs) shall be deposited within a period of six weeks from today.

5. Rest of the order dated 05.06.2026 regarding deposit of the amount in Fixed Deposit and listing of the matter, shall remain intact.

6. With these directions, the application for modification is allowed.
