Pursuant to Regulation 30 of the SEBI Listing Regulations, it is hereby informed that the Company has received a Show Cause Notice dated September 28, 2026 from the Office of the Assistant Commissioner, CGST, Gurugram in relation to the financial year 2022-23. The relevant details pursuant to Regulation 30 of the SEBI Listing Regulations read with the applicable SEBI Circulars are annexed herewith as **Annexure - A**.

Please note that the Company had already filed a writ petition before the Hon'ble High Court of Punjab & Haryana, Chandigarh in relation to a Show Cause Notice issued for an earlier period concerning the same matter as covered under the aforesaid Show Cause Notice. The necessary disclosure in this regard was made by the Company on November 22, 2024.

In the said writ, the Hon'ble High Court vide its interim order stayed the further proceedings in the concerned matter alongwith writ petitions filed by other hospitals. The Company is in the process of filing a writ before the Hon'ble High Court of Punjab & Haryana, Chandigarh in relation to the aforesaid Show Cause Notice dated September 28, 2026 and to connect the matter with the previous writ.

In respect of the captioned matter, we hereby also state and declare that the information and details provided in Annexure A, in compliance with Regulation 30(13) of the SEBI Listing Regulations, are true, correct and complete to the best of our knowledge and belief.
