ORDER

1. The instant Petitions were originally filed before Hon'ble Delhi High Court, seeking winding up with respect to the Respondent Company, M/s Vigneshwara Developers Private Limited.
2. The instant Petitions have been transferred by Hon'ble Delhi High Court to this Adjudicating Authority (**AA**) vide order dated 24.09.2025 in CO.APPL. 608/2025 (Transfer of Proceedings to NCLT) in Co. Pet. 534 of 2015, for commencement of CIRP for Corporate Debtor, M/s Vigneshwara Developers Private Limited, which is a common respondent in the instant petitions.
3. The Respondent Company was admitted to CIRP by this AA vide order dated 10.10.2019 in CP(IB)-1076/2019. The Petition although closed vide order dated 09.07.2025, has been revived by this Adjudicating Authority in IA-4999/2025 in CP(IB)-1076/2019 vide order dated 21.05.2026.
4. Since the CIRP of the Respondent Company, M/s Vigneshwara Developers Private Limited, stands revived, the instant petitions have become **infructuous**. Therefore, **TP (Co. Act) – 25(PB)/2025, TP (Co. Act) – 27(PB)/2025, TP (Co. Act) – 28(PB)/2025, TP (Co. Act) – 29(PB)/2025, TP (Co. Act) – 31(PB)/2025, TP (Co. Act) – 32(PB)/2025, TP (Co. Act) – 33(PB)/2025, and TP (Co. Act) – 30(PB)/2025** are **Dismissed as infructuous**.

5. Petitioners in the instant Petitions may file their claim before the IRP appointed for the M/s Vigneshwara Developers Private Limited, in order dated 21.05.2026.
